Jorge Gutierrez (Facilities) and Ann O'Brien (Marketing & Communications) attended the meeting to present an overview of the upcoming/ongoing construction projects and the impact it will have on the campus pathways. Items included upcoming demolition and fencing, as well as the Behavioral & Social Sciences, Art Complex, and Communications Building projects.

The Student Activity Center demolition will begin in December 2019 and last through June 2020. There will be major fenced off areas with specific pathways for traveling around campus. A designated crosswalk person will be posted each day to provide safe crossing south of the Planetarium where construction vehicles will access the campus. (See attached map). Construction on the new Behavioral & Social Sciences and Art buildings will happen from August 2020 through 2022. While these changes may make getting around campus inconvenient, it is necessary to modernize teaching spaces and improve the campus for students.

Facilities and Marketing & Communications will continue to present these overviews to all campus stakeholders. A consultant will be hired to make sure that all pathways of travel are ADA compliant and that federal and state guidelines are met. Notifications about safety, handicap accessibility, project milestones, and way-finding will be communicated regularly. The ECC website has a fantastic new interactive map for viewing locations around campus.

Other issues that will be monitored through environmental impact studies will include air and noise quality during the construction period, alternate locations for events currently held on the library lawn, and the conversion of "The Manhattan" into a café serving gourmet coffee with indoor seating for 30 people and additional outdoor seating. Food and beverages to be provided by Pacific Dining.

Staff & Student Diversity

Jaynie went over the internal case management system (Maxient), used by her office as well as student development to track and monitor various incidents and student complaints. The District is looking at ways other schools use the system. The District plans to expand the use of Maxient to include Human Resources and employee-relation cases not involving unlawful discrimination which are not currently tracked in any system.
