**The following information is being provided in accordance with the Violence Against Women Reauthorization Act of 2013 which amends the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act of 1998.**

## PURPOSE OF THIS BOOKLET

El Camino Community College District is required to comply with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act as revised in 2008 in the Higher Education Opportunity Act (Clery Act) and the Violence Against Women Act of 2013 (VAWA) which amends the Clery Act under the Campus Sexual Violence Elimination Act provision (SaVE Act).

The law specifically requires the reporting of the most recent three years for the following crimes: murder/non-negligent manslaughter, manslaughter by negligence, rape, fondling, incest, statutory rape, robbery, aggravated assault, burglary, motor vehicle theft, arson, sexual assault, dating violence, domestic violence, stalking and sexual harassment, as well as a summary of arrests and disciplinary referrals for liquor law, drug abuse and weapons violations that occur on our campus, on public property immediately adjacent to our campus or in non-campus building frequented by our students for educational purposes.

In compliance with the above law the El Camino Community College District Police Department (Campus Police) has produced this booklet containing the required information as well as valuable safety and crime prevention information.

## HOW WE PREPARE OUR CAMPUS ANNUAL SECURITY REPORT

The preparation of the El Camino College Police Department Annual Security Report is an on-going process. Every effort is made to ensure that the report is complete, accurate and in compliance with the law. This process includes the gathering of crime statistics from Campus Security Authorities, those individuals who have been identified on our campus as having a significant responsibility for student and campus activities. We also request crime information from surrounding law enforcement agencies that have jurisdiction around the campus and in locations used for off campus classes and activities.

After we have collected crime statistics from the other sources, they are reconciled and compared to the records maintained by the police department to ensure that all offenses have been counted and there are no incidents being counted twice. Offenses are recorded without information about the individuals involved. The Daily Log is also posted without individual's information.

When all statistical information and policy changes have been received, the Campus Police Department prepares the Annual Security Report and distributes the information in both a printed and on-line form. The required statistical data is also submitted to the Department of Education.

El Camino Community College District does not officially recognize any student organizations with off campus locations. El Camino Community College District does not own, operate, manage, or maintain off campus housing.

### SAFETY AND SECURITY IN THE CAMPUS COMMUNITY

At the El Camino Community College District, the safety and well being of our students, faculty and staff are always our main concern (BP3500). However, a truly safe campus can only be achieved through the cooperation of all students, faculty, and staff. El Camino Community College District prohibits the commission of any crime, particularly sexual assault, domestic violence, dating violence and stalking. This information is a part of our effort to ensure that this collaborative endeavor is effective. We hope that you will read it carefully and use the information to help foster a safe environment for yourself and others on campus.

### EL CAMINO POLICE DEPARTMENT

El Camino Community College District has a dedicated, full service police department available 24 hours a day, 7 days a week (830.32(a)California Penal Code, 72330(a)California Education Code, (El Camino Community College District Board Policy 7600).

The Campus Police Department is located at the corner of Redondo Beach Boulevard and Crenshaw Boulevard in Parking Lot K. The Campus Police Department is open 24 hours a day, 7 days a week. The Campus Police Department employs about 12 sworn police officers, 2 sergeants and a chief of police and has the primary law enforcement jurisdiction on the campus and on all properties owned and operated by the district.

The Campus Police Department is empowered as a full service state law enforcement agency and fully subscribes to the standards of the California Commission on Peace Officer Standards and Training (P.O.S.T.)

Officers receive the same basic training as city and county law enforcement officers throughout the state, plus additional training to meet the unique needs of a campus environment.

The Campus Police Department also employs police cadets and community service officers who provide a wide variety of support and service functions that assist the department in the delivery of quality law enforcement services to the campus community.

The Campus Police Department works closely with other local, state and federal law enforcement agencies and maintains memorandums of understanding with the cities of Torrance, Gardena, Hawthorne, and Inglewood and the Los Angeles County Sheriff's Department. The Campus Police Department regularly meets with these agencies and exchanges information critical to our mission of delivering quality law enforcement services and maintaining a safe and secure environment (El Camino Community College District Board Policy 3520).

## SEXUAL MISCONDUCT POLICY

El Camino Community College District is committed to creating and maintaining a community where all individuals who participate in College programs and activities can work together in an atmosphere free of violence, harassment, discrimination, exploitation, or intimidation. Every member of the community should be aware that the El Camino Community College District prohibits sexual assault, sexual harassment, domestic violence, dating violence, stalking, and retaliation and that such behavior violates both the law and District policy. The El Camino Community College District will respond promptly and effectively to reports of sexual assault, dating violence, domestic violence, stalking and sexual harassment, and will take appropriate action to prevent, correct and when necessary, discipline behavior that violates these Policies. Suspected violators may also be subjected to arrest and prosecution through the criminal justice system (El Camino Community College District Board Policy 3540).

Victims of sexual assault, dating violence, stalking and domestic violence and any other crime are encouraged to immediately contact the Hawthorne Police Department (310-675-4444) or the El Camino Community College Police Department (310-660-3100). Any person who is the target of sexual assault, dating violence, domestic violence, stalking or sexual harassment may report the incident to any El Camino Community College District office who will assist the victim in contacting the Campus Police Department. Victims are not required to contact any police department but should immediately consult the Director of Staff and Student Diversity (310-660-3593 extension 3813) or the Director of Student Development (310-660-3593 extension 3500) for advice, options, and information. All reports and complaints of sexual assault, dating violence, domestic violence, stalking or sexual harassment made to any El Camino Community College District official or Campus Security Authority must be reported to the Director of Staff and Student Diversity by the person receiving the report, immediately. Reporting sexual assault, dating violence, domestic violence, stalking or sexual harassment or any other crime to the Campus Police Department, director of Student Development or Director of Staff and Student Diversity is at the discretion of the victim. However, reporting these crimes allows the El Camino Community College District to provide resources to the victim.

Sexual Misconduct information is part of the New Student and New Staff/Faculty Orientation.

## LIMITED CONFIDENTIAL REPORTING

The El Camino Community College District will protect the privacy of individuals involved in a report of discrimination, harassment or sexual misconduct to the extent allowed by law and El Camino Community College District policy. However, confidentiality is not guaranteed as there may be times when disclosure of information is required.

When the El Camino Community College District becomes aware of unlawful discrimination, there may be an obligation to proceed with an investigation, regardless of a complainant's wishes to the contrary, in order to ensure the safety of the El Camino Community College District Community. If a person requests that their name or other identifying information not be used in an investigation, the El Camino Community College District will weigh requests for confidentiality against its duty to provide a safe and nondiscriminatory environment for all members of the El Camino Community College District Community.

For victims of crimes, it is critical that the crime is reported so that victim may get assistance in receiving care and counseling and for evidentiary purposes. Reports for purposes of inclusion in the annual disclosure of crime statistics can generally be made to other El Camino Community College District offices such as the Office of Staff and Student Diversity (310-660-3593 extension 3813) and the Office of Student Development (310-660-3593 extension 3500). These offices and all academic division offices are mandated by law to notify the Campus Police Department when sexual misconduct or gender based violence incidents are reported to them. The only person(s) on the El Camino College Campus that a true confidential report may be made to is the psychologist in the El Camino Community College District Health Center (310-660-3643). All other El Camino Community College District Employees are mandated by law to notify the Campus Police Department, including El Camino Community College District Health Center Receptionists. It is still the victim's decision whether to make a police report or not. The El Camino Community College District shall, as best as practical, maintain the identity of any alleged victim of sexual assault on El Camino Community College District property in confidence unless the alleged victim specifically waives that right to confidentiality. The El Camino Community College District shall, as best as practical, maintain the identity of any alleged assailant who is a student or an employee in confidence unless the alleged assailant waives that right to confidentiality (El Camino Community College District Board Policy 3540).

All personally identifiable information is kept confidential, but statistical information must be passed along to law enforcement regarding the type of incident and its general location, on or off campus, for publication in the Annual Campus Security Report. This report helps to provide the community with a clear picture of the extent and nature of campus crime, to ensure greater community safety. Mandated federal reporters include: student conduct officers, campus law enforcement, local police, coaches, athletic directors, student activities staff, human resources staff, advisor to student organizations and any other official with significant responsibility for student and campus activities. The information to be shared includes the date, the location of the incident and the Clery crime category.

#### DEFINITIONS

**DOMESTIC VIOLENCE** is defined as violence committed against an adult or a minor who is a spouse or former spouse, cohabitant or former cohabitant, or someone with whom the abuser has a child, has an existing dating or engagement relationship, or has had a former dating or engagement relationship.

**DATING VIOLENCE** is defined as violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim.

STALKING is defined as behavior in which a person repeatedly engages in conduct directed at a specific person that would cause a reasonable person to fear for his or her safety, the safety of others or suffers substantial emotional distress.

SEXUAL HARASSMENT is defined as unwelcomed sexual advances, requests for sexual favors and other verbal, nonverbal, or physical conduct of a sexual nature. Sexual harassment is conduct that explicitly or implicitly affects a person's employment or education or interferes with a person's work or educational performance or creates an environment such that a reasonable person would find the conduct intimidating, hostile, or offensive. Sexual harassment includes sexual violence (see definitions below). The El Camino Community College District will respond to reports of any such conduct in accordance with District Policy on Sexual and Other Assaults on Campus.

Unwanted sexual misconduct which may lead to a complaint of sexual harassment:

Electronically recording, photographing, or transmitting intimate or sexual utterances, sounds, or images of another person and/or falsifying a posting on an electronic site involving sex or sexual activity.

#### SEXUAL ASSAULT DEFINITIONS

RAPE is an act of sexual intercourse accomplished against a person's will by means of force, violence, duress, menace or fear. Also, where a person is prevented from resisting by any intoxication or controlled substances or when a person is unconscious.

SEXUAL BATTERY is unsolicited and unwanted touching of an intimate part (sexual organ, anus, groin, buttocks, and breast of a female) of another person's body. This includes situations where the victim is unable to resist due to alcohol or drug use.

FORCIBLE SODOMY is oral or anal sexual intercourse with another person, by force or fear, and against their will. Also, when the person is incapable of giving consent because of age or mental or physical incapacity, the person may be a victim of sodomy.

SEXUAL ASSAULT WITH AN OBJECT is the use of an object or instrument to unlawfully penetrate, however slight, the genital or anal opening of another person, forcibly and against their will or where the victim is incapable of giving consent because of his/her youth or temporary or permanent mental or physical incapacity.

#### CONSENT

CONSENT is informed. Consent is an affirmative, unambiguous, and conscious decision by each participant to engage in mutually agreed-upon sexual activity.

CONSENT is voluntary. It must be given without coercion, force, threats, or intimidation. Consent means positive cooperation in the act or expression of intent to engage in the act pursuant to an exercise of free will.

CONSENT is revocable. Consent to some form of sexual activity does not imply consent to other forms of sexual activity. Consent to sexual activity on one occasion is not consent to engage in sexual activity on another occasion. A current or previous dating or sexual relationship, by itself, is not sufficient to constitute consent. Even in the context of a relationship, there must be mutual consent on engaging in sexual activity. Consent must be ongoing throughout a sexual encounter and can be revoked at any time. Once consent is withdrawn, the sexual activity must stop immediately.

CONSENT cannot be given when a person is incapacitated. A person cannot give consent if he/she is unconscious or coming in and out of consciousness. A person cannot give consent if he/she is under threat of violence, bodily injury or other forms of coercion. A person cannot give consent if his/her understanding of the act is affected by a physical or mental impairment. A person cannot give consent if he/she is under the influence of alcohol or drugs.

### PREVENTION

Avoid excessive use of drugs, alcohol and any other substances that interfere with your ability to think clearly and communicate effectively.

Be aware of your surroundings. Stay away from isolated areas, day or night.

If you are being followed, walk or run to a crowded area as fast as you can. If you are driving, drive to a lighted, populated place, or a police or fire station.

Lock all doors to your car.

Communicate with friends/family so they know when to expect you and where you are supposed to be.

Campus Escorts are available to all times and especially during evening hours to assure your safety on campus and in parking lots.

Emergency phones are located throughout the campus and parking lots for you to access Campus Police immediately should you need assistance with any emergency occurrence.

### VICTIM ASSISTANCE

The El Camino Community College Police Department is committed to assisting victims of crimes. The Community Oriented Policing Unit offers many referrals to professional psychological/social service agencies, accompaniment to court (if needed), advocacy and by providing support and information.

The El Camino Community College District is committed to ensuring that students, employees and visitors are treated with sensitivity, dignity and, where ever possible, confidentiality. Title IX of the Education Amendments of 1972 and El Camino Community College District Board Policy 3540 ensures that victims of sexual assault, domestic violence, dating violence, stalking and sexual harassment will be provided with counseling services and resource information. Victim's assistance may include

changing academic environment or working situations. Every effort is made to ensure that our educational environment promotes and assists prompt reporting and compassionate support services. This service is provided to both men and women. Counseling services are available at the El Camino Community College District Health Center (310-660-3643). A community resource list is also available at the El Camino Community College District Health Center and at the El Camino Community College District Police Department. Harassment/discrimination complaints can be made to the El Camino Community College District Director of Staff and Student Diversity (310-660-3593 extension 3813).

A victim of a rape, dating violence, domestic violence, sexual assault, or stalking may request and receive any reasonable changes to their academic situation by contacting the El Camino Community College District Director of Staff and Student Diversity (310-660-3593 extension 3813).

If the victim desires, the alleged perpetrator will be prosecuted to the fullest extent of the law. The alleged perpetrator will also face academic disciplinary action and is entitled to due process and will be given notice and a full, fair and impartially investigated and resolved. Proceedings will be conducted by officials who receive annual training on the issues related to domestic violence, dating violence, sexual assault, and stalking and know how to conduct an investigation and hearing process that protects the safety of victims and promotes accountability.

The accuser and the accused are entitled to the same opportunity to have others present during an institutional disciplinary proceeding, including the opportunity to be accompanied to any related meeting or proceeding by an advisor of their choice. Both accuser and the accused shall be simultaneously informed, in writing, of the outcome of any institutional disciplinary proceeding that arises from an allegation of domestic violence, dating violence, sexual assault, or stalking.

All public information regarding the alleged violation will be redacted to protect the confidentiality of the victim.

In the event that an incident of sexual assault, dating violence, stalking, domestic violence has occurred on the El Camino Community College District campus, the Campus Police Department may issue an Emergency Protective Order. This order is effective for five court days or seven calendar days, whichever is earlier. The victim is then required to obtain a permanent protective order from the county superior court.

When a protective order is issued to a student or employee, the Campus Police Department asks that a copy of the order and the proof of service be left at the El Camino Community College District Police Department. This enables the police department to more easily confirm that the terms of the order have been violated and therefore enforce the order. If a restraining order is violated on the El Camino Community College District property, the Campus Police Department should be notified so that the protective order can be enforced. If it is violated away from El Camino Community College District campus, the local law enforcement agency should be notified.

If the victim does not want a protective court order, the victim may request assistance from the Office of Staff and Student Diversity. This may include but is not

limited to classroom changes and transportation between classes. These measures should minimize the burden on the victim.

### BYSTANDER INVOLVEMENT

As a Bystander, you can help combat domestic violence, dating violence, sexual assault, stalking and rape. Your most powerful tool is conveying your concern. The best way bystanders can assist in creating an empowering climate free of interpersonal violence is to diffuse the problem behaviors before they escalate. This can be accomplished by:

Approaching everyone as a friend

Do not be antagonistic

Avoid using violence

Be honest and direct whenever possible

Recruit help if necessary

Keep yourself safe

If things get out of hand or become too serious, contact the police

*To avoid abusive behavior watch for warning signs:*

Controlling behavior

Verbal abuse

Emotional abuse

Physical abuse.

***El Camino Community College District prohibits any offenses including, but not limited to, domestic violence, dating violence, and sexual assault and stalking (El Camino Community College District Board Policies 3540 and 5500).***

### SEXUAL ASSAULT RESPONSE INFORMATION

If you have been sexually assaulted, it is important that you seek help immediately. The El Camino Community College District can help by sharing a number of ways for you to get assistance, and you can choose the one(s) that you feel most comfortable with.

This section outlines the procedures the El Camino Community College District follows in responding to reports of sexual assault. It assumes that the incident occurred on or near campus. Many of the procedures and services described here

also apply if the incident happens off campus or if the individual reporting the assault is not a student or staff member.

The emergency telephone numbers are 9-911 (from campus extensions), 911 from pay telephones (no coins required) or cellular telephone. Our business number is (310) 660-3100. The El Camino Community College District Health Center telephone number is (310)-660-3643.

Police officers have your wellbeing as their primary concern. Members of the Campus Police Department have had specialized training in handling sexual assault cases and treat you with respect and sensitivity. If you choose to report the assault to the police, the assault will be investigated and prosecuted to the fullest extent of the law.

Regardless of your decision to report the assault to police, they will ensure that you are taken promptly to a physician for medical care and, if appropriate, collection of vital evidence required for proof of possible criminal activity.

Evidence collection is only done with the victim's permission and is free of charge. Even if the assault victim does not want to prosecute or make a police report, it is recommended that evidence be collected anyway. This is so that, if the victim later decides to file a police report and prosecute the perpetrator, the evidence will have been preserved. Evidence collection can be done at a hospital. The YWCA (877-943-5778) can provide advocates to assist the victim.

When an incident is reported to the El Camino Community College District Health Center, the individual to whom the report is made shall inform the victim of his/her option to notify the El Camino Community College District Police Department or the local police department of the incident.

- ✓ The victim shall also be informed of the importance of preserving evidence required for proof of possible criminal activity and of the availability of the institutional personnel to assist the victim in notifying the authorities of the incident, upon the victim's request. The victim shall also be informed of the existing on and off campus counseling, mental health, and other resources availability.
- ✓ The victim is informed that medical evidence can be collected at the same time as medical care is provided.
- ✓ Under these circumstances, the victim is informed that the State will bear the cost of the medical exam and the victim is instructed not to bathe, shower, or douche so that important medical evidence can be preserved.
- ✓ Although the victim is not required to notify the law enforcement agency regarding the incident, the person to whom the report is being made shall contact the Campus Police Department to inform them that a sexual assault may have occurred so that they can coordinate the campus' response to the incident.
- ✓ After the Campus Police Department is contacted, a uniformed officer will be dispatched to take the report. The victim may request a male or female officer to take the report and this request will be accommodated whenever possible.

- ✓ With the consent of the victim, a full police report will be taken by a Campus Police Officer who accompanies the victim to the hospital. At the request of the victim, a friend, family member or other designated person may be present.
- ✓ The officer will accompany the victim to the hospital. The officer will advise the victim regarding hospital procedures and the availability of assistance through the El Camino Community College District Health Center.
- ✓ A Campus Police Officer will be assigned to further investigate the criminal allegations and explain the legal process to the victim. The Campus Police Officer shall present a completed written investigation to the Los Angeles County District Attorney's office for review and filing of criminal charges.
- ✓ If the victim is unwilling to report the matter to the police or to be transported to the hospital by the police, she/he is then urged to seek assistance immediately from the El Camino Community College Health Center or a rape treatment center for coordination of medical care and assistance counseling, and other available support alternatives.
- ✓ The victim is also informed that she/he may seek the assistance of other resource for advocacy support and assistance throughout the complaint process.
- ✓ If the victim is a student, she/he may request changes in his/her academic situation or that of the alleged assailant, after the victim has made a report of an assault, and the El Camino Community College District shall grant any reasonable request for such change.
- ✓ When a student reports being sexually assaulted by another student or a staff member, the El Camino Community College District Director of Staff and Student Diversity, or designee, shall conduct a prompt, fair, impartial and thorough investigation of the allegations. The El Camino Community College District Director of Staff and Student Diversity, or designee, is trained annually in issues concerning dating violence, domestic violence, sexual assault, and stalking, as well as how to conduct an investigation and hearing process that protects the safety of victims and promotes accountability.
- ✓ The individual charged with sexual assault is entitled to due process and will be given notice and a full opportunity to respond to the allegation made against him/her. The accuser and the accused are entitled to the same opportunities to have others present during a disciplinary proceeding. The accused and the accuser have the same opportunity to have a non-participating observer present during the proceedings, and are entitled to information about the El Camino Community College District policy on rape and sexual assault and the procedures that will be followed to address the issues.
- ✓ Any form of retaliation or intimidation against anyone who has complained of or formally reported discrimination, harassment, or sexual misconduct, or has participated in an investigation of such a complaint, regardless of whether the complaint relates to the complaining person or someone else, will not be tolerated, and violates El Camino Community College District Board Policies 3430 and 3540, this procedure, and applicable law.
- ✓ At the conclusion of the investigation, the El Camino Community College District may impose disciplinary sanctions. The student who reports being

sexually assaulted and the accused party are informed of the outcome at the same time. The charged student may appeal the action as set forth in the El Camino Community College Standards for Student Conduct (El Camino Community College District Board Policy 5500).

- ✓ When the El Camino Community College District imposes disciplinary sanctions upon students, the following types may be employed (El Camino Community College District Administrative Procedure 5520):

Warning

Reprimand

Restitution

Disciplinary Probation

Removal By The Instructor

Suspension

Immediate Suspension

Expulsion

- ✓ When the District imposes disciplinary sanctions upon an employee, the following types may be employed (El Camino Community College District Board Policy 7140, Bargaining Agreements):

Warning/Verbal Counselling

Written Reprimand

Involuntary Transfer

Suspension With or Without Pay

Demotion

Dismissal

- ✓ Due process disciplinary procedures consist of:

***Lodging Of Charges***

If the accused is on immediate suspension, the hearing shall be within fifteen (15) days.

If the accused is not on immediate suspension, the hearing must be requested by the accused within five (5) days. The hearing will be scheduled within fifteen (15) days of the request.

### ***Hearing Of Charges***

The public shall be excluded

Recorded by either audio recording or stenographic recording

The hearing officer may conduct the hearing in any manner he or she deems appropriate.

When a decision is reached, the accused and the accuser shall be simultaneously notified, in writing, of his or her right to appeal.

### ***Appeal Hearing***

- ✓ An Appeal Committee will be formed of three (3) members, all District employees and all of which are trained annually on issues related to dating violence, domestic violence, sexual assault and stalking, as well as how to conduct an investigation and hearing process that protects the safety of victims and promotes accountability.

The accused party and/or the accusing party may seek appeal. It must be submitted in writing to the Title IX Coordinator or District Disciplinary Officer within seven (7) calendar days after notified of decision.

An appeal will only be granted if the Appeal Committee determines that the decision of the El Camino Community College District Disciplinary Officer was in error, new evidence has become available or the sanction imposed was excessive or insufficient.

If the Appeal Committee determines that appeal is not appropriate, the party seeking the appeal will be notified within fourteen (14) business days after receipt of accused's request for review.

If the Appeal Committee determines that an appeal is appropriate, the party seeking the appeal shall file the appeal within fourteen (14) business days after receipt of the decided outcome.

Upon request, the El Camino Community College District will disclose the results of any disciplinary proceeding conducted by the District against a student who is the alleged perpetrator of any crime of violence or a non-forcible sex offence (statutory rape, incest) to the alleged victim or, if the victim is deceased, the victim's next of kin.

## CRIME STATISTICS

Under the federal "Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act," formerly the Crime Awareness and Campus Security Act of 1990, the El Camino Community College District must annually distribute statistics on the reported occurrences of the following offenses:

***Murder and Non-Negligent Manslaughter:*** The willful, non-negligent, killing of one person by another.

***Manslaughter:*** The killing of another person through gross negligence

### ***Sex Offenses Forcible***

***Sexual Assault:*** Any sexual act directed against another person, without consent of the victim, including instances where the victim is incapable of giving consent.

***Forcible Rape:*** Penetration, no matter how slight, of the vagina or anus, with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim. This offense includes the rape of both males and females.

***Forcible Fondling:*** The touching of the private body parts of another person for the purpose of sexual gratification, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental incapacity.

***Non-Forcible:*** Unlawful, non-forcible sexual intercourse.

***Incest:*** Sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.

***Statutory Rape:*** Sexual intercourse with a person who is under the statutory age of consent.

***Robbery:*** The taking or attempted taking of anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

***Aggravated Assault:*** An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.

***Burglary:*** The unlawful entry of a structure to commit a felony or a theft.

***Motor Vehicle Theft:*** The theft of or attempted theft of a motor vehicle.

**Arson:** Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another , etc.

**Hate Crimes:** A criminal offense (Murder and Non-Negligent Manslaughter, Sexual Assault, Robbery, Aggravated Assault, Burglary, Motor Vehicle Theft, Arson, Larceny-Theft, Simple Assault, Intimidation, and Destruction/Damage/Vandalism of property) that manifests evidence that the victim was intentionally selected because of the perpetrator’s bias against the victim. Where there is evidence of victim selection based on actual or perceived bias against the victim’s race, religion, gender, sexual orientation, ethnicity, national origin or disability.

**Larceny-Theft:** The unlawful taking, carrying, leading or riding away of property from the possessing or constructive possession of another.

**Simple Assault:** An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

**Intimidation:** To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

**Destruction/Damage/Vandalism of Property:** To willfully or maliciously destroy, damage, deface, or otherwise injure real or personal property without the consent of the owner or the person having custody or control of it.

**Domestic Violence:** Violence committed against an adult or a minor who is a spouse or former spouse, cohabitant or former cohabitant, or someone with whom the abuser has a child, has an existing dating or engagement relationship, or has had a former dating or engagement relationship.

**Dating Violence:** Violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim.

**Stalking:** Behavior in which a person repeatedly engages in conduct directed at a specific person that would cause a reasonable person to fear for his/her safety, the safety of others or suffers substantial emotional distress.

**Arrests/Referrals** for campus disciplinary action for liquor law violations, drug abuse violations and weapons possession.

These offenses must be reported according to their occurrence in the following location categories:

- El Camino Community College District Campus
- Public Property Reasonably Contiguous to the El Camino Community College District Campus
- Non-Campus Buildings

## CAMPUS CRIME REPORTING PROCEDURES

Working together, safety at El Camino Community College Business Training Center is everyone's concern. No community, of course, can be totally risk free in today's society. Students, faculty, staff and visitors are partners in creating an atmosphere that is safe and conducive for teaching and learning. The El Camino Community College Police Department encourages the reporting of any crime or suspicious activity by contacting the police department (El Camino Community College District Board Policy 3515). Any office on the El Camino Community College District Campus will assist you in contacting the Campus Police Department. If you do not wish to make a report to the Campus Police Department, you may contact the El Camino Community College District Director of Title IX coordinator at 310-660-3593 extension 3813. If you do not wish to contact the Campus Police Department, you may report a crime to a Campus Security Authority. Campus Security Authorities include but are not limited to El Camino Community College District Administrators (located in all division offices), athletic coaches, club advisors, academic counselors, and the El Camino Community College District Health Center.

The Campus Police Department is the primary law enforcement agency for reporting and investigating all crimes that occur on the El Camino Community College District Campus. Any instances of criminal activity occurring on the El Camino Community College District campus should be reported to the Campus Police Department.

You may contact the Campus Police Department by calling (310) 660-3100, dialing 3100 from any El Camino Community College District telephone, dialing 911, using one of the many blue emergency poles that are located throughout the campus or by coming into the police station which is located in Parking Lot K at the corner of Redondo Beach Boulevard and Crenshaw Boulevard.

When a crime is reported to the Campus Police Department, a police officer will take a report outlining the circumstances of the incident, as well as any other pertinent information. The report is forwarded to the detective unit, where the detective reviews the report and evidence with the intent to determine the perpetrator(s) of the crime.

In all instances of criminal activity, the Campus Police Department works to determine the exact nature and perpetrator(s) of the crime for the purpose of developing a viable criminal case to be forwarded to the Los Angeles County District Attorney's Office for prosecution.

In all cases where a student is considered a suspect, the Campus Police Department will also forward the case information to the El Camino Community College District Director of Student Development for review and action as a possible violation of the Standards of Student Conduct.

The El Camino Community College District does not have a policy pertaining to confidential reporting of crimes; however, the Campus Police Department does accept voluntary, anonymous reports. Confidentiality will be kept as much as is possible. We also encourage those who are bound by "client confidentiality", (clergy, professional counselors) to inform persons they are counseling, of the desirability to make a formal crime report with the Campus Police Department. The El Camino Community College District does not have reporting procedures that encourage

pastoral and professional counselors to inform the victims they are counseling of any procedures to report crimes.

### GENERAL BUSINESS LINE

Contact the El Camino Community College District Police Department (310) 660-3100 or dial extension 3100 from any El Camino Community College District telephone.

### EMERGENCIES

In an emergency, Dial 9-911 or press the "POLICE" button from any El Camino Community College District telephone, pick up any of the emergency phones located in many of the buildings, press the button on any of the blue "POLICE" phones located in the parking lots, along many of the campus walkways and in all building elevators and some hallway or call (310) 660-3100 from a cellular telephone.

### WHAT POLICE WILL WANT TO KNOW WHEN YOU CALL

Police need to know basic information about the crime or incident you are reporting. Expect to hear these types of questions:

Who:

- Who are you? What phone number and location are you calling from?
- Don't hang up the phone until the dispatcher tells you to do so. You may be put on hold while the dispatcher contacts emergency responders.

What:

- What exactly happened or is happening? Describe the situation in complete detail.
- What are the suspect's physical characteristics? (race, sex, height, weight, hair color, etc.)
- What was the suspect wearing?

Where:

- Where are you now?
- Where did the crime happen?
- If the suspects are gone, where did they go? In what direction?
- Did they use a car or some other transportation? Did you get a license number?

When:

- When did the crime happen? Is it still in progress? (This is very important and will determine the level of response.)

## CRIME PREVENTION

One of the essential ingredients of any successful crime prevention program is an informed public. It is the El Camino Community College District Police Department's intent to inform students and staff of any criminal activity or security problems that may pose a reasonable threat to their physical safety.

A critical element of a campus safety program is education. The Campus Police Department will present safety programs, seminars and discussions on such topics as sexual assault awareness and personal safety on and off campus upon request. You may reach the Police Department by calling (310) 660-3100.

All effective crime prevention programs include some measure of people watching out for one another. All staff and students are asked to stay alert and aware of what is going on around them, and remain security conscious and involved.

## CAMPUS SAFETY/CRIME PREVENTION PROGRAMS AND SERVICES

The El Camino Community College District Police Department provides a wide variety of safety services as part of our efforts to provide quality police services to the campus community. Some of these programs and services include, but are not limited to, the following:

### Police Department Patrols

The El Camino Community College District Police Department uses uniformed and non-uniformed officers to patrol the campus and surrounding areas in cars, on bicycles, and on foot 24 hours per day, 7 days per week. These patrols are conducted on all roadways and walkways of the campus, as well as in and through the buildings.

### Campus Police/Emergency Telephones

There are emergency phones located throughout the campus that provide members of the El Camino Community College District community with direct access to the Campus Police Department. These phones ring into the Campus Police Department dispatch center and are operational 24 hours per day, 7 days per week. The Campus Police Department conducts a regular inspection of the emergency phones to insure that they are in good working order and works closely with the El Camino Community College District Facilities Planning and Services Division to arrange for repair of telephones that are found to be in need of service.

### Campus Courtesy/Escort Service Shuttle

The El Camino Community College District Police Department operates a campus courtesy shuttle. Police Cadets, Community Service Officers and Police Officers are available anytime to escort you on campus if you feel your safety is in question. You may obtain this service by calling (310) 660-3100 or by calling from any of the "Police" phones.

### Crime Prevention/Awareness Presentations

The El Camino Community College District Police Department Community Oriented Policing Unit (C.O.P.S.) will come and speak to your office, class, club, or organization. Upon request, the officers speak about the myths and realities of crime on campus and how you can stay safe. There are also a variety of topic including but not limited to sexual assault, rape, stalking, domestic violence, and bystander information. If you would like to have an officer speak to your organization, please contact the Community Oriented Policing Unit at (310) 660-3100 or stop by the Campus Police Department. Similar sexual misconduct and gender violence presentations are also available from the El Camino Community College District Office of Staff and Student Diversity.

Various student organizations present programs and events throughout the year aimed at educating the campus community.

#### Parking and Traffic Committee

The El Camino Community College District Police Department has a Parking and Traffic committee that meets monthly or as needed basis to discuss the delivery of police services to the campus community. The committee is made up of members of the campus community and they assist the El Camino Community College District and Chief of Police with setting priorities and in the delivery of police services to the campus community. These services include but are not limited to traffic control, parking, and safety concerns.

#### Assessment, Intervention and Management of Safety

The Assessment, Intervention, and Management of Safety (AIMS) is a multidisciplinary campus threat assessment and behavioral intervention team that guides the El Camino Community College District campus community in effectively assessing and addressing threatening and/or concerning behaviors. AIMS strives to assist the campus in intervening before behaviors reach a critical level.

#### Crime Prevention Activities

The El Camino Community College District Police Department sponsors several crime prevention activities. The activities are normally held in the center of campus and flyers are posted around campus announcing the events. Some of the activities have included: Vehicle Security Fair, Law Enforcement Expo and Recruitment Fair, Driving Under the Influence Workshop. Various student organizations also present activities including: Social Justice Fair, and Clothesline Project. We invite members of the campus community, students and employees, to participate in these activities and learn how one can be better prepared. Programs occur about once a month during the Spring and Fall semesters.

#### Crime Prevention Literature

The El Camino Community College District Police Department maintains a wide variety of crime prevention material in the lobby of the police department. This material deals with a wide variety of topics such as: personal safety, sexual assault awareness, home security, vehicle security, domestic violence prevention, etc.

Please stop in the police department or stop by the Campus Police Department information booth on campus and avail yourself of this valuable information.

#### El Camino Police Department Web Site

The El Camino Community College Police Department maintains a web site to provide the campus community with information about the police department and the services provided ([www.elcamino.edu/police](http://www.elcamino.edu/police)).

#### Police Beat in El Camino "Union" Campus Newspaper

The El Camino Community College Police Department works closely with the student newspaper, the "Union," to report all criminal and unusual incidents that have occurred on campus. We consider our relationship with the student newspaper a real asset to the campus community and an excellent way to keep the campus informed about what type of incidents have occurred on campus. We applaud our student newspaper staff for assisting us in getting this important information out to the campus community.

#### Campus Lighting

El Camino Community College District is on a continual quest to improve and maintain lighting around campus. The Campus Police Department completes a regular inspection of campus lighting and works closely with the El Camino Community College District Facilities, Planning and Services Division to repair inoperative lighting and to install additional lighting where a need has been identified.

#### C.O.P.S. - Community Oriented Policing

The El Camino Community College District Police Department Community Oriented Policing Unit sets up a table on the inner-campus periodically throughout the semester to be available to the campus community. We encourage members of our campus community to stop by the table, meet our department personnel, and avail themselves of the crime prevention information on display. We look forward to meeting you.

#### HOW WE REPORT CRIME TO THE CAMPUS COMMUNITY

Crime Statistic information is posted in this booklet and on our web site. In addition, El Camino Community College District utilizes a communication service that allows us to send important emergency information directly to students, faculty and staff. The Nixle Community Information Service allows us to create and send messages to subscribers instantly via text message, and/or email. The notifications are initiated by the El Camino Community College District Chief of Police for alerts and advisories, and the El Camino Community College District Public Information Office for advisories and community information. When receiving these emergency notifications, they will be rated according to the College's emergency designations.

- Alerts- Emergencies, imminent action/response needed
- Advisories- Important notices, no action needed at this time

- Community- Parking lot closures, etc.

As soon as an emergency or dangerous situation is confirmed, the Campus Chief of Police will notify the campus community. Confirmation includes verifying that the emergency or dangerous situation is real and whether or not an eminent threat to persons on or around the campus exists. Verification consists of communication with Police Officers on patrol throughout the campus, surrounding law enforcement agencies and/or public works department in neighboring areas. If the emergency or dangerous situation is confirmed, an alert will be sent on Nixle system, ECC Alert via El Camino Community College District telephones and/or over the campus public address system, whichever is appropriate. In the case of advisories, Nixle notifications, emails and possibly posted bulletins around campus may be used. Updates will be sent when available.

El Camino Community College District will not send a notification if issuing a notification will, in the professional judgment of responding authorities, compromise efforts to assist a victim or to contain, respond to, or otherwise mitigate the emergency.

You may report an emergency or dangerous situation by calling 310-660-3100 or 911, or using an emergency phone/pole.

Text the following message-**ECCPD**- This will allow you to receive alerts from the El Camino Community College District Campus. You will receive a confirmation message.

In an imminent emergency (Alert), the Standardized Emergency Management System (SEMS) will be put in use. SEMS is a group of principles developed for coordinating State and local emergency response in California. SEMS provides for a multiple level emergency organization and is intended to structure and facilitate the flow of emergency information and resources within and between the organizational levels; the field response, local government, operational areas, regions and the State management level. The organizational responses of these various agencies adhere to the same set of standards—those of the Incident Command System.

El Camino Community College District conducts a "Shelter in Place" drill during the Spring Semester and participates in the "Great California Shake Out" during the Fall semester. With these drills, the Emergency Operations Center (EOC) is also activated. The EOC provides a centralized point of El Camino Community College District emergency management. These drills are publicized to the campus community, in advance, via email.

Response levels

Level 1 – Minor to Moderate incident – Site Incident Commanders activates their Site Emergency Plans. Communication with the College Police Department and Local Emergency Responders (911). College Police Department informs District EOC via

the EOC Director. (Example: gas leak, toxic spill, bomb threat, medical emergency, shooting – a single location is involved.)

Level 2 – Moderate to Severe Emergency – Site Incident Commanders are in charge of on-scene response and directing the Site Command Team. Communication with College Police Department, Local Emergency Responders, and District EOC. District EOC partial to full activation. Coordinates with Los Angeles County Operational Area EOC. (Multiple sites are involved. Resources are not adequate and mutual aid may be required.)

Level 3 – Major Disaster – Site Incident Commanders are in charge of on-scene response and directing the Site Command Team. Communication with College Police Department, Local Emergency Responders, and District EOC. District EOC fully activation. Coordinates with Los Angeles County Operational Area EOC. (Resources are overwhelmed. A Local Emergency will be proclaimed, a State of Emergency will be declared and the Presidential Declaration of an Emergency or Major Disaster will be requested.)

#### ACCESS TO CAMPUS FACILITIES

In general, the El Camino Community College District Business Training Center is open from 7:30 A.M. to 5:00 P.M. Monday through Friday and any time classes are scheduled. The Campus Police Department may question anyone who does not appear to have authorization to be in a building after hours. Campus buildings are locked after normal hours and on holidays. Staff and faculty are asked to contact Campus Police when entering a building or facility after normal hours.

It is the responsibility of those using rooms and offices to lock doors, turn-off lighting, and close all windows upon leaving. Campus Police personnel will check areas after hours but the primary responsibility for security lies with the user of the facility.

We cannot stress enough the importance of making sure campus facilities are secured when not in use. By working together we can prevent a vast majority of thefts and vandalism that occur to campus facilities left unsecured.

#### KEYS TO DISTRICT FACILITIES

Keys are provided to staff members on a need-to-enter basis as determined by the appropriate manager. Lost or stolen keys must be reported immediately to Campus Police and the employee's manager or supervisor. Keys may not be loaned to other staff members or to students. Campus Police will confiscate any keys, which have not been specifically issued to a particular individual. Unauthorized duplication and illegal possession of keys is a misdemeanor.

#### MAINTENANCE OF DISTRICT FACILITIES

The El Camino Community College District Facilities Planning and Services Division (FPS) is responsible for the maintenance of district facilities. The Campus Police Department and FPS Division work closely to insure the district facilities are maintained for safety and security.

## DISTRICT PROPERTY

No El Camino Community College District property may be removed from campus without expressed permission from the District. Unauthorized removal of property from campus is a violation of the law and District policy.

## SUBSTANCE ABUSE POLICY

In accordance with Public Law 101-226, "Drug Free Schools and Communities Act Amendment of 1989," the Board of Trustees of the El Camino Community College District prohibits the unlawful possession, use, distribution or manufacture of illicit drugs (El Camino Community College District Board Policy 3550) and alcohol (El Camino Community College District Board Policy 3560) by students, employees and visitors on El Camino Community College District property or at any El Camino Community College District sponsored or sanctioned activity.

In accordance with El Camino Community College District Board Policy 3550 "Drug Free environment and Prevention Program", El Camino Community College District has a substance abuse education program, which includes special presentations, health classes, workshops and programs.

Any student or employee in violation of this policy is subject to disciplinary action up to and including expulsion from El Camino Community College District Business Training Center or termination from employment for violations of this policy.

The possession, use or sale of alcoholic beverages by anyone on El Camino Community College District property is a misdemeanor as per California Business and Professions Code 25608 and a violation of the El Camino Community College District Board Policy 3560.

Use, sale or possession of any illegal drug is a violation of California state law and the policy of the El Camino Community College District (El Camino Community College District Board Policy 3550).

Any person found in violation of laws pertaining to alcohol or drugs, including underage drinking, may be subject to arrest by the Campus Police Department. Criminal prosecution is separate from any administrative discipline that may be imposed by the District.

## Tobacco

El Camino Community College District is a smoke and Tobacco free environment. El Camino Community College District prohibits the use of cigarettes, e-cigarettes, cigars, snuf, snus, water pipes, hookahs, chew or any other non-combustible tobacco product on any District property (El Camino Community College District Board Policy 3570).

## WEAPONS POSSESSION

It is a serious violation of El Camino Community College District Board Policy 3530 and the California Penal Code Section 626.10 to possess a firearm or certain knives on District property, on school ground or in school buildings. Written permission must be obtained from the Office of the President of El Camino Community College District or the president's designee (El Camino Community College District Board Policy 3530).

## MEGAN'S LAW/SEX OFFENDER REGISTRATION REQUIREMENT & INFORMATION

The State of California requires sex offenders to register with the police in the jurisdiction in which they reside. The State makes this information available to law enforcement agencies and to the public. California state law also requires sex offenders that are enrolled, employed, or carrying on a vocation with or without compensation at an institution of higher education to register with the college/university police.

California law and CA DOJ's Megan's Law web page allows the public to view information about sex offenders that may be residing in their community. This enables the public to be aware of potential risks in their community. The public can then make informed decisions when taking safety precautions to protect themselves and their children from sex offenders.

## CRIME PREVENTION TIPS ON AND OFF CAMPUS

### On Campus

- Be especially aware of your surroundings at times when you may be less alert and more vulnerable to an attack; e.g., during exams, when you are upset, sick, or tired.
- Use discretion and caution when taking shortcuts through isolated parts of campus.
- Know the location of emergency phones on routes to and from class.
- Keep personal belongings in view while in class, the library or lab.
- Wherever you are, on campus or off, if you see or hear someone who might be in trouble, your options include running, yelling, confronting, and calling the police.
- Learn self-defense techniques by enrolling in a self-defense class.
- Use the Escort service by calling Campus Police.
- Ride the campus courtesy shuttle.

### Using ATM Machines

- If you feel threatened while using the ATM, push the cancel button to cancel your transaction. Just walk away and complete your transaction later.
- Avoid using an ATM at night. Most ATM crimes occur between 7:00 PM and midnight.
- If you must use an ATM at night take another person with you.

- Check around the ATM first to make sure no one is lurking in the shadows.
- Use machines that can be clearly seen from a street or public area.
- Use machines that are inside buildings or in well-lighted areas.

#### In an Apartment.....At Home

- Install and use locks on your doors and windows.
- Have your locks changed, re-keyed or add a new lock when you move into a new house or apartment.
- Keep doors locked day or night whether you are home or not.
- Know who is at the door before opening it. Demand I.D's from anyone you don't know.
- If someone comes to your door and asks to use your phone to call for help, offer instead to make the call.
- If you live in an apartment, be alert when in the laundry or garage area by yourself.
- Close your blinds and shades at night.
- Give your home a "someone home" look. Put radio and lights on a timer.
- Have good lighting around entrances.
- Develop an escape plan for use in case of an intruder or fire.
- Leave spare keys with a friend, not in accessible places.
- Know your neighbors and know which ones you can trust in an emergency.
- Keep emergency numbers near the phone.

#### On the Street...While Walking

- Act confident. Look and be alert about the people around you.
- Be aware of your surroundings. Cross the street or change direction if you think you are being followed.
- Be careful when people ask you for directions. Reply from a distance rather than getting too close to a car.
- Travel with a friend whenever possible to reduce the chances of being attacked. This includes going to public restrooms.
- Wear clothes and shoes that give freedom of movement.
- Vary your route if possible.
- Consider carrying pepper spray for personal protection. Know how to use it and have it readily available when out in public.
- Notice cars that pull up beside you or pass you more than once.
- Keep one hand free when walking.
- Carry change for bus fare or a telephone call.
- Do not hesitate to get attention however you can if you are in trouble. Do not be afraid to make a scene.
- If you travel a regular route at night, become familiar with stores that stay open, gas stations, and other places where there will be people.
- If you use a wheelchair, try to check your destinations ahead of time for accessible entrances.
- For an emergency, use a public phone to dial 911 (no coin is necessary).

#### Driving a Car

- Have your keys in your hand as you approach your car.
- Lock your doors when driving and after parking.

- Check the back seat and floor.
- Always keep at least a half tank of gas in your car.
- Maintain the car in good running condition.
- Keep your valuables out of sight, under the seat, in the glove compartment or trunk.
- Park in well-lighted areas.
- Try to be especially alert in parking structures.
- Avoid parking next to vans, as you can be pulled in through the sliding door.
- If you have car trouble, signal for help by raising the hood or tying a handkerchief to the door. Remain in the car with doors locked until identifiable help arrives.
- Should another motorist offer to help, roll down window only an inch and ask him or her to call the police or auto club.
- Keep an emergency kit containing a flashlight, flares, telephone change, distress signs and other essentials in your car.

#### On the Telephone

- Be wary of telephone surveys.
- List only your first initial and last name in the telephone directory.
- Think about the information you give out over the telephone and to people you don't know well. Tell roommates and housemates not to give information by phone about who is home, who is out, how long anyone is expected to be out.
- Never reveal your number to a wrong number caller.
- If you receive a threatening or obscene phone call, hang up. Blow a loud whistle or leave the phone off the hook. Contact the police and make a report.
- Answering machines may be used to screen calls. Your outgoing message should not say that you are away from home.

#### On an Elevator

- Check the inside of an elevator before entering. Wait for the next elevator if you are unsure of the people inside.
- When riding an elevator, stand by the control board. If you feel in danger, press all the buttons and get off the elevator as soon as possible.
- All elevators on the El Camino College campus are equipped with emergency phones.

#### On Public Transportation

- Check the bus schedule to avoid long waits at the bus stop. Become familiar with routes and timetables in your area.
- Wait for buses at well-lighted stops.
- If possible, join other people at a nearby stop.
- If someone bothers you on the bus, say loudly, "Leave me alone" or "No". Get up and find another seat. Tell the driver.
- Stay awake on public transportation if you are alone.
- Notice who else gets off at your stop. If you feel someone is following you, walk towards a populated area. Avoid walking directly home.
- Be aware that hitchhiking can be very dangerous.

## While Cycling

- Use reflectors, reflective tape, or other similar devices on cycling shoes, fenders, belts, frames, pedals and handlebars.
- Keep to the right. Ride with traffic, not against it.
- Use hand signals to indicate turning or stopping.
- Ride defensively.
- Use bicycle paths whenever possible.
- Walk your bicycle across busy intersections.
- Perform regular maintenance checks.
- Wear appropriate clothing.
- Park your bike in an open, well lighted frequently traveled area.
- Secure it properly. The "U" bolt locks provide the best protection. Consult the Community Oriented Policing Unit of the El Camino College Police Department for more information.
- Report any suspicious person you may see loitering around bicycle racks.
- Always use a bike light and rear tail lamp when riding at night.

## While Jogging

- Be aware of your environment.
- If possible, consider jogging with a friend.
- Choose well-traveled running paths and be aware of any isolated areas you will run through.
- Vary your route.
- At night, wear light colored clothing or wear reflective markings.
- Tell your roommate or friend your route and expected time of return.
- If approached by a car while running alone, do not stop to give directions or answer questions. Leave the road and head for a populated area.
- Don't let yourself be surprised. Listening to your headset may make you unable to hear approaching traffic, emergency sirens or any other danger signals.

## If Attacked...Self-Defense

- If someone tries to grab your purse, let it go. Most injuries from robberies occur when people resist and refuse to comply with the robber's demands.
- If you are attacked, whether you resist and how you resist will depend on your personal resources and your personal values. Give some thought right now to what you would do in various situations that could arise. The more you have thought ahead, the more likely you will be to act in the way you've planned.
- Have you taken a self-defense class? Do you think you could hit or kick someone who is attacking you? Do you know how to get away from someone grabbing you? What objects could you use to defend yourself?
- In considering your reactions to different situations, keep these three basic rules in mind:
  - 1) Trust your instincts.
  - 2) Don't be afraid to be impolite or make a scene; this is especially important, even if it is someone you know.
  - 3) Try to remain calm--use your imagination and good judgment give yourself time to think.

### If You Are Sexually Assaulted

- Go to a safe place that has a phone.
- Call the police, rape crisis hotline, and a friend or family member. Tell someone.
- DO NOT wash hands, bathe, shower, douche, change clothes or straighten up the area. This destroys evidence.
- Reporting is your choice. If you do not report, try to write down the details of the assault and save them in case you change your mind.
- Whether you report or not, get medical attention for treatment of external and/or internal injuries and test for sexually transmitted diseases and pregnancy.
- Take time to recover. Get counseling.
