MINUTES

I. INFORMATION/ANNOUNCEMENTS

A. Alignment Grid/Flex Day Debrief (K. Whitney)

K. Whitney reported that all the departments completed the first draft of alignment grids on Flex Day. Some faculty found that the process of completing the grid helped them to understand the alignment of course SLOs, PLOs, and ILOs better. Other faculty expressed some frustration with how quickly they were expected to complete the alignments. C. Mello clarified that whole campus was attempting to meet the accreditation commissions' standard for alignment of outcomes. He agreed to communicate the faculty's displeasure to the SLO facilitators.
