Catalog Description: This class is designed to meet the minimum requirements for

training as required by Penal Code Section 832 and certified by the California Commission on Peace Officer Standards and Training (P.O.S.T.). The course is certified by P.O.S.T. in the areas of laws of arrest and ethical use of force, arrest methods and control, and firearms training. The course has 45 hours of lecture covering the California laws of arrest and firearms, 9 hours of training in arrest methods and control, and 18 hours of training in the use of firearms for a total of 72 hours. The course will cover the basic fundamentals of the laws of arrest, arrest methods and controls, and the basic principles of firearms training which will enhance an individual's ability to meet the State's minimum requirements for employment

in a law enforcement or allied agency.

Additional Description:

This is a standardized course and is certified by the California Commission on Peace Officer Standards and Training (POST). The course has three components: 45 hours of lecture covering the below listed topics (Learning Domains), 9 hours of training in arrest methods and control, and 18 hours of training in the use of firearms for a total of 72 hours. The Learning Domains contain the minimum

required foundational information.

PC 832 ARREST AND FIREARMS COURSE:

EL Camino College Student Learning Outcomes:

Students will be able to:

- Successfully pass the comprehensive CA. Peace Officer Standards and Training (POST)
 State PC 832 written test with a minimum score of 75%, covering course workbook and instructed materials;
- Successfully demonstrate and perform the instructed arrest control techniques at a skill level sufficient to pass CA. Peace Officer Standards and Training (POST) State PC 832 Arrest Control Techniques physical demonstration test;
- Demonstrate during the training to the instructor's satisfaction that they can safely handle and operate the supplied firearm during range training, and pass the firearms proficiency shooting test with a minimum shooting score, as per CA. Peace Officer Standards and Training (POST) State PC 832 requirements.

Course Student Learning Objectives

The major learning objectives of this course are listed below and will be evaluated through various assessment methods, which may include quizzes, examinations, presentations, essays, homework, and/or research projects.

- Students will learn about CA. Laws of Arrest.
- Students will learn about CA. Search and Seizure Law.
- Students will be able to identify Crime Scene Investigation methods available in investigations.
- Students will be able to safely operate and qualify with an issued pistol on a standard POST range qualification course.
- Students will learn about the function of the Criminal Justice System.
- Students will be able to identify Leadership, Ethical, and Professional standards for Peace Officers.

Grades-Examinations-Testing

GRADING-Multiple Testing Sections Requiring A Passing Score In Each Test



Since this course is for a CA. State Certification, students are required to demonstrate their proficiency in performing the tasks required by the skills test. Proficiency means that the student achieved a passing score in each area established by the CA. Peace Officer Standards and Training Commission.

LETER GRADE WRITTEN TEST: The letter grade for the course will be based on the final written examination score, except for any students who fail to pass the written test on the first attempt and need to take a retest. A successful retest with a score of 75% or better achieved (only one retest is permitted) will result in a final letter grade of a "C" regardless of the passing score percentage. To pass the comprehensive CA. Peace Officer Standards and Training (POST) State PC 832 written test a minimum score of 75% is required. Grade categories shall be as follows:

100% - 90% = A 89% - 80% = B 79% - 75% = C Below 75% = F

FIREARMS TEST: Students must pass the Firearms range qualification test in order to pass this course. This test requires the student to demonstrate to POST standards that they can safely handle and operate the supplied firearm during range training, and pass the firearms shooting proficiency range qualification test with a minimum shooting score, as per CA. Peace Officer Standards and Training (POST) State PC 832 requirements.

ARREST AND CONTROL TECHNIQUES TEST: Students must also pass the skill examinations on the Arrest and Control Techniques portion of the course. Students must successfully demonstrate and perform the required instructed skills of arrest control techniques at a skill level sufficient to pass CA. Peace Officer Standards and Training (POST) State PC 832 Arrest Control Techniques physical demonstration test. The testing standard is pass/fail.

To pass the PC 832 Arrest and Firearms course, students <u>must successfully complete all</u> <u>three testing components</u> of the PC 832 Arrest and Firearms Course to receive a passing grade in the course.

Student Conduct/School Policy/Course Policy

The classroom is a place for the conveyance of knowledge. Students must conduct themselves in a manner which is respectful of the other students and instructors.



This class is governed by all relevant El Camino College policies. Students will be expected to abide by El Camino College and Transportation Security Agency policies and conduct themselves appropriately.

The ability to express ideas, thoughts, and opinions verbally is a critical skill in all aspects of law enforcement and public services. Students are encouraged to participate in class, ask questions, and stimulate dialog with discussions regarding the topics.

Attendance

Students are expected to be in attendance each class session. Recognizing work schedules, childcare considerations, and other factors understandably might occur please let the Instructor know if you are going to be delayed or miss any class. (Please notify the instructor by email as soon as it is known that the student will be delayed, and when you will be arriving, including a phone contact).

With this type of course it should be every students goal not to miss any classroom, firearms, or Arrest and Control training. Only a very small amount of the entire training time may be missed (see CA POST Policy below) before the maximum limit has been exceeded.

There are also some mandatory periods (for safety reasons) that you will need to be present to advance further in the training (ACT/Firearms).

CA. Peace Officer Standards and Training Attendance Standards-Special Attendance Regulation:

Any person attending POST training for certification may not miss **more than 5% of the instruction**. Any student **missing more than 5% of attendance** will need to retake the entire course. Five percent of 72 hours should be **approximately 3.5 hours maximum**. This standard is more restrictive than normal college policy.

Academic Honesty Policy:

El Camino College places a high value on the integrity of its student scholars. When an instructor determines that there is evidence of dishonesty in any academic work (including, but not limited to cheating, plagiarism, or theft of exam material), disciplinary action appropriate to the misconduct as defined in BP 5500 may be taken. A failing grade on an assignment in which academic dishonesty has occurred and suspension from class are among the disciplinary actions for academic dishonesty (AP 5520). Students with any questions about the Academic Honesty or discipline policies are encouraged to speak with their instructor in advance.



Academic Accommodations Policy:

Additional Requirements-Fingerprint Livescan Clearance Required:

State law (PC 13511.5) requires that prior to enrollment in the firearms course, non-sponsored students obtain a firearms clearance through a criminal records check conducted by submission of fingerprints. The fingerprint check is submitted through the LiveScan system and usually costs the student between \$70 and \$100 (approximately). Charges vary depending upon location selected.

Safety:

Since this course includes both physical and firearm requirements, all students must be cognizant of the need to practice a high level of safety and care in this training.

Electronic Device Policy:

Recognizing that cellphones, IPADs, tablets, laptops, and similar devices are often required for work or other important notifications such as family illnesses or other emergencies they will be allowed in class. However I ask that you either turn them off or *set them to a non-audible signal such as vibrate*. In order to minimize classroom disruption, if it is absolutely necessary that you answer it immediately go out into the hallway to do so. Refrain from *texting, emailing on tablet, cellphone, laptop or PC* during class to prevent distractions to Instructor and students.

This course involves real world and contemporary issues as faced by law enforcement. Consequently, some of the instructional material includes printed, video, film, photographs, or presentations that may have serious issues and violence. Students are expected to view this material in a mature manner.

State of California Peace Officer Standards and Training Learning Domains used in this course. The Arrest and Firearms (PC 832) course consists of two components, which total a minimum of 64 hours. The Arrest component has a 40-hour requirement, and the Firearms component has a 24-hour requirement. These components are divided into 14 individual topics, called Learning Domains. The Learning Domains contain the minimum required foundational information for given subjects. The training and testing specifications for a particular domain may also include information on required instructional activities and testing requirements. The specific learning domains are identified in the PC 832 training specifications.
