Purpose of Position: To plan and implement developmentally appropriate programming for children ages 18 months to 2 ½ years old while providing quality, nurturing care.

Major Duties: The toddler teacher works under the supervision of the Director of Education. Job duties include, but are not limited to the following:

- Assure that each toddler and parents are greeted warmly and with enthusiasm each morning; each toddler is comforted; and is gradually assisted in joining group
- Supervise assigned group of children and be aware of total classroom/playground situation at all times; assure the well-being of all the children in that environment
- Plan and implement developmentally appropriate activities according to the individual and small group needs as well as their interests
- Facilitate and nurture the development of each child's self-esteem, trust, and growing autonomy
- Organize each day's activities to provide toddlers with a variety of experiences and opportunities that
 allow them to develop curiosity, initiative, problem-solving skills, and creativity, as well as a sense of
 self and a feeling of belonging to the group
- Tend to children's personal hygiene needs
- Consistently use positive guidance and classroom management techniques.
- Develop and maintain warm, open, and positive relationships with families.
- Complete timely, neat, and accurate documentation deemed necessary for providing quality services
- Serve as an educational resource to parents and community.
- Maintain knowledge of and compliance with Title 22 regulations specific to infants and toddlers.
- Other duties as assigned.

Required Qualifications:

- 1. Associate's Degree or equivalent in Child Development or Early Childhood Education, coursework must include a minimum of 3 units related to the care of infants/toddlers or instruction specific to infants/toddlers
- 2. Minimum of 2 years experience working with infants/toddlers in a licensed child care facility
- 3. Pediatric CPR & first aid training
- 4. Current negative TB test
- 5. Professional level knowledge of educational theory, child development, and teaching skills
