Dear Members of the Board:

Happy New Year! I trust all your resolutions are still intact and you are rested and ready for a rewarding, fulfilling and healthy 2014. My resolution is still intact. I have not made a thoroughbred horse wager at Hollywood Park yet this year.

As you know, our January Board meeting is Tuesday, January 21, in the Board Room at 4:00 p.m. Due to a prior commitment, Trustee Numark is unable to attend the meeting. Since Tuesday is the first full day of classes for the Spring semester, parking and traffic around the College will be difficult. A cadet will be posted to assist you with parking in the red reserved parking spaces on the perimeter road, south of the Administration building.

The agenda includes a presentation by Dr. Cynthia Mosqueda on El Camino College's First Year Experience Program. Please note Attachment A highlighting Dr. Mosqueda's recent honor.

The consent agenda is relatively brief. It is highlighted as follows:

- 1. Academic Affairs presents curriculum changes and a new format as explained in Dr. Francisco Arce's communication, Attachment B. Additionally, sabbatical leaves for 2014 are recommended.
- 2. Student and Community Advancement section includes the Community Education schedule for Winter/Spring 2014 (See Attachment C) and the acceptance of an application and grant. Please note Dr. Nishime's explanation of the Sector Navigator concept, Attachment D.
- 3. Administrative Services presents the recommended tuition fee for 2014-15.

We are pleased to report that the 2012-13 Annual Audit Report indicates that the financial statements fairly present, in all material respects, the financial position of

the business-type activities of the District as of June 30, 2013. This year there are only two recommendations: One highlights internal controls presented by reconciling two different accounting systems between the District and Los Angeles County and the other is the recognition that the Child Development Fund continued deficit spending. (See Attachment E)

Please note that per the Board's request at the last meeting, we have changed the presentation of services provided by the District vs. services received by the District for each of the contract categories either under the \$84,100 amount or above the \$84,100 amount.

Also included in this section is the recommendation to award the bid for the Allied Health Building project at the Compton Education Center. The Compton Special Trustee will also approve this recommendation at the Board meeting on the same day.

- 4. Administrative Services Measure E section recommends the approval of the International Parking Design (IPD) contract for architect and engineering design services for Parking Lot C. This item was tabled from the last Board meeting. Please note Attachment F from Mr. Thomas Brown providing answers to the Board's questions. Also note the completion of the upgrades in Lot F (channel parking structure).
- 5. Human Resources includes routine personnel items and a series of Board policies and procedures.
- 6. Compton Education Center section includes Attachment G, a resolution to establish an Adult Education Consortium for our Compton Educational Center.
- 7. The Superintendent/President and Board of Trustees recommend Student Trustee travel. The change in the Superintendent/President's travel extends the Annual Marketing Trip to include one meeting in London, England.

The 2014 Trustee goals were amended as indicated in the report. (See Attachment H)

The Non Consent Agenda recommends the approval for authorization to issue Tax Revenue and Anticipation Notes for 2013-14 and the accompanying resolution to execute the authorization. The Closed Session Agenda includes consultation with Ms. Linda Beam and Mr. Spencer Covert.

# Other Issues:

During the Foundation's report at the last Board meeting, questions were raised concerning the Foundation's International Student Housing Project. Please see Attachment I for Ms. Katie Gleason's updated information.

We are now in receipt of a letter of interest from the Los Angeles County Office of Education (LACOE) regarding the El Camino College Child Development Center. Please see Attachment J for Dr. Francisco Arce's communication on this issue. The College must also consider the long-term opportunities with the changing status of the Child Development Center and El Camino College's future land-use issues. Administration will most likely make a recommendation to contract with the Urban Land Institute to update our facilities plan and land-use arrangements.

A number of you will attend the Community College League of California (CCLC) Effective Trustee Workshop and Legislative Conference on January 24-27. You are sure to hear direction on mandated Board of Trustees' trainings. Please see Attachment K for Ms. Linda Beam's memo on facilitated mandated training for Board of Trustees. This is an important accreditation consideration.

A number of Trustees have requested information on our High School recruitment program. Please see Attachment L for Dr. Francisco Arce's correspondence on our current plans.

Recently the Accrediting Commission for Education in Nursing (ACEN) visited both El Camino and the El Camino College Compton Center. Their findings were not encouraging and around the March time frame may take negative action. Dr. Arce is examining our options and is in discussion with representatives from ACEN.

Ribbon cutting and groundbreakings are scheduled for the next three months. As the community representatives, we hope you are able to attend any or all these events. Please see Ms. Garten's communication on Attachment M.

SUBJECT: FIRST YEAR EXPERIENCE (FYE) PROGRAM

The First Year Experience (FYE) program is designed to prepare recent high school graduates for academic success and to help them select a career path. Sometimes getting started may seem overwhelming to students as they face decisions that will impact their futures. FYE provides the supportive environment that students need to adjust to college during that first critical year. FYE students receive priority registration, academic counseling, enroll in learning communities, and partake in educational fieldtrips.

Through FYE, students learn how to be a successful college student by becoming a part of a learning community. They study and learn in groups, have access to vital campus resources, develop important study skills, and learn how to access and manage electronic information such as e-mail, Internet, and library databases.

According to the Office of Institutional Research & Planning, students who participate in the First Year Experience program are more likely to successfully complete transfer-level English and mathematics courses and are more likely to persist into their second year of study at El Camino College when compared to non-participating first year students. They also reach the 30-unit threshold faster, are twice as likely to earn their associate degrees within a three-year time period, and are more likely to transfer to a four-year university.

SUBJECT: Board Review and Approval of Curricular Proposals: Compliance with New Regulation Requiring Board Approval of Non-substantial Curriculum Changes

This is to put in context some changes you will see in the Academic Affairs Curriculum Board of Trustees Consent Agenda effective January 2014. The most recent edition of the *Program and Course Approval Handbook* distributed by the California Community Colleges Chancellor's Office contains new language intended to ensure California Education Code and Title 5 compliance for review and approval of curriculum. This handbook, disseminated in late fall 2013, requires colleges to maintain evidence documenting district board approval for curricular actions submitted to the Chancellor's Office for review. These curricular actions include new courses and programs, substantial changes, non-substantial changes, and active/inactive status updates. Therein is the change. Effective in fall 2013 non-substantial changes require Board approval.

The Office of Academic Affairs will present full documentation to the Board for review and approval of all new courses, new programs, program changes, and substantive curricular changes. Substantial curricular changes include changes to degree credit status and credit units. Non-substantial curricular changes include changes to course numbers, course titles, and transfer status. In January 2014 it is recommended the Board accept changes in course numbering for many courses. The numbering change is the result of changes in course repetition policy. Where many courses could be repeated as many as three times, the new regulations limit course enrollment to one time. This necessitated changes the numbers for many courses that were once repeatable.

The District will be in compliance with the *Program and Course Approval Handbook*, 5<sup>th</sup> *edition* and validate that curricular actions submitted to the Chancellor's Office were approved by the Board of Trustees. Board of Trustees meeting minutes and College Curriculum Committee minutes retained at the college are sufficient documentation for audit purposes.

RE: Audit Report, Letter and Findings

The January Board packet materials include the audit report, letters and findings. The independent auditors' report letter provides a "clean opinion" of the financial statements.

Also included are the Federal management letter (which states we are in compliance with OMB 133) and the State management letter (which states there were no State findings).

We are pleased to report the auditors had only two findings (page 76):

Finding 1: Not all open (stale dated) items on the reconciliation report have been resolved between the District's and LA County's accounting systems. The Auditors are correct in that a few items still remain open. The District will continue to reduce the number of reconciling items, but is likely a few items will always remain.

Finding 2: Once again the auditors highlighted the continued and growing deficit of the Child Development Fund. This matter is resolved with the closing of the Child Development Center.

We are pleased that our findings have been reduced from four to two.

Subject: International Parking Design (IPD) Recommendation

The following rational was used in selecting IPD as the architect/designer for the Lot C parking structure. In 2004, five architect/design firms (International Parking Design, Watry Design, Inc., Walker Parking Consultants, Roesling Nakamura Architects, Carl Walker, Inc.) were selected to be interviewed.

The committee that selected IPD consisted of Rocky Bonura, Director of Business Services, Mike D' Amico, Chief of Police, Dave Shannon, Director of Athletics, Bob Gann, Director of Facilities, and David Miller, Assistant Director of Facilities.

As the projects on the north side of campus began to develop, discussions began regarding the value in replicating the design for the parking structure. Since IPD had designed the parking structure located at the south end of campus (Lot H), IPD believed they could demonstrate a cost savings and submitted a proposal based on price negotiations with the College.

The Board of Trustees approved design fees of \$610,000 for Parking Lot H with a projected budget of \$8,750,000.

In comparison, the Parking Lot C Project proposed design fee of \$1,200,000 is reasonable in comparison to the \$26,000,000 projected project costs.

These fees are in alignment with the Architectural Fee Schedule and account for less than 5% of the construction costs.

The State of California is re-examining how it offers adult education. The current budget provides funding for non-competitive planning grants for consortia of K-12 and community college districts. The regional consortia will develop plans for expanding and improving adult education services by creating linkage between the two educational systems.

El Camino College through Community Advancement is forming a consortium with the adult education programs in the South Bay. It is important that Compton Community College District also works with its feeder districts to form a consortium to serve the Compton district. As the linkage between the adult education and community college programs will serve as the cornerstone of any plan, it is vital that El Camino College Compton Center, which offers the instructional program for Compton, serve as a member of the Southwest Los Angeles Adult Education Consortium. #### The governing board shall conduct its meetings as follows:

(1) A notice identifying the location, date, and time of the meeting shall be posted in each community college maintained by the district at least 10 days prior to the meeting and shall remain so posted to and including the time of the meeting.

(2) The governing board shall conduct its meetings within the boundaries of the community college district, except as provided in subparagraphs (A) and (B).

(A) The governing board may meet outside of its district boundaries for the limited purpose of meeting with another local agency so long as the meeting meets both of the following criteria:

(i) The meeting occurs within the boundaries of one of the participating local agencies.

(ii) The meeting is open and accessible to the public, including the residents of the district whose board is meeting outside the boundaries of the district.

(B) The governing board may meet outside of its district boundaries if the board finds it necessary to meet in closed session with its attorney to discuss pending litigation and if the attorney's office is located outside of the boundaries of the district.

There are two exceptions as noted on the attached; neither of these exceptions permits the El Camino Board to hold a regular meeting of their own outside the district boundaries.

El Camino College Foundation Cabrillo LLC International Student Housing Project Micro Studio Complex

The El Camino College Foundation has entered into a project to provide a housing option for international students. We have signed a master lease agreement with West Cabrillo Fund (WCF) LLC for a property located at 1646 Cabrillo Avenue, Torrance, CA The property is the former Torrance Hotel which was purchased and renovated by WCF. The upper floor consists of 40 units which will be rented to students, primarily ECC international students. The maximum capacity is approximately 60 - 65 students as some units can house multiple students. In addition to the living units there is a large retail space downstairs that is being converted to a community space for the students. The community room will include lounge furniture, ping pong, tables and chairs, wireless internet access and vending machines. This area will be available to students only and will provide a central meeting point for the students.

The purpose and benefits of the project is threefold.

- 1. Having a dormitory style housing option will make El Camino College more competitive in the recruitment of international students.
- 2. This project will generate unrestricted funds for the Foundation which is critical to the continued growth of the organization.
- 3. This venture provides a low-risk, minimal investment opportunity to determine whether student housing is a profitable business enterprise for the Foundation and/or the College.

This opportunity was first brought to the Foundation through WCF in June 2013. The Foundation board of directors established a Real Estate Project Committee to review and consider the project. The committee, which included two board members with extensive real estate experience, spent seven months reviewing all aspects of the project, consulted with legal counsel, city officials and El Camino College senior administration. Representatives from the committee met numerous time with Mr. Lee Johnson, primary member of WCF to discuss contractual obligations, costs, responsibilities, legal and liability concerns. After extensive discussion and consideration the committee's recommendation to the board was to approve moving forward with the project.

On October 24, 2013 Foundation President Mo Hakimi called a special meeting of the full board of directors

The Foundation has established a limited liability corporation 1646 Cabrillo LLC for the purposes of managing this project. The LLC is a single member company thus the tax exempt status of the Foundation passes to the LLC making the LLC exempt from earned income taxation. Initially, there was a concern about possible liability for the College and the Foundation. We have taken the following steps to minimize liability concerns:

- 1. Establish a separate LLC.
- 2. Hired legal counsel to review documents and provide advice and counsel.
- 3. Established separate Directors and Officers insurance for the members of the LLC.
- 4. Obtained liability insurance (in addition to what is currently held by WCF) for the LLC.
- 5. Entered into an agreement with Global Student Services (GSS), a home-stay company for placing international students. GSS will be the primary point of contact for students including referral, contracts, placement, extension and all other issues related to international student housing needs.

- Term of the lease: 36 months
- Start: January 1, 2014 End: December 31, 2017
- 40 Units at \$400 each per mo. (first year, 3% increases each year thereafter)
- Community room (1800 sq. ft.) \$700 per mo. (first year, increases to \$1500 year 2)
- Three year lease with option for three year renewal

This letter is to express interest on behalf of the Los Angeles County Office of Education (LACOE) and Pacific Asian Consortium in Employment (PACE) to lease the child care facility on the El Camino campus. LACOE plans to use the space to provide Head Start and State Preschool services for children ages three to five years old, by July 1, 2014. We would like to arrange a meeting as soon as possible to discuss this request.

Our programs offer children early learning experiences that help them grow up with the knowledge, skills, and attributes to flourish in school. Since 1979, LACOE's early education services have expanded to influence the lives of thousands of children and families through Head Start, Early Head Start, and State Preschool across Los Angeles County. We contract with school districts and private non-profit agencies for direct services to children and families with the greatest need.

LACOE works with 15 delegate agencies to offer the highest quality early childhood education programs to more than 12,000 children from birth to five years old. Our programs work closely with parents to educate them on their roles as their children's primary educators.

The Torrance area is assigned to LACOE's delegate agency PACE, which would provide direct services to children at the El Camino facility. PACE's comprehensive preschool program serves more than 1,800 children and families, including those in the Central Los Angeles and South Bay areas. Through Head Start and Early Head Start, and State Preschool, children receive education, nutrition, health, social services, mental health, and disabilities services.

We propose to serve 60 - 120 families based on the model offered. Our goal is to make half-day and full-day services available for families enrolled on campus. Please understand that federal and state funds support our programs and LACOE is obligated to generate non-federal share. must generate \$25.00 in non-federal dollars. Our collaboration with El Camino College would be of immeasurable benefit to the families and children surrounding the campus.

# El Camino College

2013-2014 Academic Year Outreach Plan

The El Camino College Office of Outreach & School Relations working in coordination with various on-campus student support programs provides outreach services to all in-district high schools. During the 2013-2014 Academic Year, El Camino College will aggressively outreach to prospective high school students to help meet college enrollment goals and meet new state mandates as outlined in the Student Success Act of 2012 also known as California Senate Bill 1456. All new in-district high school students that complete orientation, take the assessment tests, and have an education plan developed by Monday, March 31, 2013, will be eligible for priority registration for the Summer/Fall 2014.

#### **Information Session**

Information Sessions are presentations made at high school campuses early during the fall semester to educate prospective students of the academic offerings, athletic opportunities, financial aid including scholarships, and other student support services provided by El Camino College. Information Sessions may be provided via informational tables, classroom presentations, and college nights.

#### **Application Workshop**

Application Workshops generally take place throughout the fall semester at high school campuses to help prospective students learn of how to apply online for admission to El Camino College. All students must complete an online admission application before being able to continue with the rest of the matriculation steps. An El Camino College student identification number and El Camino College student e-mail account are issued upon submission of the online admission application.

#### **Orientation**

Orientations are provided in a variety of forums to help meet the needs of prospective high school students. The orientation is offered online and in-person orientations are provided at high school campuses and at El Camino College throughout the academic year.

#### **Assessment Testing**

Assessment Testing generally takes place during the late fall semester and throughout the spring semester to help appropriately place students within the college's English and mathematics curriculum. Assessment Testing is a requirement prior to students being able to meet with an academic counselor to develop an education plan. Assessment Testing may take place at high school campuses or at El Camino College. Free bussing is being provided to all in-district high schools.

#### **Education Plan**

Education Plans are created for new students by college academic counselors either at high school campuses or at El Camino College throughout the spring semester. Abbreviated Education Plans are

one or two semesters in length. Comprehensive Education Plans are two or more semesters in length. Education Plans outline course sequence by semester/term and help students meet their educational goal(s) of completing a vocational certificate, associate degree, and/or transfer to a four-year university.

SUBJECT: December IT issues

- 1. <u>College applicant follow-up emails</u>: When an application is received, normally two follow up emails are sent to each applicant. In mid-October, a new version of email was installed. This new version did not provide the former connectivity to the application process. This element has now been corrected and emails are now being received by applicants.
- 2. Drop for non-payment deadline delayed: Colleague (our student information system) experienced a file corruption at 10:23 p.m. on 12/09/2013 that prevented students from paying fees. The fee payment deadline was originally midnight on 12/09/2013. This problem was identified around 2 a.m. on 12/10/2013 during our automated nightly backup. Apparently there was so much activity on 12/09 (over \$2Mil in collections 12/9-12/11) that the transactions log over flowed and corrupted the files. ITS staff began correcting the problem at 5 a.m. This time gap is due to the fact that the backup needed to be completed prior to taking corrective actions. The system was confirmed back online at 7:30 a.m. Due to this problem, the payment deadline was extended for one day. ITS posted the extension on the portal and the cashiers were also advised. We are working with Ellucian to expand our integrity checks which would allow an earlier detection and correction of these types of issues. We may also change payment due times and other critical deadlines to correspond with regular business hours.
- 3. <u>Team Sites unavailable:</u> ITS responded to a complaint by users that Team Sites were unavailable on 12/11. Team sites are hosted on the portal which is Microsoft SharePoint product. The Microsoft SharePoint Index server search engine is required to locate and access a Team Site by a user, and that search engine halted for unknown reasons. When this occurs, the search engine itself must be restarted. Normally, the search engine requires two to four hours to complete this process before all Team Sites are accessible. The search engine did not restart properly as expected. Thus, a call was placed to Microsoft support to get assistance with the issue. Microsoft was able to resolve the issue within two hours and then staff was able to once again begin the search engine start up process. The Team Sites hosted on this portal were down for portions of three days. Team Sites hosted by Etudes were not affected.

4. <u>Constituency Error message received by new students:</u> At times, the number of active accounts exceeds the ability of the automated system to process. We are currently changing our process to more frequently deactivate inactive accounts.

Vavrinek, Trine, Day and Company LLP, an independent external auditing firm, recently completed our 2012-2013 Compton Community College District (CCCD) Financial Audit Report. The 2012-2013 CCCD Financial Audit Report can be found online at: <u>http://www.district.compton.edu/administration/businessadmin/financia</u> <u>ldocs.asp</u>. The CCCD Annual Financial Audit was completed on time and submitted to the California Community College Chancellor's Office prior to the December 31, 2013 deadline with an unmodified opinion of the financial statements.

Below is a summary of results regarding the 2012-2013 Annual Financial Audit Report:

- 1. CCCD general fund ending balance was \$7.1 million, which is above the 5% minimum reserve requirement recommended by the California Community College Chancellor's Office.
- CCCD only had six audit findings, which is a significant reduction compared to the 2011-2012 (thirteen auditing findings) and 2010-2011 audits (twenty-six auditing findings).
- 3. Of the thirteen 2011-2012 audit findings, eight were noted as fully implemented and five were noted as in process and are currently being addressed.
- 4. The 2012-2013 CCCD Annual Financial Audit reports did not include audit adjustments, nor did it include material weaknesses in our internal controls.
- 5. The 2012-2013 CCCD Annual Financial Audit Report also reported on the Federal Awards an unmodified opinion. No audit findings were noted in the Federal Awards.

#### **Re: Facilities Projects Update**

Dear President Fallo:

Currently, we have five facilities projects in various phases of construction at the Compton Center. The five projects include the Learning Resource Center (LRC), Music Building Renovation, Utility Infrastructure Phase 1 and 2, and the Allied Health Building. Below is a brief update on each of these projects.

LRC Project is approximately 75% complete and will be completed by March 31, 2014. The general contractor is finishing the mechanical, electrical and technology work in the facility. The grand opening for the LRC is scheduled for April 15, 2014 at 2:00 p.m. The total cost for this project is \$25 million.

**Music Building Renovation Project** was submitted by the Architect (WLC Architects) to the Division of the State Architect (DSA) in December 2013 and we anticipate construction for this project being completed by the fall of 2015. Total cost for this project is \$1 million.

Utility Infrastructure Phase 1 Project (with Central Plant and Stadium Lighting) and Utility Infrastructure Phase 2 Project are approximately 95 % and 98% completed. We anticipate both of these projects being completed by March 2014. The Utility Infrastructure Phase 1 and 2 Projects include roadway improvements, new central plant, parking lot improvements, and a new campus-wide lighting project. Total cost for these two projects is \$46.5 million.

Allied Health Building Project is scheduled to begin construction in February/March 2014, subject to the approval of the El Camino CCD Board of Trustees and the State of California Department of Finance awarding the contract to AMG & Associates, Inc. AMG & Associates, Inc, was the lowest responsive and responsible bidder for this project. Previously, AMG & Associates, Inc has worked on the construction of numerous fire stations and is currently working on the construction of a \$17 million elementary school in Santa Maria, CA. Total cost for the Allied Health Building project is \$12 million.

Governor Brown has presented an overview of his budget proposal for the fiscal year 2014-15. For California Community Colleges, the items of interest include:

- 1. A COLA of 0.86%. While we are thankful for a COLA, most had projected a COLA of double that amount.
- 2. Restoration of access by 3%. Even with this opportunity to restore (or grow), our funding would still fall below the 2008 level.
- 3. New funding for student success programs and developing state-wide success projects.
- 4. New funding (one-time) for instructional equipment and deferred maintenance.
- 5. Elimination of inter-year deferred payments from the State. This will significantly reduce the amount needing to be borrowed using TRANs.
- 6. Funding of energy efficiency projects (Prop 39).
- 7. Providing funding for back fills needed due to apportionment shortages resulting from RDA shortages, property tax shortages and recurring structural deficits.
- 8. Providing funding for regional adult education consortia.
- 9. No increases in State tuition.

The Governor made it very clear in his budget message that he intends to use one-time funds for the pay down of debt obligations. Thus, his focus is on the deferred payments and the state's pension obligations.

The California Community College Trustees (CCCT) board serves a major role within the Community College League of California. Meeting five times a year, the twenty-one member board provides leadership and direction to ensure a strong voice for locally elected governing board members.

From January 1 through February 15, nominations for membership on the CCCT board will be accepted in the League office. Nominations are to be made by member district board of trustees; and each district may nominate only members of its board.

Each nominee must be a local community college district trustee, other than the student trustee, and must have consented to be nominated. Only one trustee per district may serve on the board.

An official Biographical Sketch Form and Statement of Candidacy **must** accompany the Nomination Form mailed to the League office, and <u>please use only these forms</u>. Although not required, it is recommended that nomination materials be sent via certified mail, return receipt requested. Faxed materials will **not** be accepted due to the quality of transmission.

The election of members of the CCCT board will take place between March 10 and April 25. Each member district board of trustees will have one vote for each vacancy on the CCCT board. CCCT board members are elected by the institutional member governing boards for three-year terms. No CCCT board member shall serve more than three (3) terms consecutively. This year eight persons will be elected to the board. Of those eight seats there are six incumbents eligible to run for re-election, one board member has termed out, and one seat was vacated by a trustee that did not run for re-election at the district level. This vacated seat will be filled by the trustee that receives the least number of votes among the top eight vote getters. Pursuant to the CCCT Governing Policies, that person will complete the term of the vacated seat, which expires in 2015.

Election results will be announced at the CCCT annual conference. The newly elected members of the board will assume their responsibilities at the conclusion of the annual conference, May 4, 2014.



Dear Dr. Fallo,

My name is Carolina Gonzalez a current student at El Camino College. With the support of El Camino's Child Development department, I have recently declared my major to Child Development. I am currently working with Reading Partners and became profoundly interested in teaching young children. This letter is to express my concerns on the decision made to close down the Child Development Center that will become effective by June 30, 2014.

My understanding in the decision to close down the CDC is because of the unexpected failure in different areas of the department. Throughout the past years since 2008/09, there has been a decline in the number of children enrolled. Therefore, El Camino has been paying more money to keep the CDC open. The former director of the center Sandy Parvis was not able to keep up a good quality program. The center was then seen as a negative environment for the children. These issues not only caused negative feedback, but also no revenue was seen neither positive result. There is no doubt that a change had to happen, the center could not continue losing money, or be viewed as a negative environment. Bringing in Jennifer Montgomery as the new director as of July of 2014 was a start.

After the board had made its decision to give the center a year to see progress, a second vote was taken and to confirm the closure. It has become hard and stressful for the Child development department to reconstruct the whole center. My concerns are that there was not enough time given in order to see any progress. Professor Michelle Moen shares her feelings about the center closing and says "We were promised a year to see the increase of finances and the quality of the

center, and we were actually given three months, we did improve the quality but not finances". Jennifer Montgomery who has accepted to change and improve our center has made many outstanding changes. To begin she is now implementing what is being taught in our classrooms. There has been an increase in the children enrolled from under twenty children to over fifty children. Ms. Montgomery has worked very hard in making the center what I call a model. She has also gathered grants to help tuition, and gathered connections with agencies for help financially. This dramatic change has been made in only three months that is to say with more time our center will become successful.

Our center is helping students, parents and our communities become united as one through our CDC. Students use the CDC as an educational opportunity to observe and learn, also used as a practicum for AS in Child Development. Berenice Leon a student at El Camino says "I think it was an opportunity for us to see what we were being taught in class implemented in action". As future educators we use our observations in the center to fully experience to work with children. I was fortunate to make my observation this semester in the center, and I simply enjoyed watching the connections the teachers had with the children. The children knew their transitions and there was a positive environment. I personally enjoyed watching the three year olds play dramatic play. I had the privilege to see what I had studied and learned in class become alive in action. I worry that future students pursuing the educational field would not get to experience what we are being taught. Our students need a quality lab to learn and grow from. Furthermore, student parents and staff find it convenient to have their children in the center. Not only is it free for students but it benefited people who had a low income. Also taking consideration of our children who have become accustomed of the environment and staff, what would occur to these children? Shouldn't they have a voice in this?

Overall I understand the circumstances in which our financial needs have become deprived because of increasing budget deficit. But I am not alone in this fight there have been petitions, parent speakers and written letters like mine to keep our Child Development center open. I suggest giving a second vote to actually see improvement in our center, a year was promised but in only three months the decision had been made for closure. With our new director, increased enrollment I have no doubt that in a near future we will see finances increase.

I can be contacted at any time through my email stated above. I look forward to hearing from you. Thank you for your attention to this matter.

The following summarizes the emergency incident and responses by various agencies on Wednesday, January 8, 2014. The information in the summary was provided by Chief Trevis.

At about 2:30 p.m., the afternoon mail was delivered to the El Camino College switchboard area in the Administration Building. A college employee opens an envelope and powder falls out. Upon finding a note claiming the powder is anthrax, the employee calls El Camino College Police.

ECC Police immediately seal off the Administration Building lobby and call the Los Angeles County Fire Department. Upon arrival, the LA Fire Department makes the call to evacuate all employees in the Administration Building. The Fire Department contacts the Sheriffs Hazardous-Materials (Haz-Mat) Department. Per federal protocol, the LA Fire Department also contacts the FBI. In the meantime five employees are sent to the hospital for procedures for possible contamination.

At 3:30 p.m. Haz-Mat, via their mobile lab, determines the powder is not anything dangerous. At 5:30 p.m., the building is given the all clear and all agencies leave ECC.

The FBI is handling the incident as a federal criminal investigation because the letter was sent via U.S. mail. The FBI provided direction for any media calls to be referred to their local PIO Office.



## BRIEFING December | 2013

## SB 751 – Amendment to the Brown Act Promoting Greater Transparency in Public Agencies

On January 1, 2014, SB 751 will go into effect, requiring the legislative body of every California local agency to publicly report any action taken and the vote or abstention on that action of each Board member present for the action. The purpose of the legislation is to promote greater transparency and improve public accountability.

Signed into law by Governor Jerry Brown on September 6, 2013, SB 751 amends the Brown Act (Government Code 54953) to require, essentially, a recordation of a roll call vote for each action taken at public meetings. Under current law, the votes of individual board members are reported for closed meetings and meetings conducted by teleconference. SB 751 will apply the same requirement to open meetings. This means that the current practice, by some agencies, of merely recording the number of "ayes" or "nays" for an action will no longer be sufficient.

This new law applies to the legislative bodies of local public agencies, including the boards of K-12 schools, community colleges, municipalities, special districts and Joint Powers Authorities (JPAs). Those agencies will have to implement procedures by January 1, 2014 to ensure that a roll call vote is taken and individual Board member votes or abstentions are recorded in the minutes for every action taken at a meeting.

For meetings in which Keenan assists an agency in scheduling the meeting and recording the minutes, Keenan staff is ready to assist the agency to ensure compliance with SB 751 as of January 1, 2014.

## **One Full Year Sabbatical**

Kathy Morgan – Nursing (Fall/Spring 2014-15)

<u>Type of Sabbatical</u>: Professor Morgan will enroll in formal classwork in pursuance of an advanced degree or to increase the applicant's teaching field.

<u>Project</u>: A doctoral degree will enhance Professor Morgan's knowledge and confidence in her leadership roles as lead instructor, assistant director, and chair of the curriculum committee. A doctoral degree will also help her stay at the forefront of the changes in healthcare in America. She will be attending University of San Diego as a full-time student.

## One Semester Sabbatical (one semester at full pay)

## Ellen Antoine – Political Science (Fall 2014)

<u>Type of Sabbatical</u>: Dr. Antoine will focus on a program of independent study in the applicant's teaching field other than formal class work.

<u>Project</u>: Dr. Antoine plans to do research and reading to expand her knowledge of political, social and economic changes in Europe, with particular attention to the European Union since the collapse of the Soviet Union. She also plans to put together a booklet of the various European organization, the different institutional structure, and how different organizations overlap in their current membership. This work would be available to her students and students of any interested colleagues in history as well as political sciences.

## Mark Crossman - Communication Skills (Fall 2014)

<u>Type of Sabbatical</u>: Dr. Crossman will write a textbook for which there is a commitment to publish extended by a recognized publisher.

<u>Project</u>: Dr. Crossman will release the 4<sup>th</sup> edition of <u>Burden of Proof</u>: <u>An Introduction to</u> <u>Argumentation and Guide to Parliamentary Debate</u>. His work will include updating the core material in political material, competitive collegiate parliamentary debate, and adding high school forensics material to the textbook.

## Chris Gold – History (Fall 2014)

<u>Type of Sabbatical</u>: Dr. Gold will focus on formal class work in pursuance of an advance degree or to increase the applicant's proficiency in the applicant's teaching field. <u>Project</u>: Professor Gold plans to enroll in two courses to redevelop her online courses in History 101 and 102. The courses will provide in-depth instruction in the pedagogy and technology of teaching online.

## Lars Kjeseth – Math (Fall 2014)

<u>Type of Sabbatical</u>: Dr. Kjeseth will focus on a program of independent study in the applicant's teaching field other than formal class work.

<u>Project</u>: Dr. Kjeseth will begin with two parallel undertakings: (1) an investigation of the cutting edge of online problem-based and conceptual activities and assessments and (2) training with specialists from Pearson to learn how to build customized online investigations. Following the initial work, he plans to develop four model activities and associated assessments which will be tested in Math 37 and 67. This project will help create online problem-based and conceptual activities and assessments so he can train and guide his colleagues in producing high quality activities and assessments of their own.

## Jenny Simon – English as a Second Language (Fall 2014)

<u>Type of Sabbatical</u>: Dr. Simon will focus on a program of independent study in the applicant's teaching field other than formal class work.

<u>Project</u>: Dr. Simon plans to compile a test bank for ESL 52A and 52B that instructors can use to build their test. The purpose is to strengthen the reading/vocabulary building series of courses in the ESL program by ensuring consistency in the way students are assessed. The outcome of the project will be a test bank from comprehension questions about level-appropriate readings, fill-in vocabulary items, and parts of speech.

## Matthew Ebiner – Geography (Fall 2014)

<u>Type of Sabbatical</u>: Professor Ebiner will focus on a program of independent study in the applicant's field teaching field other than formal class work.

He will travel to areas in the western USA to learn more about the environments and landforms there. Dear Friends,

We recently launched a new series of reports on the *State of Higher Education in California* to bring attention to the critical challenges facing higher education in our state and the opportunities for solving them.

*The State of Latinos in Higher Education in California* was the first report in this series. *The State of Blacks in Higher Education in California* was the second. I have attached the infographics highlighting some of the key findings with this letter. You can find the full reports, webinar, and extensive media coverage on our website at <u>www.collegecampaign.org.</u> As we enter 2014, we are hopeful that all of us can work towards achieving equity in student outcomes--across racial, ethnic, and income groups.

As you know, California's diversity is growing as is the demand for educated workers by employers. Business leaders and civil rights activists agree that our economic future will depend on our ability to better prepare and educate our populace. The low educational attainment rates of California's Latinos coupled with little or no improvement in some trends over time for Blacks is both startling and unacceptable. We believe that more Californians deserve the opportunity to go to college and graduate, and that gaps in educational success must be closed.

Thanks to the leadership at the Board of Governors and the California Community College Chancellor's Office you now have a new tool to help you address this: The Student Success Scorecard which tracks how well colleges are doing in remedial, job training, graduation and completion rates disaggregated by race and gender. Of course, data is important, but not as much as acting upon it. Enclosed is a brief postcard on some of the key student success efforts under way and questions that can give you a clear picture as to opportunities at your community college.

I have also enclosed the latest update on implementation of Associate Degrees for Transfer across the state at each community college and California State University. As you know, this year the legislature and Governor Brown signed additional legislation to strengthen the Student Transfer Achievement Reform Act (SB 440 by Senator Alex Padilla) that articulates clear benchmarks for offering Associate Degrees for Transfer at

each community college and for accepting Associate Degrees for Transfer at each CSU campus; Requires the CSU to develop an admissions redirection process for students; requires the development of at least two Associate Degrees for Transfer in areas of emphasis by Fall 2015 and for the CSU to accept these degrees; and requires community colleges and the CSU to communicate this transfer option to students. I hope you will aggressively pursue strengthening transfer at your campus.

These reports and the scorecard shine a light on some of the critical challenges facing higher education in California, but most importantly we are interested in working with you in pressing for change and solutions that will turn these statistics around. This includes urging the Governor, state policymakers, and higher education leaders to make college going, success, and equity a top priority. This can only happen if we demand something different than what we are currently doing. More funding, more accountability, and a clear public agenda with intentional goals to increase college going and success are critical pieces of the puzzle.

My hope is that we all become more comfortable about demanding good data and talking about race as an opportunity to design solutions for closing gaps and reversing negative trends - instead of assigning blame. The recommendations will be part of our focus in 2014.

I hope you find these reports valuable, that you use the scorecard and progress on implementation of the Associate Degrees for transfer and an opportunity to strengthen the work at your campus. If you have any questions or wish to discuss the findings and the recommendations any further, do not hesitate to reach out.






California is home to more than 14.5 million Latinos




Latinos lag in college completion; only 11% of Latinos have a B.A.




## In 2012, most Latinos enrolled at a California Community College





## The persistent opportunity gap



Blacks are slightly overrepresented at California's Community Colleges and enroll in for-profit colleges at a rate greater than CSU and UC combined




In the past decade, the enrollment rates of Black high school students to the CSU and UC have remained virtually unchanged, despite a growth in the Black population

SB 440 – Senator Alex Padilla Clean-Up Legislation for SB 1440, the Student Transfer Achievement Reform Act Signed into law on October 10th, 2013

#### BACKGROUND

In 2010, The Campaign for College Opportunity, along with the California Community College's Chancellor's Office, the California State University, the Student Senate for California Community Colleges, and the California State Student Association, established a remedy for the troubled transfer function: Senate Bill 1440 (Chapter 428, Statutes of 2010), the Student Transfer Achievement Reform (STAR) Act.

Nearly three years later, despite considerable progress at the community colleges and the California State University in carrying out the SB 1440 transfer reform, there remained foundational elements that lacked in the access, flexibility, and communication of this new degree and transfer pathway. The follow-up legislation, SB 440 recognizes that without robust implementation of SB 1440 and a recommitment to the state's transfer mission, students, and ultimately the State of California, will suffer.

The recently passed SB 440 law addresses three main themes of SB 1440 implementation to improve the existing Associate Degree for Transfer pathway for students:

#### Greater Access

- Articulates clear benchmarks for offering Associate Degrees for Transfer at each community college and for accepting Associate Degrees for Transfer at each California State University campus.
- Requires the California State University to develop an admissions redirection process for Associate Degree for Transfer students.

#### Improved Flexibility and Response to Students' Needs

• Require community colleges to develop at least two Associate Degrees for Transfer patterns in areas of emphasis by fall 2015 and require California State University campuses to accept these degrees for transfer.

#### Commitment to Outreach and Marketing

 Require the community colleges and the CSU, in consultation with key stakeholders including students, to develop a student-centered communication and marketing strategy for the transfer degree pathway.

Dear Superintendent Fallo:

On October 17, 2013, the U.S. Department of Education, Office for Civil Rights (OCR), received a complaint against El Camino College (College) and, in a letter dated November 19, 2013, informed you that the complaint was accepted for investigation and resolution. The complainant<sup>1</sup> alleged that in retaliation for her prior advocacy, the College denied her academic adjustments (such as extra time on tests) necessary to ensure that she could participate in the education program in a nondiscriminatory manner.

Since then, OCR obtained additional information about the complaint. OCR has determined that it is appropriate to administratively close this complaint and will take no further action on it.

OCR routinely advises recipients of Federal funds and public education entities that Federal regulations prohibit intimidation, harassment or retaliation against those filing complaints with OCR and those participating in the complaint resolution process. Complainants and participants who feel that such actions have occurred may file a separate complaint with OCR.

Under the Freedom of Information Act, it may be necessary to release this document and related records upon request. In the event that OCR receives such a request, it will seek to protect, to the extent provided by law, personal information that, if released, could reasonably be expected to constitute an unwarranted invasion of personal privacy.

Whereas, The U.S. system of regional accreditation has been well-established and provided essential guarantees of quality in America's post-secondary institutions since the 1950's; and

Whereas, Keys to the overall success of this unique system are a spirit of collaboration and mutual respect between the regional commissions and their member institutions and a shared focus on the needs and interests of the student who attend these institutions; and

Whereas, For the last decade, the relationship in the Western region between the Accrediting Commission for Community and Junior Colleges (ACCJC) and many of California's 112 public community colleges (which collectively constitute 84% of the institutional membership of ACCJC and serve over 95% of the student enrollments at ACCJC member institutions) has been contentious and, in many instances antagonistic; and

Whereas, The Western region is the only one of the six accrediting regions of the U.S. where a separate commission exists for the purpose of accrediting two-year institutions rather than having a single commission accredit both two-year and four-year institutions; and

Whereas, The troubled nature of the relationship between ACCJC and many of its member institutions is manifested in multiple ways, including the following:

- The extraordinary frequency and severity of sanctions levied by ACCJC against California community colleges compared to 0 sanction levels and types seen in other regions and in four-year institutions accredited by WASC-Senior
- Widespread distrust of ACCJC by faculty statewide as reflected in numerous resolutions, articles and complaints prepared and approved by organizations such as the Community College Council of the California Federation of Teachers, the Community College Association of the California Teachers Association, the California Community College Independents, and the Faculty Association of the California Community Colleges
- The creation of two separate Task Forces by two different State Chancellors in order to grapple with the issues surrounding the accreditation of the system's colleges
- ACCJC's announcements in July 2012 and July 2013, of its action first to place CCSF on "Show Cause" and then to deny ac-0 creditation to CCSF, effective July 2014, actions which have created an unprecedented public relations, enrollment and financial crisis for that institution, threatening its very existence as the only public community college in the City and County of San Francisco, despite widespread support for the college from the people of San Francisco

Therefore, Be It Resolved, That the Academic Senate of San Jose City College hereby expresses its deep concern over the adversarial nature of the relationships between ACCJC and many of California's community colleges; and be it

Further Resolved, That this Academic Senate urges careful scrutiny of ACCJC's work as a regional accreditor during the upcoming review of ACCJC for federal recognition by the U.S. Dept. of Education (USDOE); and be it

Further Resolved, That this Academic Senate recommends that the USDOE include in its review of ACCJC consideration of merging ACCJC and WASC Senior into a single higher education accrediting commission for the Western region in order to bring the structure of this region's commission in line with the structure of the other five regions; and be it

Finally Resolved, That this Academic Senate urges ACCJC itself to consider, in its own self-evaluation, how ineffective the Commission has been in fostering a spirit of collaboration and mutual respect between itself and its member institutions and that the Commission take meaningful steps to begin developing a more collaborative spirit in its work with the California community colleges.
