Bylaws

Nothing has changed in the by-laws, just wanted to go over the information for new members. Section 1. Committee Established.

The committee was established with the passing Measure E bond in 2002 under Prop 39. In 2012, another bond Measure E was passed and this committee took on the duties and rights set forth in the Bylaws with oversight responsibility over both 2002 Measure E and 2012 Measure E.

Section 2. Purposes.

The purposes of the Committee are set forth in Prop 39, and the Bylaws are specifically made subject to the applicable provisions of Prop 39 as to the duties and rights of the Committee. The Committee shall be deemed to be subject to the *Ralph M. Brown Public Meetings Act* of the State of California.

Section 3. Duties.

The Committee shall perform the duties set forth in Section 3.1, 3.2 and 3.3 and shall refrain from those activities set forth in Sections 3.4 and 3.5.

- 3.1 <u>Inform the Public</u>. The Committee shall inform the public concerning the District's expenditure of bond proceeds.
- 3.2 <u>Review Expenditures</u>. The Committee shall review expenditure reports produced by the District to ensure that:
 - (a) Bond proceeds were expended only for the purposes set forth in the Measures; and
 - (b) No bond proceeds were used for any inappropriate teacher or administrative salaries or other operating expenses.
- 3.3 <u>Annual Report</u>. The Committee shall present to the Board, in public session, an annual written report which shall include the following:

- (a) A statement indicating whether the District is in compliance with the requirements of Article XIIIA, Section 1(b)(3) of the California Constitution; and
- (b) A summary of the Committee's proceedings and activities for the preceding year.

Section 5. Membership

5.1 Number.

The Committee shall consist of a minimum of seven (7) members appointed by the Board of Trustees from a list of candidates submitting written applications, and based on criteria established by Prop 39, to wit:

- One (1) student enrolled and active in a community college support group, such as student government.
- One (1) member active in a business organization representing the business community located in the District.
- One (1) member active in a senior citizens' organization.
- One (1) member active in a bona-fide taxpayers association.
- One (1) member active in a support organization for the college, such as a foundation.
- Two (2) members of the community at-large.
