El Camino College-Compton Center *Customized* IPEDS Data Feedback Report 2015 Summary of Findings

The National Center for Education Statistics (NCES) distributes a standard report to college and university leaders each year entitled *IPEDS Data Feedback Report*. The report summarizes demographic, enrollment and achievement data from the previous year (in this report, data through 2013-14 academic year and Fall 2014). *Median* results from a comparison group developed by each institution are displayed next to institutional results. The darker bars on all charts represent El Camino College Compton Center (Compton) while the lighter bars represent the comparison group median. Methodological notes are on pages 7 and 8 of the report.

Comparison groups are auto-selected by IPEDS based on institutional size, location and type (e.g., public, 2-year). Given Compton Center's distinct student body and unique history, the automated group does not serve as a meaningful yardstick for comparison. In its place, a *customized* comparison group was used which includes:

- Baltimore City College (MD)
- Cerritos College
- LA Southwest College
- LA Trade Tech
- Merritt College
- West LA College

These colleges were selected because they are minority serving, of comparable size, and in urban/suburban locations.

Figure 1. Race/Ethnicity & Gender

The racial/ethnic and gender distributions at Compton Center are fairly similar to comparison colleges, with the Center having a larger percentage of Hispanic/Latino students and slightly larger percentage of African-American students. The percentage of women at the Center is very similar to the peer group median².

Figure 2. Headcount

Compton Center's institutional size is slightly smaller by headcount and in Total FTE³ enrollment compared to the median. Full-time enrollments are similar to the comparison colleges while part-time enrollments are much lower than the median, suggesting that unique (student) enrollments in winter and summer contribute to Compton's lower annual enrollment totals.

Figure 3. Number of Degrees and Certificates

Compton Center awarded fewer Associate degrees than the peer median in 2013-14 (262 vs. 435). Compton Center also awarded fewer mid-term certificates (15 vs.143) and short-term certificates (81 vs. 209). These discrepancies may reflect the relative prevalence of part-time students, who would take longer to achieve awards, and to the enrollment recovery experienced during this period following Compton College's accreditation revocation. Local figures show that the number of degrees and certificates has consistently increased during all years of the ECC partnership and dramatically increased in 2011-12, potentially narrowing the student achievement gap to some extent in future reports.

Figure 4-5. Academic Year Tuition and Fees

These figures show 3- or 4-year trends of college costs. Figure 3 shows that in 2014-15 tuition and fees for Compton Center were lower (\$1,142) than for the peer groups (\$1,220). The average net price of attendance in 2013-2014 was similar for Compton Center and its peer groups (Figure 5).

Figures 6-9. Grant/Scholarship Recipients

The percentage of *all students* receiving some form of reported financial aid was 48% in 2013-14, much lower than the peer group median of 68% (Figure 8). Compton Center students also received fewer Pell grants at 27%, compared to 38% for the comparison median. Average Pell award amounts (in dollars) were slightly lower than the median but average amount of any financial aid was higher than the median (Figure 9). Compton Center students did not receive federal loans.

The percentage of full-time, first-time degree/certificate-seeking (FTF) students who received financial aid was somewhat lower at 74% compared to the median rate of 81% (Figure 6). The rate was also lower for state/local grants. However, rates were slightly higher for FTF students who received federal grants and Pell grants compared to the median rates.

Figures 10-12. Graduation & Transfer-out Rates

These figures reflect a variety of graduation and transfer rates along with fall to fall persistence (IPEDS refers to this rate as *Retention*).

Graduation rates remain low at Compton Center, with 11% overall and 11% for the Fall 2011 FTF cohort. The overall graduation rate and the Fall 2011 FTF cohort graduation rate is slightly lower than the peer institution median of 15%. Although the *transfer-out* rate is also low, this rate measures all college transitions, including to other community colleges. California Community College and local transfer rates, such as reported in the *Annual Factbook*, are much better measures of actual 4-year transfer.

College fall-to-fall Retention rates (Figure 10) show slightly higher persistence for full-time students (62% vs 59%) and slightly lower persistence for part-time students (34% vs. 36%). Looking at time-to-degree measures in Figure 12 (Fall 2010 cohort), Compton Center had extremely low but comparable "normal time" (2-year), 150% (3-year) normal time graduation rates, and 200% (4-year) normal time graduation rates. Fall 2010 still represents an early cohort of the partnership. With recent efforts to increase the number of degrees and certificates at Compton Center, this rate is expected to rise somewhat in the next few reports.

Figures 13-16. Staffing, Salaries, Revenues & Expenses

Similar to Figure 3, the comparative staffing levels reported in Figure 15 may reflect differences in enrollment levels, local definitions and institutional organization, so comparison is less meaningful. Also, revenue sources and expenses detailed in Figures 13 and 14 are also affected by institutional size and local definitions.

Figure 16 compares average salaries of full-time instructional staff but there is insufficient information from other institutions to draw any comparisons.

Conclusion

Compton Center benefits from a customized comparison group reflecting similar features of the institution. On several measures of student achievement, the Center performed similarly to the custom group median. The notable exception was the number of certificates awarded in 2013-14 which was substantially less than the number awarded to the comparison group. While these measures may still reflect the unique events experienced by the Center, comparable persistence and a gradual increase in awards over time show promise for the future.




Figure 1. Percent of all students enrolled, by race/ethnicity, and percent of students who are women: Fall 2014




Figure 3. Number of subbaccalaureate degrees and certificates awarded, by level: 2013-14


Figure 4. Academic year tuition and required fees for full-time, first-time degree/certificate-seeking undergraduates: 2011-12 to 2014-15




Figure 6. Percent of full-time, first-time degree/certificate-seeking undergraduate students who received grant or scholarship aid from the federal government, state/local government, or the institution, or loans, by type of aid: 2013-14




Figure 7. Average amounts of grant or scholarship aid from the federal government, state/local government, or the institution, or loans received for full-time, first-time degree/certificate-seeking undergraduate students, by type of aid: 2013-14





Figure 8. Percent of all undergraduates receiving aid, by type of aid: 2013-14








Figure 10. Graduation rate and transfer-out rate (2011 cohort); graduation rate cohort as a percent of total entering students, and retention rates of first-time students (Fall 2014)


Figure 11. Graduation rates of full-time, first-time degree/certificate-seeking undergraduates within 150% of normal time to program completion, by race/ethnicity: 2011 cohort




Figure 13. Percent distribution of core revenues, by source: Fiscal year 2014





Figure 14. Core expenses per FTE enrollment, by function: Fiscal year 2014





METHODOLOGICAL NOTES

Overview

This report is based on data supplied by institutions to IPEDS during the 2014-15 data collection year. Response rates exceeded 99% for most surveys. Detailed response tables are included in IPEDS First Look reports, which can be found at

http://nces.ed.gov/pubsearch/getpubcats.asp?sid=010.

Use of Median Values for Comparison Group

The value for the comparison institution is compared to the median value for the comparison group for each statistic included in the figure. If more than one statistic is presented in a figure, the median values are determined separately for each indicator or statistic. Medians are not reported for comparison groups with fewer than three values. Where percentage distributions are presented, median values may not add to 100%. Missing Statistics

If a statistic is not reported for your institution, the omission indicates that the statistic is not relevant to your institution and the data were not collected. Not all notes may be applicable to your report.

Use of Imputed Data

All IPEDS data are subject to imputation for total (institutional) and partial (item) nonresponse. If necessary, imputed values were used to prepare your report.

Data Confidentiality

IPEDS data are not collected under a pledge of confidentiality.

Disaggregation of Data by Race/Ethnicity

When applicable, some statistics are disaggregated by race/ethnicity. Data disaggregated by race/ethnicity have been reported using the 1997 Office of Management and Budget categories. Cohort Determination for Reporting Student Financial Aid and Graduation Rates

Student cohorts for reporting Student Financial Aid and Graduation Rates data are based on the reporting type of the institution. For institutions that report based on an academic year (those operating on standard academic terms), student counts and cohorts are based on fall term data. Student counts and cohorts for program reporters (those that do not operate on standard academic terms) are based on unduplicated counts of students enrolled during a full 12-month period.

Description of Statistics Used in the Figures

Admissions and Test Score Data

Admissions and test score data are presented only for institutions that do not have an open admission policy, and apply to first-time, degree/certificate-seeking undergraduate students only. Applicants include only those students who fulfilled all requirements for consideration for admission and who were notified of one of the following actions: admission, non-admission, placement on a wait list, or application withdrawn (by applicant or institution). Admitted applicants (admissions) include wait-listed students who were subsequently offered admission. Early decision, early action, and students who began studies during the summer prior to the fall reporting period are included. For customized Data Feedback Reports, test scores are presented only if they are required for admission.

Average Institutional Net Price

Average net price is calculated for full-time, first-time degree/certificate-seeking undergraduates who were awarded grant or scholarship aid from the federal government, state/local government, or the institution anytime during the full aid year. For public institutions, this includes only students who paid the in-state or in-district tuition rate. Other sources of grant aid are excluded. Average net price is generated by subtracting the average amount of federal, state/local government, and institutional grant and scholarship aid from the total cost of attendance. Total cost of attendance is the sum of published tuition and required fees, books and supplies, and the average room and board and other expenses.

For the purpose of the IPEDS reporting, aid received refers to financial aid that was awarded to, and accepted by, a student. This amount may differ from the aid amount that is disbursed to a student.

Core Revenues

Core revenues for public institutions reporting under GASB standards include tuition and fees; state and local appropriations; government grants and contracts; private gifts, grants, and contracts; sales and services of educational activities; investment income; other operating and nonoperating sources; and other revenues and additions (federal and capital appropriations and grants and additions to permanent endowments). Core revenues for private, not-for-profit institutions (and a small number of public institutions) reporting under FASB standards include tuition and fees; government appropriations (federal, state, and local); government grants and contracts; private gifts, grants, and contracts (including contributions from affiliated entities); investment return; sales and services of educational activities; and other sources. Core revenues for private, forprofit institutions reporting under FASB standards include tuition and fees; government appropriations, grants, and contracts (federal, state, and local); private grants and contracts; investment income; sales and services of educational activities; and other sources. At degree-granting institutions, core revenues exclude revenues from auxiliary enterprises (e.g., bookstores, dormitories), hospitals, and independent operations. Nondegree-granting institutions do no report revenue from auxiliary enterprises in a separate category. These amounts may be included in the core revenues from other sources.

Core Expenses

Core expenses include expenses for instruction, research, public service, academic support, institutional support, student services, scholarships and fellowships (net of discounts and allowances), and other expenses. Expenses for operation and maintenance of plant, depreciation, and interest are allocated to each of the other functions. Core expenses at degree-granting institutions exclude expenses for auxiliary enterprises (e.g., bookstores, dormitories), hospitals, and independent operations. Nondegree-granting institutions do not report expenses for auxiliary enterprises in a separate category. These amounts may be included in the core expenses as other expenses.

Equated Instructional Non-Medical Staff Salaries

Institutions reported total salary outlays by academic rank and gender, and the number of staff by academic rank, contract length (9-, 10-, 11-, and 12-month contracts), and gender. The total number of months covered by salary outlays was calculated by multiplying the number of staff reported for each contract length period by the number of months of the contract, and summing across all contract length periods. The weighted average monthly salary for each academic rank and gender was calculated by dividing the total salary outlays by the total number of months covered. The weighted average monthly salary was then multiplied by 9 to determine an equated 9-month salary for each rank.

FTE Enrollment

The full-time equivalent (FTE) enrollment used in this report is the sum of the institution's FTE undergraduate enrollment and FTE graduate enrollment (as calculated from or reported on the 12-month Enrollment component). Undergraduate and graduate FTE are estimated using 12-month instructional activity (credit and/or contact hours). See "Calculation of FTE Students (using instructional activity)" in the IPEDS Glossary at http://nces.ed.gov/ipeds/glossary/.

FTE Staff

The full-time-equivalent (FTE) of staff is calculated by summing the total number of full-time staff and adding one-third of the total number of part-time staff. Graduate assistants are not included.

Graduation Rates and Transfer-out Rate

Graduation rates are those developed to satisfy the requirements of the Student Right-to-Know Act and Higher Education Act, as amended, and are defined as the total number of individuals from a given cohort of fulltime, first-time degree/certificate-seeking undergraduates who completed a degree or certificate within a given percent of normal time to complete all requirements of the degree or certificate program before the ending status date of August 31, 2014; divided by the total number of students in the cohort of full-time, first-time degree/certificate-seeking undergraduates minus any allowable exclusions. Institutions are permitted to exclude from the cohort students who died or were totally and permanently disabled; those who left school to serve in the armed forces or were called up to active duty; those who left to serve with a foreign aid service of the federal government, such as the Peace Corps; and those who left to serve on an official church mission. Transfer-out rate is the total number of students from the cohort who are known to have transferred out of the reporting institution (without earning a degree/award) and subsequently re-enrolled at another institution within the same time period; divided by the same adjusted cohort (initial cohort minus allowable exclusions) as described above. Only institutions with a mission that includes providing substantial preparation for students to enroll in another eligible institution are required to report transfers out.

Retention Rates

Full-time retention rates is a measure of the rate at which students persist in their educational program at an institution, expressed as a percentage. For four-year institutions, this is the percentage of first-time bachelors (or equivalent) degree-seeking undergraduates from the previous fall who are again enrolled in the current fall. For all other institutions this is the percentage of first-time degree/certificate-seeking students from the previous fall who either re-enrolled or successfully completed their program by the current fall. The full-time retention rate is calculated using the percentage of full-time, first-time degree/certificate-seeking undergraduates, while the part-time rate is calculated using the percentage of part-time, first-time degree/certificate-seeking undergraduates.

Total Entering Undergraduate Students

Total entering students are students at the undergraduate level, both fulland part-time, new to the institution in the fall term (or the prior summer term who returned in the fall). This includes all first-time undergraduate students, students transferring into the institution at the undergraduate level, and non-degree/certificate-seeking undergraduates entering in the fall. Only degree-granting, academic year reporting institutions provide total entering student data.

Tuition and Required Fees

Tuition is defined as the amount of money charged to students for instructional services, and required fees are those fixed sum charges to students for items not covered by tuition that are required of such a large proportion of all students that the student who does not pay the charge is an exception. The amounts used in this report are for full-time, first-time degree/certificate-seeking undergraduates and are those used by the financial aid office to determine need. For institutions that have differential tuition rates for in-district or in-state students, the lowest tuition rate is used in the figure. Only institutions that operate on standard academic terms will have tuition figures included in their report.
