Tapizar wins Sham at Santa Anita, looks to Derby

ARCADIA—Tapizar pulled away from Clubhouse Ride for a 41/4-length victory in the \$100,000 Sham Stakes on Saturday at Santa Anita, giving trainer Steve Asmussen an early contender for the Kentucky Derby.

Ridden by Garrett Gomez, Tapizar ran 1 1-16 miles in 1:40.38.

Gomez said Tapizar struggled to pay attention and take direction, but it didn't matter with his talent.

"When I asked him to pick it up, I couldn't quite get his focus going," Gomez said. "Hopefully, he has many more gears. He traveled beautiful, and he's a beautiful mover."

Asmussen said he plans to keep Tapizar at Santa Anita for the track's 3-year-old series, culminating in the April 9 Santa Anita Derby before the Kentucky Derby at Churchill Downs in May. The colt has already had one impressive victory at Churchill, a 101/2-length maiden win in November.

"With the races that he ran at the end of Churchill, I thought he was ideal for the series that's here," Asmussen said.

Tapizar earned \$60,000 for the win, his second in five starts, and paid \$4.20, \$2.80 and \$2.10. Clubhouse Ride returned \$3.40 and \$2.20, and Anthony's Cross paid \$2.60 to show.

Also Saturday, trainer Bob Baffert's Indian Firewater led from the gate and held off the charging Tweebster by a nose in the \$150,000 San Fernando Stakes.

Ridden by Mike Smith, Indian Firewater went straight to the front of the field of eight 3-year olds and had heavy favorite Thiskyhasnolimit on his flank for most of the race, covering 1 1-16 miles in 1:41.53.

Indian Firewater paid \$13, \$6.60 and \$4.40. Tweebster returned \$5.60 and \$4, and Do It All paid \$8 to show. Thiskyhasnolimit faded to fourth in the stretch.

The son of Baffert star Indian Charlie, Indian Firewater earned \$90,000 for the win, his third in 14 starts, for a career total of \$257,120.

Three dead as 10 cars crash on Pacific Coast Highway

LOS ANGELES—A car veered into oncoming lane of the Pacific Coast Highway, setting off a "very violent" 10-vehicle pileup that left three people dead and three others injured.

The famed roadway was packed with beach traffic on the summer-like Saturday when two vehicles collided in the initial crash, then eight more became entangled in the wreckage, Newport Beach police Lt. Bill Hartford said.

Three adults from two vehicles were declared dead at the scene and three others were taken to hospitals with injuries, one of them critical.

Two cars were overturned, some people were trapped inside their vehicles, and it took hours before some of the dead could be removed from the wreckage.

"Officers responding found glass strewn on both sides of the roadway, up onto the sidewalk, indicating a very violent traffic collision," Hartford said.

Sam Schudi was driving one of the cars involved with his wife Kelli in the passenger seat. They say an oncoming car hit a car two vehicles in front of them and became airborne.

"I heard the screech and the sound, and all the sudden I saw this car come flying in the air," Kelli Schudi told KCAL-TV. The couple was not among the injured.

The highway remained closed hours after the accident and was likely to be shut down through the night.

The famous highway runs along the ocean through many of California's most scenic stretches and most expensive neighborhoods.
