### **CALL TO ORDER**

Chair Simon called the College Curriculum Committee (CCC) meeting to order at 2:30 p.m.

### VICE PRESIDENT'S REPORT

El Camino College has been put on warning by the Accrediting Commission for Community and Junior Colleges (ACCJC) concerning Student Learning Outcomes (SLOs) and assessment.

El Camino College must complete assessments by spring 2013 and submit a Follow-Up Report by October 15, 2013. The college is at a high level development stage and will require some additional work to meet proficiency. The ACCJC will return to the campus in November to conduct an evaluation. A number of courses and programs assessed in 2006 and 2007 have disappeared from the CurricUNET database. F. Arce is looking into the possibility of separating SLOs from the CurricUNET process and plans to meet with vendors for a demonstration of their product. The SLO coordinators are working with division deans to identify and inactivate courses that have not been taught in over three years. According to Q. Chapman, approximately 70 courses have not been taught in three years. F. Arce has requested division deans to counsel their faculty to do a better job with the assessments.

### **APPROVAL OF MINUTES**

The committee conducted a live vote to approve the minutes from the February 12, 2013 meeting, which received unanimous approval.

### COURSE DISICIPLINE

B. Perez discussed the process of assigning courses to disciplines. Since passage of the Community College Reform Act (AB 1725), faculty have been given the primary role in determining the qualifications needed for a person to teach a course. Each committee member

brings a different point of view, knowledge, and expertise in their disciplined area and should become involved in assigning courses within disciplines and make recommendations for the appropriate qualifications required to teach a course.

There are two questions faculty must ask and be prepared to answer:

- 1. When someone is hired with the minimum qualifications for one discipline, what courses may the instructor teach if the college has not assigned courses to disciplines?
- 2. When a course is to be offered, what discipline specific preparation is appropriate to teach that course?

For the minimum qualifications for faculty and administrators in California Community Colleges, refer to the Disciplines List in CurricUNET.

#### Fine Arts

Chair Simon sent back Art 141 to the course author to make the following major changes:

- 1. Reconsider eliminating "art" as the course discipline. Just having "multimedia" as the discipline will severely restrict the pool from which you can draw potential candidates to teach this course. Consider including both "multimedia" and "art."
- 2. Review Lori Suekawa's comments on adding "color" to the course description.
- 3. Update entry skills page and choose the courses with the new numbers to match skills.

Chair Simon also sent back Art 143 to the course author to make the following major change:

1. Reconsider eliminating "art" as the course discipline. Just having "graphic arts" as the discipline will severely restrict the pool from which you can draw potential candidates to teach this course. Consider including both "graphic arts" and "art."

### **Mathematics**

Chair Simon sent back Mathematics 110 and Math 115 for course author to modify the course outline of record:

- 1. For Mathematics 110, update the Text and Materials section using the required books and materials recommended by Ed Martinez. Adjust the number of hours of independent study in section VI so that the course hours equal enough for 3 units suggested by M. Lipe.
- 2. For Mathematics 115, update the Conditions of Enrollment section to match skills to English 1A (the recommended preparation for this course). Modify the Text and Materials section using the required books and materials recommended by E. Martinez.
