CALL TO ORDER

Chair Kjeseth called the College Curriculum Committee (CCC) meeting to order at 2:35 p.m.

APPROVAL OF MINUTES

• The minutes from the February 23rd meeting were sent via email and approved before today's meeting. Chair Kjeseth thanked the committee for the continued success of reviewing and approving the minutes electronically in a timely manner.

VICE PRESIDENT'S REPORT

• F. Arce shared a concern that was discussed at the Board of Trustees meeting Monday evening – would SLO's be included in the new course outlines. Chair Kjeseth replied that CurricUNET will be able to accommodate SLO information.

CHAIR'S REPORT

• The official first phase of CurricUNET training has rolled out. Chair Kjeseth requested the committee members to review and share any comments and/or suggest any changes.

CURRICULUM REVIEW

Behavioral and Social Sciences Proposals

- G. Miranda, Dean of Behavioral and Social Sciences, distributed errata sheets to the committee with course revisions.
- Per Chair Kjeseth, all grammatical changes were included.
- History 175 All recommendations were accepted and completed. No questions were asked.
- History 176 A concern was voiced regarding the required text should the title be consistent with that of the required text of History 175, as it is the same textbook? It was decided to correct the title in History 176.
- Philosophy 11 All recommendations were accepted and completed. No questions were asked.

- Psychology Major There was discussion regarding Psychology 9A and 9B, and should Mathematics 150 be considered. Chair Kjeseth stated that Mathematics 150 should be reviewed. G. Miranda will take the recommendations of the committee back to the Psychology department for review. It was decided to leave the major requirements as is for now.
- Chair Kjeseth called for a motion to approve the conditions of enrollment and the distance education versions for the course proposals, and the major. M. Lipe moved, J. Sims seconded, and the motion was carried.

Fine Arts Proposals

- C. Fitzsimons, Dean of Fine Arts, presented an inactivation for the Entertainment Lighting Technology Certificate of Achievement.
- F. Arce questioned if any students had completed more than half of the courses required to obtain their certificate before inactivating the certificate. It was determined that the course had not been offered in more than 3 years; therefore, there would be no need to pursue this.
- Recommendations for the proposal were accepted.
- Chair Kjeseth called for a motion to approve the certificate inactivation. M. Lipe moved, J. Sims seconded, and the motion was carried.

Health Sciences and Athletics Proposals

- M. Lipe distributed errata sheets to the committee for course revision.
- Physical Education 120ab All recommendations were accepted and completed. No questions were asked.
- Chair Kjeseth called for a motion to approve the course proposal. V. Rayford moved, J. Thompson seconded, and the motion was carried.

Humanities Proposals

- M. Kline distributed errata sheets to the committee for course revision, major revision, and certificate revision.
- English A-X There was a question as to the similarity between English A and English A-X. M Kline informed the committee that English A-X is the ESL version of English A.
- Journalism Major There was some confusion with the existing requirements, which M.
 Kline explained: the English department previously had changes approved by the CCC in
 Spring 2009. The existing requirements will be updated on the proposal and the proposed
 requirements will remain as is; however, the updated requirements are not on the current
 proposal.
- Journalism Certificate of Achievement The same situation applies to this certificate as it does to the Journalism Major, with the same results.
- Chair Kjeseth called for a motion to approve the conditions of enrollment for the course proposal, major, and certificate revision. M. Lipe moved, J. Sims seconded, and the motion was carried.

Industry and Technology Proposals

• T. Jackson distributed errata sheets to the committee for requirements for the Associate in Science Degree in Cosmetology, Certificates of Accomplishment and Achievement in Cosmetology, and new course proposal.

- Associate in Science Degree A correction was made on the errata sheet, changing units for Cosmetology 1 from 6.5 to 13.
- Certificate of Accomplishment On errata sheet, Chair Kjeseth requested to remove 'OR' after Cosmetology 1, and remove 'AND' after Cosmetology 10. These corrections were approved and made.
- Certificate of Achievement A correction was made on the errata sheet, changing the hours of completion towards the 1600 hour total from 1100 to 1000 for Level II requirements.
- There was a discussion to clarify the issue of units according to Chair Kjeseth, at one time the number of units assigned were quite high and out of line with Title 5. Unit values changed, and have now been corrected due to an error made during the summer. The minutes from that meeting will be updated accordingly.
- Cosmetology 5 The title of this course should be Cosmetology 5ab. This is an evening version of Cosmetology 4, meeting 20 hours per week. In regards to item 5.2 on Form 2 'Is this course similar to an existing course at El Camino College?', it was determined that 'Yes' should be marked instead of 'No', and the explanation required will be drafted at a later time.
- The balance of the Industry and Technology degrees and certificates, which were distributed to the committee for this meeting, will be discussed at the next CCC meeting.
- Chair Kjeseth called for a motion to approve requirements for the Associate in Science Degree in Cosmetology, Certificates of Accomplishment and Achievement in Cosmetology, and new course proposal. R. Hughes moved, J. Thompson seconded, and the motion was carried.

GENERAL EDUCATION PROPOSAL

• There was a second reading of the proposal to update the course requirements for the Associate Degree General Education Pattern. S. Panski moved to adopt. Chair Kjeseth asked for any discussion. There was none, and Chair Kjeseth called for a vote to adopt. The results were: 11 - Yes, 0 - No, 0 - Abstention, and the motion was carried to adopt as is.

CONSENT AGENDA PROPOSALS

- The committee reviewed the consent agenda proposals. There were 7 course proposals on the agenda Behavioral and Social Sciences (1), Fine Arts (2), Health Sciences and Athletics (3) and Humanities (1).
- After review of the Consent Agenda, Chair Kjeseth asked for a motion to approve the proposals. S. Panski moved, A. Himsel seconded, and the motion was carried.

NOMINATIONS FOR NEW CCC CHAIR

- J. Thompson, who along with B. Jaffe is coordinating the election, stated that so far no one has agreed to accept a nomination, nor has anyone stepped forward of their own accord.
- The new Chair will serve a 2-year term (2011-2013), spending the 2010-2011 term shadowing Chair Kjeseth.
- According to the Bylaws, a nominee must be an active, voting member of the CCC.
- If there are no nominees, we will need to ask the Academic Senate to temporarily suspend the Bylaws in order to have a non-voting member nominated.
- The committee then discussed the issues of the Chair's duties, responsibilities, obligations, and workload.

ADJOURNMENT

• Chair Kjeseth called for a motion to adjourn the meeting. A. Himsel moved, J. Thompson seconded, and the motion carried. The meeting was adjourned at 4:10 p.m.

BEHAVIORAL AND SOCIAL SCIENCES DIVISION

COURSE REVIEW; CHANGES IN DESCRIPTIVE TITLE, CATALOG DESCRIPTION

1. History 175 - History of Asian Civilizations to 1600

Current Status/Proposed Change

This course <u>focuses surveys</u> on the political, economic, social, and cultural development of Asian civilizations from earliest times to 1600. Emphasis <u>will be is</u> placed on the experiences of India, China, Japan, Korea, and Southeast Asia and their interactions. Topics include the emergence of the earliest Asian civilizations, the development of major religious and philosophical traditions, the rise of regional and imperial states, and the impact of early contacts with the West.

Recommendation:
