CALL TO ORDER

Chair Kjeseth called the College Curriculum Committee (CCC) meeting to order at 2:30 p.m.

APPROVAL OF MINUTES

The minutes from the May 10 meeting were sent via email and approved as submitted prior to today's meeting.

CURRICULUM REVIEW: FULL REVIEW RESULTS

The following courses and programs were approved and are ready for final action:

- ✓ English 1A
- ✓ Environmental Technology A.S. degree program inactivation
- ✓ Environmental Technology Hazardous Materials Certificate of Achievement program inactivation
- ✓ Environmental Technology Occupational Safety and Health Certificate of Achievement program inactivation

It was noted that the new Kinesiology program has been returned to the course author for revisions, and will be re-introduced for review next fall.

NEW PROGRAM DEVELOPMENT

Q. Chapman gave a presentation to the committee concerning New Program Development. Copies of the presentation were distributed to the committee. Issues on this subject arise at different times, and Q. Chapman will meet with individual faculty to advise and assist with program development. Today's presentation acts as a refresher course, to let the committee know what is going on at the state level. Q. Chapman fielded a request – define what is meant by program. Basically, the type of program being discussed today is defined as a sequence of courses in a course of study, or a body of courses that lead to the goal of a degree or certificate.

Highlights and discussion included:

- The idea for a new program includes: evidence, support, justification, documentation.
- The Program and Course Approval Handbook (PCAH) outlines these requirements.
- A plan should be developed before moving on to approval.
- An advisory board is required for vocational programs. Although not required for non-vocational programs, it is helpful and strongly recommended.
- Job market information needs to be provided for career technical education (CTE) programs.
- Adequate resources must exist to maintain the program, including funding for faculty, equipment, and library or learning resources.
- The program must be in compliance with state and federal laws.
- If you are going to develop a new program, you must be able to sell it.

The top 11 reasons that delay approval of credit program applications were outlined. Chair Kjeseth noted that most of our programs are appropriate and have a good chance of being accepted.

- Q. Chapman then reviewed credit courses and course approval, noncredit courses and programs, and Title 5 course approval and credit certificates. There was discussion and clarification regarding types of credit certificates:
 - Certificates of Achievement are 18 or more units, degree applicable credit, and must be approved by the Chancellor's Office in order to be awarded.
 - Certificates of Accomplishment are fewer than 18 semester units, and may not be listed on the student's transcript. These certificates do not require Chancellor's Office approval.

ANNOUNCEMENTS

CCC members were reminded to submit their division plans for Fall 2011 – these are due June 7. Chair Kjeseth and Q. Chapman will assign courses to a particular CCC meeting, as a more organized strategy for completing course review. Since no one volunteered for a final Standard Review sub-committee, a final review will not be conducted. Standard review will resume in the fall.

F. Arce announced that 50 sections have been added to the Summer 2011 schedule. The focus will be on general education transfer, and some CTE courses.

ADJOURNMENT

Chair Kjeseth called for a motion to adjourn the meeting. V. Rayford moved, S. Rodriguez seconded, and the motion was carried. The meeting was adjourned at 3:20 p.m.
