#### A. SLO Update:

Pati Fairchild reported that the division has done very well in catching up on the number of SLO statements assessed; only a few assessments are still due. Dr. Rodriguez thanked everyone for their hard work on this.

Steve Cocca noted that CurricuNet is sending messages regarding course approvals that are directed to the wrong individuals; Kaysa Laureano is the point person and should be notified.

Pati reported that two other software programs are being evaluated for use with SLO assessments; it is likely that the TracDat software will be selected.

- A. Budget Announcements: It was announced that, effective July 1, 2013, part-time and casual employees cannot work more than 25 hours a week; this is a result of the provisions of the Affordable Health Care Act
- B. Schedule Development Spring 2014: Denise reported that the first draft of schedules for Spring 2014 will be distributed in the next week.
- C. Parking Concerns: Steve Cocca expressed concern about the difficulty of parking in the general area because of construction. He feels that those holding staff/faculty parking permits should be able to park in visitor stalls. There was also discussion regarding the possibility of the college providing a shuttle from the parking structure.
- D. Conference Reimbursement Requests: Faculty who have receipts should submit them to Jonelle as soon as possible for processing.
- E. Honda Internships: Pati Fairchild reported that Honda Research and Development is accepting applications for 16-week paid internships in the following areas: electrician, CATIA, auto body.
