- 1. College Council 2013-14 Goals:
  - a. Focus on student success and learning.
  - b. Monitor and support the advancement of the College's completion agenda of increasing the number of degrees, certificates, and transfers.

  - d. Actualize the "Making Decisions at El Camino College" document.
  - e. Complete the review of all policies and procedures relating to Accreditation.
  - f. Set up a review cycle for all policies and procedures.
- 2. AP/BP 3410 (Nondiscrimination): Will be presented to the Board for a First Reading at the October meeting.
- 3. AP 7150 (Evaluation): VP Beam will revise and prepare for presentation to the Board for a First Reading at the October meeting.
- 4. Committees Listed on Portal Report: VP Higdon reported that the Portal replaced Infonet and that chairpersons or approved users can upload minutes and update committee membership. - 5. Policies and Procedures Inventory: Lists from the President's Office, Academic Affairs, Administrative Services, Student Services and Human Resources were distributed for review. VP Beam presented the following:

  - b. BP 7351 (Retirement Classified Service): Has not been updated since adopted in 1978; need to remove.
  - c. BP/AP 7700 (Whistle Blower Protection): Will finalize at the October 21 College Council meeting.
  - d. BP 7510 (Domestic Partners): Will finalize at the October 21 College Council meeting.

e. BP/AP 7110 (Delegation of Authority): Will finalize at the October 21 College Council meeting.

VP Beam will forward an electronic copy of the above policies/procedures.

It was suggested that the policies and procedures be staggered for review in a two, four and six year cycle in the first round. The first priority will be those policies/procedures necessary for accreditation. It was noted that once all policies/procedures in the Human Resources area are updated, those required by law will be recommended for update off-cycle.
