In order to remain eligible for EOPS you **MUST** make at least 3 contacts each semester. At least 2 contacts **MUST** be with an EOPS Counselor. Not completing EOPS requirements will result in being placed on warning status with the program and/or dismissal.



Educational Planning Contact

- Update a current educational plan each semester with an EOPS Counselor. If you have an updated educational plan from another department, an EOPS counselor needs to review it.

Recommended Deadline:

Monday, April 1th



Mid Semester Check-In Contact

- Meet with an EOPS Counselor or Advisor to discuss progress in reaching educational goals for the term and to review resources to enhance student success.

Recommended Deadline:

Monday, April 29th



Follow-up Planning Contact

- The purpose of this contact is to help you prepare for the next term or to make future plans if you are graduating, receiving a certificate, or transferring.

Recommended Deadline:

Monday, May 20th

Progress Reports due by April 18th*

EOPS is using ECC Connect to help faculty, staff, and students build success together. Speak with your instructors to inform them that they have the option to submit a midterm progress report online through ECC Connect beginning March 18. Please note that paper progress reports are still available for pick up at the EOPS Counseling Office if your instructor prefers to complete the paper version. Please note that you must meet with an EOPS Counselor to discuss any substandard progress reports (grades below a "C" or NP) by May 9th before the "W" deadline.
