- ✓ VA will only pay for classes which are towards my current academic major. * VA does not pay for Contemporary Health 1 (CH-1), except for Dependents under Chapter 35 and Chapter 33 Transfer of Entitlement (TOE).

- ✓ I must submit to the El Camino College/El Camino College Compton Center Records Office all transcripts from any other college I have attended prior to seeing an Academic Counselor.

- ✓ If I reduce my units at any time, I will be held liable for any overpayments received from the VA

- ✓ If I ADD or DROP classes, I must notify the Veterans Office immediately by filling out a Change of Enrollment Notification.

- ✓ The VA will not pay for repeated courses, unless a grade of "C" or better is required to meet a prerequisite, or a grade of W, NC, or F was received.
