



# BUSINESS ADMINISTRATION MAJOR

## Transfer Requirements

The following requirements for the major are subject to change without notice. To assure accuracy of the information on this sheet, you should consult with a counselor, the articulation officer, or review articulation agreements via the internet at [www.assist.org](http://www.assist.org).

### CAREER OPPORTUNITIES

Business Administration programs are designed to prepare people to plan, organize, and control the activities of people and other resources to achieve the objectives of an organization. Typical options under Business Administration major include: Accounting, Finance, Management, Human Resources Management, International Business, Management Information Systems, Operations Management (or Management Science), Marketing, and Business Law, Real Estate and Labor Relations, Transportation and Logistics. Not every college offers all of these options; check with the transfer college catalog or web site of your choice.

### CALIFORNIA STATE UNIVERSITY, DOMINGUEZ HILLS

**Pre-Major Courses:** Business 1A-1B; CIS 13; Economics 1, 2; Law 4 or 5; **Recommended:** Math 150 as preparation for an upper division course at CSUDH.

**International Business Concentration:** add Political Science 10

### CALIFORNIA STATE UNIVERSITY, FULLERTON

**Pre-Major Courses:** CIS 13; Economics 1, 2; Law 4; Math 160 or 190

\* Economic 2 will double count for major and General Education. Additional lower division prerequisites include Accounting and Business Writing to be taken at CSU Fullerton. (See a business counselor and [www.assist.org](http://www.assist.org) for further information.)

### CALIFORNIA STATE UNIVERSITY, LONG BEACH \*Impacted

**Pre-Major Courses:** Business 1A-1B; CIS 13; Economics 1, 2; Law 5; Math 150\*; 160 & 161 or 190; Philosophy 3 or 8 or 23 (Philosophy 3 or 23 is required for the option in Accounting and Philosophy 8 is required for the option in Management Information Systems).

\*Applicants must complete pre-major courses with grades of C or better. A minimum cumulative GPA of 2.40 is required for admittance to the major. However, this is subject to change, please check the website at [www.csulb.edu](http://www.csulb.edu) or consult with the CSULB representative for details.

*\*Math 150 is a new requirement effective fall 2008; prior to this, Math 140 was required. There will be a three year grace period to allow students who have taken Math 140 to meet the requirement. Effective fall 2011, Math 140 will not be required as major preparation and will be removed from ASSIST. The new requirement will be Math 150; 160 and 161 or 190.*

### CALIFORNIA STATE UNIVERSITY, LOS ANGELES

**University requirement:** English 1C

**Pre-Major Courses:** Business 1A-1B; CIS 13; Economics 1, 2; Law 5; Math 150. (Math 160 is required for MIS)

### CALIFORNIA STATE UNIVERSITY, NORTHRIDGE

**Options:** Business Law, Financial Services (impacted), Management, Marketing, Real Estate, Supply Chain Management, and Systems and Operations Management.

**Pre-Major Courses:** Business 1A-1B, 28, CIS 13 or Business 54; Economics 1, 2; Law 5; Math 150 and 160 or 190. A cumulative GPA of 2.5 will be required for the financial service option for admission.

**Marketing Option:** add Psychology 5; Geography 1 or 8 or Geology 1

**Accounting Option:** this option is impacted. Students must complete Business 1A and Business 28 with grades of "B" or better. The other prerequisite courses need to be completed with grades of "C" or better. Students will apply to the Accounting option in their first semester at CSUN. Applicants will be ranked by GPA and admitted to the major in that order until all spaces are filled.

## **SAN DIEGO STATE UNIVERSITY**

### **\*Impacted**

**Pre-Major Courses:** Business 1A-1B (articulation pending); & 28 (Business 28 is not required for accounting majors.); CIS 13; Economics 1, 2; Law 4; Math 150 or Psychology 9A or Sociology 109; Math 140 & 160 or 190.

### **NOTES:**

Students must apply to enter the University under the business administration pre-major. To be admitted to the upper division emphasis, students must meet the following criteria:

- 1) Grades of C or better required in each pre-major class
- 2) Complete a minimum of 60 transferable semester units
- 3) Have a minimum cumulative GPA of 2.90
- 4) Complete all lower division GE by the spring semester prior to transfer.

## **CALIFORNIA POLYTECHNIC STATE UNIVERSITY, SAN LUIS OBISPO**

### **\*Impacted**

**Pre-Major Courses:** Business 1A-1B; Economics 1, 2; Law 5; Math 150 & 160

### **NOTES:**

1. The Economic major is also offered in the School of Business with options in Business and Industrial Economics, International Trade and Development, and Quantitative Economics.

## **CALIFORNIA STATE UNIVERSITY, SAN JOSE**

**Pre-Major Courses:** Business 1A-1B; Economics 1, 2; CIS 13; Law 4; English 1B or 1C; recommended: Math 140 and 150.

Accounting, Accounting Information Systems, and Corporate Financial Management Majors are not required to take Business 1B.

## **CALIFORNIA STATE POLYTECHNIC UNIVERSITY, POMONA**

**Pre-Major Courses:** Business 1A-1B; Economics 1 & 2; English 1C; Math 150; CIS 13; Law 4 Finance. Real Estate and Law concentrations should add Math 160 and 161.

## **UNIVERSITY OF SOUTHERN CALIFORNIA, (USC)**

**Pre-Major Courses:** English 1A, 1B or 1C; Economics 1, 2; Math 160 & 161 or 190; Math 218 taken at USC. Recommended: Business 1A-1B (completion of 1A-1B will remove one required BUAD course at USC)

\* Note: It is highly recommended that students complete the following pre-major requirements by the end of the fall semester prior to the application deadline (February 1): Economics 1 & 2; second semester of English (1B or 1C); and Math 160 and 161 or 190.

A maximum of 64 units can be transferred from a community college. Applications for admissions to the School of Business Administration can be submitted after completing at least three semesters of transferable college work and 30 transferable units as well as the courses listed above. Admission is competitive; students with an average GPA of 3.70 or higher and grades of "B" or better in the courses required for admission will have an advantage in the admissions review process.

## **LOYOLA MARYMOUNT UNIVERSITY**

**Pre-Major Courses:** Business 1A-1B; Economics 1, 2; Math 160; CIS 13

A lower division business law class is required after transfer. A student must have completed a course in Business Calculus, (ECC Math 160), with a grade of "C" (2.0) or better in order to transfer into the College of Business Administration.

All Business Administration students must satisfy the general education requirements and complete the Business Administration requirements listed above. In most cases, students are eligible to transfer after completing 30 units of transferable coursework, with a minimum GPA of 3.00. A maximum of 60 units may be transferred from all community college work.

## **MOUNT SAINT MARY'S COLLEGE**

**Pre-Major Courses:** Business 1A-1B, 25; Economics 1, 2; Law 4 or 5; Math 130 or 140; Math 150; CIS 13; Speech 1

A maximum of 66 semester credit units may be transferred from all community college work.

### **PEPPERDINE UNIVERSITY, SEAVER COLLEGE**

Business 1A-1B, 54; Math 140, 150, 160 or 180; Economics 1, 2

### **PEPPERDINE UNIVERSITY, GRAZIADIO SCHOOL OF BUSINESS AND MANAGEMENT**

(This program is for full time working adults; location is in Culver City; it is NOT offered through Seaver College in Malibu).

To transfer to the School of Business and Management's Bachelor of Science in Management program, a student must have earned a minimum GPA of 2.0 on 60 or more transferable semester units from a regionally accredited college. Students should have two years of full time work experience before entering the program.

Recommended courses: Business 1A, 1B, Economics 1, 2, and business courses.

### **UNIVERSITY OF REDLANDS, WHITEHEAD CAMPUS-TORRANCE (ACCELERATED DEGREE)**

Recommended courses: Business 1A-1B; Economics 1, 2; Math 130, 150

Students should have a minimum of 40 transferable units to be eligible for admission with a minimum GPA of 2.0. Three years of work experience is highly recommended.

### **UNIVERSITY OF CALIFORNIA, RIVERSIDE**

**Pre-Major Courses:** Economics 1, 2; CIS 13; Business 25; Business 1A-1B; Math 150 or Psychology 9A; Psychology 9B (not required for fall 2008 admission); Math 160 or 190. Students may also take Math 180 at ECC in preparation for Math 22 at UCR. Other prerequisites must be taken at UCR.

To meet selection criteria to be admitted directly into the Business Administration major, students should complete: Business 25, Business 1A-1B, Economics 1, 2, CIS 13, Math 160 or 190, and Math 150 or Psychology 9A prior to transfer, and all general education must be completed, (IGETC strongly recommended). A GPA of at least 2.5 in all UC transferable course work is required.

### **UNIVERSITY OF CALIFORNIA, BERKELEY**

**Major Prerequisite Courses:** Business 25; Economics 1, 2; English 1A & 1B; Math 150, 190; One additional writing or Literature course from the Creative Writing, English, or Literature departments. The course must be UC transferable for at 3 semester or 4 quarter units; Three years of a single foreign language in high school or Chinese 2 or French 2 or German 2 or Italian, or Japanese 2 or Spanish 2 at El Camino College. (Visit the website [www.assist.org](http://www.assist.org) for other options to meet the foreign language requirement).

To be eligible for admission to the Haas School of Business a student must:

1. Complete all prerequisite courses for letter grades. (See above)
2. All 7 of the breadth courses under the College of Letters and Sciences for those applying fall 2009 or beyond (see breadth requirement guidelines on page 4).
3. Complete at least 60 UC transferable semester units.
4. Complete the foreign language requirement.
5. Items 1 through 4 must be completed by the end of the spring term prior to fall enrollment. However, it is recommended that all major requirements be completed prior to transfer and the majority completed by the end of the fall semester in which the UC application is submitted.
6. Students must meet the breadth requirement through course work. AP, A level, or IB exams will not fulfill breadth requirements. IGETC does not meet breadth requirements.

**Note:** Prerequisite courses must be completed no more than 5 years before admission to Haas. Apply in November for admission for the following Fall semester. The completed application must be postmarked no later than November 30. ## **Breadth Requirements**

### **Students applying fall 2009 and beyond:**

The breadth requirement has changed to the College of Letters and Science 7-Course Breadth. While some courses may fit into more than one breadth category, a single course may not be used by the student to fulfill multiple breadth requirements, nor may a course be used to satisfy both a breadth and a prerequisite requirement. Students must take one course from each of the following seven areas; All seven courses must be completed by the end of the spring term prior to the start of the Haas Undergraduate Program:

## **UNIVERSITY OF CALIFORNIA, IRVINE**

### **B.A. Business Administration:**

This major will begin accepting applications for fall 2010. Junior level applicants with the highest grades overall (minimum cumulative GPA of 3.0) and who satisfactorily complete required lower-division major requirements will be given preference for admission.

**Required courses:** Math 150 or Psychology 9A or Sociology 109; Business 1A,1B; Economics 1, 2; Math 190, 191
