## Transfer Requirements

### CAREER OPPORTUNITIES

Industry employs the largest number of economists in such locations as banks, credit institutions, insurance companies, manufacturing firms, utilities and consulting firms. Economists work as management trainees, economic researchers, urban planners, bank officers, hospital administrators, consumer protection agents, and public administrators. A person with a bachelor's degree might work in government and industry positions that involve collecting and compiling data (knowledge of statistics is required). Quantitative Economists forecast changes such as interest rates and housing starts. Understanding how nations interact in the world economic arena is increasingly important. Economics can be the basis for careers in law, labor, politics, and journalism. A master's degree or higher is necessary for college and university teaching.

**Pre-Major Courses:** Economics 1 and 2; Math 160 or 190; CIS 13; Students may take Math 191 and will be exempt from taking Accounting 201B at CSU Fullerton. Economics 2 will double count for major preparation and general education.

### CALIFORNIA STATE UNIVERSITY, LONG BEACH

**Pre-Major Courses:** Business 1A and 1B; Economics 1 and 2; Math 160 and 161 or 190  
Recommended preparation for graduate study: Math 190, 191, 220  
Major Options: Business Economics or Mathematical Economics & Economic Theory

### CALIFORNIA STATE UNIVERSITY, LOS ANGELES

**University Requirement:** English 1C  
**Pre-Major Courses:** Economics 1, 2; Math 150; Option 1) Applied Economics: add Business 1A-1B; CIS 13; Math 160 or 190. Option 2) Social and Behavioral Sciences: add Business 1A-1B; Math 160

### CALIFORNIA STATE UNIVERSITY, NORTHRIDGE

**Pre-Major Courses:** Business 1A and 28; Economics 1 and 2; Math 150 and 160 or 190. Recommended for graduate study: Math 190-191.  
\* All courses must be completed with a "C" or better.

### CALIFORNIA STATE POLYTECHNIC UNIVERSITY, POMONA

**Pre-Major Courses:** Economics 1 and 2 or 5; Math 190-191; Business 1A; English 1C, 72

### CALIFORNIA STATE POLYTECHNIC UNIVERSITY, SAN LUIS OBISPO

**Pre-Major Courses:** Economics 1 and 2; Support courses: Business 1A and 1B; Law 5; Math 150 and Math 160 or 190-191;

### SAN DIEGO STATE UNIVERSITY

**\*Impacted major:** Cumulative GPA of 2.40.

**Pre-Major Courses:** Business 1A; Economics 1 and 2; Math 150, Math 140 and 160 or 190; CIS 13  
Options available in International Economics, Pre-professional Studies, Quantitative Analysis

### **UNIVERSITY OF CALIFORNIA, BERKELEY**

**Pre-Major Courses:** Economics 1 and 2; Math 190 and 191 or 160 and 161. The average GPA of students admitted is 3.5 in prerequisites for the major. Complete as many lower division requirements as possible before transfer. In general, applicants are selected primarily based upon strength of academic preparation and grade point average.

\*Note: Transfer students **MUST** complete IGETC or L&S Requirements in Reading and Composition, Foreign Language, and Quantitative Reasoning by the end of the spring term prior to fall transfer at Berkeley.

### **UNIVERSITY OF CALIFORNIA, IRVINE**

**Pre-Major Courses:** Economics 1 and 2; CS 3 and 30; Math 190 and 191, 220, 270 (students may take Math 4 at UCI or Math 220 and 270 at ECC); Two courses from Anthropology 1, 2, 3, Geography 1, 2, 5, Political Science 3, Psychology 5, Sociology 101

### **UNIVERSITY OF CALIFORNIA, LOS ANGELES**

*Fall Applicants Only - The average GPA of students admitted is about 3.70.*

**Pre-Major Courses for Economics:** English 1B or 1C; Economics 1 and 2; Math 190 and 191

**Pre-major Courses for Business Economics:** Business 1A-1B; English 1B or 1C; Economics 1 and 2; Math 190 and 191

**Pre-Major Courses for Economics/International Area Studies (International Business or Government Service):** English 1B or 1C; Economics 1 and 2; Math 190 and 191; 5<sup>th</sup> semester of any modern language which is spoken in the geographical area of the student's major concentration.

**Notes:** **1.** Once admitted to a major outside the Department of Economics, a change of major to any of the three Economics majors will not be permitted. **2.** If pursuing a double major in Economics and a second major, apply only to the Economics major.

**Pre-Major Courses:** Economics 1 and 2; Math 190 and 191  
**Business Economics option:** add: Business 1A

**B.A. Economics:** Economics 1 and 2; Math 190, 191, and 220

### **UNIVERSITY OF CALIFORNIA SANTA BARBARA**

**B.A. Economics:** Economics 1 and 2; Math 190 and 191 and 270. Students will need a 2.85 GPA in

**B.A. Business Economics:** Economics 1 and 2; Business 1A and 1B; Math 150, Math 190 and 191 or Math 160 and 161 (beginning, Fall 2011, Business Economics will no longer be offered, A new major, Economics and Accounting is being offered this Fall and will replace the Business Economics major.

\*Note: Students are initially admitted to the pre-major. Only the first repeat of any pre-major course will be accepted by the Department of Economics in determining full admission to the full major. The criteria is subject to annual review and revision, interested students should consult the department directly to obtain current information regarding specific additional criteria for admission to the full major.
