#### **ABOUT THE PROGRAM:**

The Radiologic Technology Program at El Camino College is a <u>diagnostic medical radiography program</u> leading to an A.S. Degree and eligibility to take licensing examinations for the American Registry of Radiologic Technology (ARRT) R.T. (R), and certification by the State of California, Radiologic Health Branch for Radiography (C.R.T) and Fluoroscopy (F).

This program does not offer separate courses in only fluoroscopy for state certification. The fluoroscopy courses are integrated within the Program Courses. This program does not offer courses for certification in Mammography, Ultrasound, Nuclear Medicine, Radiation Therapy, MRI or Computed Tomography (CT).

The <u>Associate in Science (A.S.) Degree</u> Radiologic Technology program is a minimum of twenty-five months in length. The Program begins a new class of students each FALL semester. The program consists of four regular semesters (Fall and Spring), two eight week Summer sessions, and one Fall semester post session.

The clinical (hospital) internship parallels the academic courses. Satisfactory completion of all academic and clinical competencies for the degree and certification requirements qualifies students for State and National Certification examinations.

The Radiologic Technology Program is <u>fully accredited</u>, having met requirements of The Joint Review Committee on Education in Radiologic Technology (JRCERT), and the California Department of Public Health, Radiologic Health Branch (CDPH-RHB).

Radiologic Technology Program Courses must be taken in sequence, and each course must be completed with a minimum grade of "C" to continue into the next semester and remain in the program.

#### TRANSFER CREDIT:

Students wishing to transfer from another Radiologic Technology program must contact the Program Director for assessment. Advanced standing will be determined following the submission and evaluation of course descriptions, official transcripts, and verification of clinical experience. Applicants with prior training or experience in Radiologic Technology <u>may</u> petition for credit by examination for RTEC A, RTEC 106, RTEC 107, and RTEC 111. Each applicant will be evaluated on an individual basis.

#### **ADMISSION INTO THE PROGRAM:**

Students are admitted into the program by an application process. Applications are available online on the ECC Radiologic Technology programs website:

A limited number of students are admitted into the program annually. Class size is determined by the availability of clinical space, approximately 24 students per year. There is no longer a waiting list for the program. Admission is based on a multi-criteria point system. The application filing period is every year during the Spring semester for Fall entrance into the program. In order to apply it is expected that all prerequisites are complete only general education courses be in progress at the time of application. After being admitted to the program students will be notified by email about their program start date and also information about the mandatory orientation classes held in the summer prior to start the program in the Fall.

### Special Note Regarding A.R.R.T. Certification Eligibility

Students must comply with the "Rules of Ethics" contained in the American Registry of Radiologic Technologists' (ARRT) Standard of Ethics. These are minimally acceptable standards of professional conduct for all presently Registered Technologists and Applicants. The "Rules of Ethics" are intended to promote the protection, safety and comfort of patients. The "Rules of Ethics" are available for review at www.arrt.org

The <u>A.R.R.T.</u> may deny applications for certification if the applicant has been found guilty of dishonesty, fraud, deceit, acts which deceive the public, felony, child abuse, sex offender crimes; acts involving narcotics, dangerous drugs or devices, assault and/or battery and other crimes.

For a Pre-Application Packet

Requests for Criminal Background Checks: The Joint Commission on Accreditation of Hospitals Organizations (JCAHO) requires that <u>all persons</u> involved in direct patient care, complete and pass a personal background check. JCAHO requires verification of competency of all individuals who have direct contact with patients or employees; this includes **students** doing clinical rotations in the healthcare facility. Competency extends beyond technical skills to an individual's criminal history. HR 1.20 & Title 5, section 58106 allows districts to **establish limitations** on **enrollment** for various reasons to protect health and safety.

Successful completion of a criminal background check is **required for admission** and continuation in all Health Sciences Programs. The criminal background check policy and procedure for meeting this mandated prerequisite is available from the Program Director. The student shall be responsible for paying any associated costs of a criminal background check. The Radiologic Technology Program background checks are done at a cost of approximately \$50.
