- General Assistance (GA)

METHOD A - REQUIRED DOCUMENTATION

Submit one of the following documents:

- Copy of a <u>current or last</u> month's check for CalWORKs, SSI, SSP, or GA benefits. Current or last month's bank statement with direct deposit of SSI benefit is acceptable documentation. Please submit a PHOTOCOPY of your benefit check or bank statement.
- Agency Certification Form, verifying eligibility, with an authorized signature, agency stamp, and <u>current date</u>.

- Independent Student: A copy of <u>signed</u> student(s)'and/or spouse's Register Domestic Partner's IRS Tax Return Transcript or U.S. Income Tax Return(s) for 2015.
- Non-tax Filers: A copy of W-2 Transcript or W-2(s) from the IRS or a copy of 1099 Transcript from the IRS or 1099(s)
