# IPEDS Data Feedback Report 2020 Highlight of Findings



The National Center for Education Statistics (NCES) distributes a standard report to college and university leaders each year entitled *IPEDS Data Feedback Report*. The report summarizes demographic, enrollment and achievement data from the previous year (in this report, data through 2018-19 academic year and Fall 2019) and includes comparative references from earlier reports. *Median* results from a comparison group developed by each institution are displayed next to institutional results. The darker bars on all charts represent El Camino College (ECC) while the lighter bars represent the comparison group median. The *median* is the value for the college located in the middle of an ordered list of college values; each measure may have a different institution at its median. Methodological notes are on pages 11 through 14 of the report.

Below are highlights from each figure presented in the IPEDS Data Feedback Report:

# Figure 1. Race/Ethnicity and Gender (page 3)

- ECC has a lower percentage of Hispanic/Latino students, by sixteen percentage points, compared to the comparison group's median.
- ECC has a higher percentage of Black or African American students by eight percentage points compared to the comparison group's median.
- El Camino College has a slightly lower percentage of female students (51%) compared to the comparison group's median (55%).

# Figure 2. Headcount and FTE (page 3)

- ECC is one of the larger schools that enrolls 34,373 students while the comparison group's median is 31,947 students enrolled during the 2018-2019 school year.
- ECC served 18% more full-time students in Fall 2019 (8,240) compared to the comparison group's median (6,748).
- ECC generated 12% more full-time equivalent (FTE) enrollment than the median for the comparison group during the 2018-2019 school year.

# Figure 3. Distance Education (page 3)

- The percentage of students taking at least one distance education course in Fall 2019 is slightly lower (16%) at ECC compared to the comparison group (19%).
- The percentage of students exclusively in distance education in Fall 2019 is slightly lower (7%) at ECC compared to the comparison group (9%).

# Figure 4. Number of Degrees and Certificates (page 4)

- ECC awarded 69% more Associate's degrees (3,648) than the comparison group's median (2,551) in 2018-2019.
- The number of medium-term (1 -2 years) and short-term certificates (less than 1 year) awarded are higher in number at ECC compared to the comparison group.

# Figures 5-6. Academic Year Tuition, Fees, and Net Price (page 4)

- Figure 5 shows that ECC's academic year tuition and fees in 2019-2020 were slightly lower (\$1,144) compared to its comparison group's median (\$1,220).
- Figure 6 indicates that the average net price of attendance<sup>1</sup> in 2018-2019 was higher for ECC students (\$11,719) than the comparison group's median (\$6,318).

# Figures 7-8. Financial Aid Grant Recipients (page 4-5)

- Figure 7 shows that the percentage of first-time, full-time degree/certificate-seeking (FTF) students at ECC who received some form of grant aid in 2018-2019 was 70%, lower than the comparison group's median (73%).
- Figure 8 indicates that FTF students received greater grant awards (\$5,959) compared to the comparison group's median (\$5,470).
- The percentage of El Camino College first-time, full time degree seeking students receiving Pell grants (46%) was lower than the comparison group percentage (50%).

# Figures 9-11. Retention, Graduation & Transfer-Out Rates (page 5-6)

- Figure 9 shows the fall to fall retention rates for full time students was 77% for both ECC and the comparison group.
- Graduation rates for first-time, full-time degree-/certificate-seeking students (Figure 10) was slightly higher for ECC (35%) than the comparison group (29%).
- The data in Figure 10 also shows a transfer-out rate of 10% and 11% for ECC and the comparison group, respectively. This rate measures all college transfers, including to other community colleges.
- Figure 11 represents the graduation rates for full-time, first-time degree/certificate seeking students disaggregated by ethnicity. The figure shows that ECC Asian, Latino, and White students had slightly higher graduation rates compared to the comparison group's median in each of these categories.

# Figures 12-13. Graduation Rates by Financial Aid Type & Time to Completion (page 7)

- ECC Fall 2016 full-time, first-time Pell grant recipients had a 29% graduation rate within 3 years (150% of normal time<sup>2</sup>) compared to the comparison group's median (25%).
- Figure 13 shows graduation rates for Fall 2015 full-time, first-time degree/certificate seeking students. ECC had higher graduation rates within 3 years (150% of normal time) and within 4 years (200% of normal time) compared to the comparison group's median.

# Figures 14-17. Awards and Enrollment Rates by Pell Status (pages 7-8)

- The percentage of first-time, full-time ECC students (Figure 14) and non-first-time, full-time ECC students (Figure 16), both Pell recipients and non-Pell recipients, that received awards in four-, six-, and eight-years were slightly higher to the comparison group's median.
- The percentage of first-time, part-time ECC students (Figure 15), both Pell recipients and non-Pell recipients, that received awards in four-, six-, and eight-years were similar to the comparison group's median.
- Non-first-time, part-time ECC students (Figure 17), both Pell recipients and non-Pell recipients, that received awards in four-, six-, and eight-years were slightly higher to the comparison group's median.

# Figures 18-23. Staffing, Salaries, Revenues & Expenses (pages 9-10)

- Revenue sources and expenses as detailed in Figures 18 and 19 are affected by institutional size and local definition so comparison is less meaningful.
- Similar to Figures 18 and 19, the comparative staffing levels reported in Figure 20 may reflect differences in enrollment levels, local definitions and institutional organization, so comparison is less meaningful.
- Figure 21, which compares average salaries of full-time instructional staff, shows that salaries at ECC are higher than the comparison group's median.

# Conclusion

Despite demographic similarities with peer institutions, ECC had better student outcomes in many categories of the 2020 report than their comparison group's median, especially in terms of degree counts, time to graduation rates, and retention rates. The report does not give an indication of where ECC ranks numerically within the peer group but the rates reported demonstrate that El Camino College is continuing to perform among top colleges in the group in these outcomes.




Figure 1. Percent of all students enrolled, by race/ethnicity, and percent of students who are women: Fall 2019




Figure 3. Percent of students enrolled in distance education courses, by amount of distance education: Fall 2019




Figure 5. Tuition and required fees for full-time, first-time degree/certificate-seeking undergraduates: Academic years 2016-17 to 2019-20


Figure 6. Average net price of attendance for full-time, first-time degree/certificate-seeking undergraduate students, who were awarded grant or scholarship aid: 2016-17 to 2018-19


Figure 7. Percent of full-time, first-time degree/certificate-seeking undergraduate students who were awarded grant or scholarship aid, or loans, by type of aid: 2018-19


Figure 8. Average amounts of awarded grant or scholarship aid, or loans awarded to full-time, first-time degree/certificate-seeking undergraduate students, by type of aid: 2018-19


Figure 10. Graduation and transfer-out rates of full-time, first-time degree/certificate-seeking undergraduates within 150% of normal time to program completion: 2016 cohort


Figure 9. Retention rates of first-time degree/certificate seeking students, attendance status: Fall 2018 cohort

program completion, by type of aid: 2016 cohort





Figure 14. Award and enrollment rates of first-time, full-time, degree/certificate-seeking undergraduates after 8 years of entry, by Pell status:















Figure 18. Percent distribution of core revenues, by source: Fiscal year 2019








Figure 20. Full-time equivalent staff, by occupational category: Fall 2019

Figure 21. Average salaries of full-time instructional non-medical staff equated to 9-months worked, by academic rank:




Figure 22. Percent distribution of library collection, by material type: Fiscal Year 2019

Furthermore, data used in this report are provisional level and may be revised for a limited time through the IPEDS Prior Year Revision system.

# Cohort Determination for Reporting Student Financial Aid, Graduation Rates, and Outcome Measures

Student cohorts for reporting Student Financial Aid and Graduation Rates data are based on the reporting type of the institution. For institutions that report based on an academic year (those operating on standard academic terms), student counts and cohorts are based on fall term data. Student counts and cohorts for program reporters (those that do not operate on standard academic terms) are based on unduplicated counts of students enrolled during a full 12-month period.

Student cohorts for reporting Outcome Measures are based on a full-year cohort from July 1-June 30 for all degree-granting institutions.

# **DESCRIPTION OF INDICATORS USED IN THE FIGURES**

# Admissions (only for non-open-admissions schools)

# Admissions and Test Score Data

Admissions and test score data are presented only for institutions that do not have an open admission policy, and apply to first-time, degree/certificate-seeking undergraduate students only. Applicants include only those students who fulfilled all requirements for consideration for admission and who were notified of one of the following actions: admission, non-admission, placement on a wait list, or application withdrawn (by applicant or institution). Admitted applicants (admissions) include wait-listed students who were subsequently offered admission. Early decision, early action, and students who began studies during the summer prior to the fall reporting period are included. For customized Data Feedback Reports, test scores are presented only if scores are required for admission.

#### Student Enrollment

#### **Enrollment Counts**

12-month Enrollment captures a cumulative unduplicated headcount of enrollment over the full 12-month period beginning July 1 and ending June 30. In contrast, Fall Enrollment captures number of students enrolled on a particular date in the fall. Fall enrollment is often referred to as a "snapshot" of an institution"s enrollment at a specific time.

#### FTE Enrollment

The full-time equivalent (FTE) enrollment used in this report is the sum of the institution's FTE undergraduate enrollment and FTE graduate enrollment (as calculated from or reported on the 12-month Enrollment component). Undergraduate and graduate FTE are estimated using 12-month instructional activity (credit and/or contact hours). See "Calculation of FTE Students (using instructional activity)" in the IPEDS Glossary at https://surveys.nces.ed.gov/ipeds/VisGlossaryAll.aspx.

#### Total Entering Undergraduate Students

Total entering students are students at the undergraduate level, both full- and part-time, new to the institution in the fall term (or the prior summer term who returned in the fall). This includes all first-time undergraduate students, students transferring into the institution at the undergraduate level, and non-degree/certificate-seeking undergraduates entering in the fall. Only degree-granting, academic year reporting institutions provide total entering student data.

#### **Completions**

#### Completions and Completers

Completions collects data on undergraduate and graduate completions and completers in a 12-month period. Completions are the counts of postsecondary awards granted where each award reported once but multiple awards may be reported for one recipient. Completers are the counts of students granted postsecondary awards. The count of completers is collected in two ways. The first way counts all completers, while the second way counts completers by award level (e.g., number of associate's completers, number of bachelor's completers).

# Student Financial Aid

# Financial Aid Recipients and Amounts

Student Financial Aid collects the counts of undergraduate students awarded different types of financial aid and the total amounts of aid awarded. The average dollar amount of aid awarded is then calculated. In addition, Student Financial Aid collects counts of full-time, first-time undergraduate student awarded aid and amounts of aid, and counts of undergraduate and graduate students receiving military educational benefits.

# **Charges and Average Net Price**

# Average Institutional Net Price

IPEDS collects data to calculate average net price at each institution for two groups of undergraduate students: those awarded grant aid and those awarded Title IV federal aid.

Average net price is calculated for full-time, first-time degree/certificate-seeking undergraduates who were awarded grant or scholarship aid from the federal government, state/local government, or the institution anytime during the full aid year. For public institutions, this includes only students who paid the in-state or in-district tuition rate. Other sources of grant aid are excluded. Average net price is generated by subtracting the average amount of federal, state/local government, and institutional grant and scholarship aid from the total cost of attendance. Total cost of attendance is the sum of published tuition and required fees, books and supplies, and the average room and board and other expenses.

For the purpose of the IPEDS reporting, aid awarded refers to financial aid that was awarded to, and accepted by, a student. This amount may differ from the aid amount that is disbursed to a student.

# Retention, Graduation Rates, and Outcome Measures

# Retention Rates

Retention rates are measures of the rate at which students persist in their educational program at an institution, expressed as a percentage. For four-year institutions, this is the percentage of first-time bachelors (or equivalent) degree-seeking undergraduates from the previous fall who are again enrolled in the current fall. For all other institutions this is the percentage of first-time degree/certificate-seeking students from the previous fall who either re-enrolled or successfully completed their program by the current fall. The full-time retention rate is calculated using the percentage of full-time, first-time degree/certificate-seeking undergraduates, while the part-time rate is calculated using the percentage of part-time, first-time degree/certificate-seeking undergraduates.

# Graduation Rates and Transfer-out Rate

Graduation rates are those developed to satisfy the requirements of the Student Right-to-Know Act and Higher Education Act, as amended, and are defined as the total number of individuals from a given cohort of full-time, first-time degree/certificate-seeking undergraduates who completed a degree or certificate within a given percent of normal time to complete all requirements of the degree or certificate program; divided by the total number of students in the cohort of full-time, first-time degree/certificate-seeking undergraduates minus any allowable exclusions. Institutions are permitted to exclude from the cohort students who died or were totally and permanently disabled; those who left school to serve in the armed forces or were called up to active duty; those who left to serve with a foreign aid service of the federal government, such as the Peace Corps; and those who left to serve on an official church mission.

A further extension of the traditional Graduation Rates (GR) component which carries forward 100% and 150% graduation rates data previously reported in the GR component is the Graduation Rates 200% (GR200) component, which requests information on any additional completers and exclusions from the cohort between 151% and 200% normal time for students to complete all requirements of their program of study.

Transfer-out rate is the total number of students from the cohort who are known to have transferred out of the reporting institution (without earning a degree/award) and subsequently re-enrolled at another institution within the same time period; divided by the same adjusted cohort (initial cohort minus allowable exclusions) as described above. Only institutions with a mission that includes providing substantial preparation for students to enroll in another eligible institution are required to report transfers out.

## Outcome Measures Data

Alternative measures of student success are reported by degree-granting institutions to describe the outcomes of four degree/certificate-seeking undergraduate student groups: First-time, full-time (FTFT); First-time, part-time (FTPT); Non-first-time, full-time entering (NFTFT); and Non-first-time, part-time entering (NFTPT). Additionally, each of the four cohorts collects data on two subcohorts: Pell grant recipients and non-Pell grant recipients. These measures provide the 4-year, 6-year, and 8-year award rates (or completions rates) after entering an institution. NCES calculates award rates by dividing a cohort's or subcohort's adjusted cohort into the number of total awards at 4-year, 6-year, and 8-year status points.

The initial cohort can be revised and take allowable exclusions resulting in an adjusted cohort. Institutions are permitted to exclude from the initial cohort students who died or were totally and permanently disabled; those who left school to serve in the armed forces or were called up to active duty; those who left to serve with a foreign aid service of the federal government, such as the Peace Corps; and those who left to serve on an official church mission.

The highest award and the type of award (i.e., certificate, Associate's, or Bachelor's) are reported at each status point. For students who did not earn an undergraduate award after 8-years of entry, the enrollment statuses are reported as either still enrolled at the institution, or subsequently transferred out of the institution. Unlike the Graduation Rates data, all institutions must report on a full-year cohort (students entering July 1 of one year to June 30 to the next) and on their transfer out students, regardless if the institution has a mission that provides substantial transfer preparation.

# **Finance**

# Core Revenues

Core revenues for public institutions reporting under GASB standards include tuition and fees; government (federal, state, and local) appropriations and operating and nonoperating grants/contracts; private gifts, grants, and contracts (private operating grants/contracts plus gifts and contributions from affiliated entities); sales and services of educational activities; investment income; other operating and nonoperating sources; and other revenues and additions (capital appropriations and grants and additions to permanent endowments). "Other core revenues" include federal appropriations, sales and services of educational activities, other operating and nonoperating sources, and other revenues and additions.

Core revenues for private, not-for-profit institutions (and a small number of public institutions) reporting under FASB standards include tuition and fees; government (federal, state, and local) appropriations and grants/contracts; private gifts, grants and contracts (including contributions from affiliated entities); investment return; sales and services of educational activities; and other sources (a generated category of total revenues minus the sum of core and noncore categories on the Finance component). "Other core revenues" include government (federal, state, and local) appropriations, sales and services of educational activities, and other sources.

Core revenues for private, for-profit institutions reporting under FASB standards include tuition and fees; government (federal, state, and local) appropriations and grants/contracts; private grants/ contracts; investment income; sales and services of educational activities; and other sources (a generated category of total revenues minus the sum of core and noncore categories on the Finance component). "Other core revenues" include government (federal, state, and local) appropriations and other sources.

At degree-granting institutions, core revenues exclude revenues from auxiliary enterprises (e.g., bookstores and dormitories), hospitals, and independent operations. Non-degree-granting institutions do no report revenue from auxiliary enterprises in a separate category, and thus may include these amounts in the core revenues from other sources.

#### Core Expenses

Core expenses include expenses for instruction, research, public service, academic support, student services, institutional support, scholarships and fellowships (GASB) or net grant aid to students (FASB) and other expenses. Core expenses exclude expenses for auxiliary enterprises, hospitals, and independent operations. "Other core expenses" is the sum of grant aid/scholarships and fellowships and other expenses.

#### **Endowment Assets**

Endowment assets, for public institutions under GASB standards, and private, not-for-profit institutions under FASB standards, include gross investments of endowment funds, term endowment funds, and funds functioning as endowment for the institution and any of its foundations and other affiliated organizations. Private, for-profit institutions under FASB do not hold or report endowment assets.

# Salaries and Wages

Salaries and wages for public institutions under GASB standards and private (not-for-profit and for-profit) institutions under FASB standards, include amounts paid as compensation for services to all employees regardless of the duration of service, and amounts made to or on behalf of an individual over and above that received in the form of a salary or wage.

# **Staff**

#### FTE Staff

The full-time-equivalent (FTE) by occupational category is calculated by summing the total number of full-time staff and adding one-third of the total number of part-time staff. Postsecondary teachers category includes instructional staff who are primarily engaged in teaching and those who do a combination of teaching, research, and/or public service. It also includes staff whose primary functions are research or public service. Instructional support occupations include archivists, curators, and museum technicians; librarians and media collections specialists; librarian technicians; student and academic affairs and other education services occupations. Other staff include staff in service occupations; sales and related occupations; office and administrative support occupations; natural resources, construction, and maintenance occupations; production, transportation and material moving occupations; and military specific occupations. Graduate assistants are not included.

#### Equated Instructional Non-Medical Staff Salaries

Institutions reported the number of full-time nonmedical instructional staff and their salary outlays by academic rank, gender, and the number of months worked (9-, 10-, 11-, and 12-months). Salary outlays for staff who worked 10-, 11-, and 12-months were equated to 9-months of work by multiplying the outlays reported for 10-months by 0.90, the outlays reported for 11 months by 0.818, and the outlays reported for 12-months by 0.75. The equated 10-, 11-, and 12-outlays were then added to the outlays for instructional staff that worked 9-months to generate a total 9-month equated salary outlay. The total 9-month equated outlay was then divided by total number of instructional non-medical staff to determine an equated 9-month average salary. This calculation was done for each academic rank. Salary outlays were not reported for staff that work less than 9-months and were excluded.

# Student-to-Faculty Ratio

Institutions can provide their institution's student-to-faculty ratio (i.e., student-to-instructional staff) for undergraduate programs or follow the NCES guidance in calculating their student-to-faculty ratio, which is as follows: the number of FTE students (using Fall Enrollment survey

data) divided by total FTE instructional staff (using the total Primarily instruction + Instruction/research/public service staff reported in Human Resources component and adding any not primarily instructional staff that are teaching a credit course). For this calculation, FTE for students is equal to the number of the full-time students plus one-third the number of part-time students; FTE for instructional staff is similarly calculated. Students in "stand-alone" graduate or professional programs (such as, medicine, law, veterinary, dentistry, social work, or public health) and instructional staff teaching in these programs are excluded from the FTE calculations.
