


#### Quick Reminder

What new practices has your division created to support students and faculty in a hybrid/hyflex/online/in-person learning environment?

Most of our programs depend on studios, labs and performance spaces and we are working to bring as many classes back to campus as possible while continuing to offer online sections where appropriate. This gives students and faculty flexibility in being able to choose from a variety of learning/teaching modalities.

We have several ongoing projects to upgrade our facilities which will improve the on-campus experience for our students and faculty:

o Dance Department Modular Village – The Dance Department will be moving to new studios in the ECC Modular Village being created in Lot L. Dance faculty and the division have requested that the studios be equipped for hyflex instruction. o Completion of the new Arts Complex building – The new Arts Complex is nearing completion and we are planning on scheduling classes in it for the Spring semester. We intend for the new building to provide the opportunity for students and faculty to return to on-campus instruction in the areas of Film, Photography, and Visual Art that will help them recover from the COVID shut down.


