

The Chancellor's Office is giving the colleges increasing authority over course approvals. It's possible that they will next give the colleges authority for approving non-credit courses. This authority is contingent on us completing the certification process, which was completed last week and is described on the following slide. If we lose this authority, it would add 4-6 months to the approval process because all of our courses would need to be approved by the Chancellor's Office.

The slides that follow also explain that we can now offer certificates of achievement for as few as 8 units. Certificates of achievement are listed on students' transcripts (and earn the college more points in the new funding formula); certificates of accomplishment are not listed on students' transcripts.

Things are going really smoothly with the implementation of the new curriculum and catalog software. In the meantime, we are relying on a paper process, affectionately known as Curricu-Janet. <sup>(2)</sup>

There was discussion of whether departments should be encouraged to lower the units required for their certificates. For example, Music requires 20 units for a certificate of achievement. This decision rests with the department. Providing comparison data for certificate requirements may encourage departments to review their requirements.

### Other CCC Accomplishments

#### Catalog (Accalog)

-Completed the transition of our current pdf catalog to the online Accalog system.

- -Underwent review from various departments on campus.
- -DigArc is making final changes based on our feedback.
- -Training on how to manage and customize the catalog will begin in two weeks.

**Next phase:** Building the curriculum **(Curriculog)** component - uploading forms/setting up approval process)

**Transition:** Moved to a "paper" process. Proposal forms and outlines are emailed to the Divisions, faculty make changes directly on the forms and sends them back - they are reviewed and sent to the CCC. Things are going smoothly thanks to division clerical support.

#### **Reviewed:**

Articulation agreements from 8 local high schools. Approved 19 course reviews with 35 more courses slotted for the October 9<sup>th</sup> meeting.

Darcie will be ECC's delegate at Fall Plenary. A resolution of no confidence in the Chancellor may be presented at Plenary. As discussed in spring and fall ECC senate meetings, approximately 6 of 114 colleges have passed such votes. These expressed concern about the lack of consultation for AB 705, the fully online college, and performance-based funding.

Area D (San Diego) faculty brought a resolution to their meeting but it was voted down; it may be presented again at Plenary. ECC senators were invited to offer input so Darcie can effectively represent the ECC Senate. The ECC Federation executive board passed a vote of no confidence in the Chancellor. ECC senators advised abstaining at Plenary because the issues are better addressed individually, there is a need for more information to make an informed decision, and abstention keeps the door open for the resolution to return for another vote. Darcie's colleagues trust her to make a wise decision on behalf of the ECC Senate.

#### fh. VP Instructional Effectiveness: Russell Serr

The status reports for SLOs are the best they've ever been. The quality is also very high. However, this semester we are still missing 5 program reviews. This is not good. The new orientation gives faculty a 10-month heads up as a way to encourage them to start right away. Lead faculty need to start early, but the department must also support them. CTE has two-year reviews. KDD noted that if we want Program Review to be a faculty-led process, it's essential that faculty provide stronger leadership in this area. Continuous improvement is required by Ed Code and for accreditation. Senators were asked to help communicate to their division how essential it is that faculty are providing strong leadership so the college has "sustainable continuous quality improvement." This requires processes which are "ongoing and systematic" (ACCJC Rubric for Program Review).

#### fh. VP Instructional Effectiveness: Russell Serr

Faculty don't have to complete Program Review alone; Russell and Linda Clowers provide endless support to help faculty succeed. Russell Serr thanked the Program Review Committee which provides thoughtful feedback and suggestions.

# G. Information Items -Discussion

#### e. ASO Update: Wiley Wilson

ASO is having a special election this week for President and Vice President. The blood drive is also this week. There will be no movie night this fall but ASO hopes to offer two in spring. They are working on a Thanksgiving family dinner with turkey gift cards. Metro U-Pass has new tiers: 100% subsidy for homeless students, 50% for students in programs such as EOPS, and 25% for students with ASB sticker. There is no longer a requirement that students be receiving the California Promise Grant to purchase U-Pass. These will be offered again the 2<sup>nd</sup> or 3<sup>rd</sup> week of spring semester.

# D. Special Committee Reports

Faculty should have received information from their dean about the training module that needs to be completed by all faculty this semester. Full-time faculty can apply for flex credit by submitting a conference report. Adjunct faculty are asked to complete the training as part of their five hours of other professional obligations.

The MyECC portal Team Sites are going away at the end of winter session. With Canvas, it's not a good use of resources to maintain two programs that serve the same purpose.

A question came up last meeting about service animals. This will be addressed in a separate policy/procedure.

There were very minor changes made to AP 4055 at Council of Deans. A question arose about a student whose accommodation allows her more time on tests. She understood she would have 8 weeks to write an essay the class had 4 weeks to complete. The procedure refers to tests; might we need to clarify that it's in-class tests? The SRC helps students understand what is reasonable re: accommodations. Prior practice can also guide us. Darcie will liaise with Gary to learn more about how we can prevent misunderstandings.

#### b. Institutional Research and Planning: Strategic Planning – Ross Miyashiro

The plan will be published in a separate document, which hasn't yet been named. Copies of the current version of BP 1200 were distributed for information only. These have been reviewed by the Ed Policies Committee. However, since our planning processes are being revised, IR suggested we wait until after the next Strategic Planning Committee meeting to bring BP 1200 and the Strategic Plan to Senate in November/December. #### c. Human Resources Update: Reviewsnap – Jane Miyashiro

We have a new online system for performance appraisal, Reviewsnap, which will roll out in December/January for administrative managers. Faculty may be invited to provide input into a "360 review" for their dean. 360 reviews incorporate feedback not only from supervisors but also from those reporting to the evaluatee. With the new system, evaluations will be completed entirely online. There will be a video providing training on how to offer constructive feedback. Rather than sending to a lot of people who not have responded, the new approach will be more specific and strategic. HR is aiming for a 100% return rate. Feedback will be incorporated into a development plan. What is the dean doing well? What can they improve on? All feedback will be anonymous. The VPs will look at the information and what patterns are emerging.

#### c. Human Resources Update: Reviewsnap – Jane Miyashiro

Senators asked about the Applause cards and how to provide positive feedback now that the program has been discontinued. HR emailed a survey (deadline October 19<sup>th</sup>) asking for feedback on the new system and for volunteers for the planning committee.

Clarification was provided regarding the online evaluations. The new online system will be rolled out for deans first, then classified, then faculty. The software platform is distinct from the content of faculty evaluations. A task force worked last year to review and revise faculty forms. Those are being reviewed by Council of Deans and the Federation. They will then come to Academic Senate whose approval is required for the changes to be implemented. The goal is to complete consultation in fall and roll out revised forms on Reviewsnap in spring.

Thanks to VP Miyashiro for updating Senate on Reviewsnap, our new online review software!
