MINUTES

ECC Minimum Qualifications List

- EPC reviewed the FSA/MinQuals/Equivalency Task Force edits to the Minimum Qualifications list.
- EPC approved the use of the min quals list titles in the CCCCCO list in lieu of our locally developed titles (see the new table of contents for an overview).
- EPC approves the reformatting to reflect the CCCCCO list and for ease of understanding.
- EPC approves the inclusion of notations when the local min qual exceeds the state one.
- EPC approves the changes to discipline min quals that were completed in consultation with Deans and discipline faculty, including Accounting, Community College Counselor of Students with Disabilities, Computer Information Systems, Developmental Disabilities: Disabled Students Programs and Services, Engineering, Learning Disabilities Specialist, and Public Safety.
- EPC approved the recommendation to use the language from the CCCCCO list to describe Interdisciplinary Studies.
- EPC approved the inclusion of an Academic Strategies and Human Development min qual under Interdisciplinary Studies.
- EPC would like to ask the Deans about whether we need a min qual for Educational Development to be listed under Interdisciplinary Studies.
- It was noted that for the “Disciplines Requiring any Bachelor’s or Associate Degree and Professional Experience,” we divide this into categories. Category 1 exceeds the CCCCCO min qual by requiring 5 years of work experience, instead of two, in addition to the BA. We need to note that we are exceeding the min qual in these disciplines. EPC would like to point this out to the Deans and see if they would like to leave it this way.
- EPC would like to ask the Deans whether some of the disciplines in category 2 (requiring the BA and two years experience) should be moved to category 1 (requiring BA and five years experience). These include Athletic Training, Aviation, Diagnostic Medical Technology, Restaurant Management, Radiological Technology, Respiratory Technician, and Respiratory Technologies.
