Training for the Curriculog transition has begun. The training schedule consists of nine calls, four of which have been completed. The next phase of training will focus on data validation, integration, forms set-up, and complying with Title V Education Code. The new online catalog is scheduled for released on May 9.

6. VICE PRESIDENT'S REPORT: Vice President of Academic Affairs – J. Shankweiler

J. Shankweiler emailed C. Martin, Director of Library Learning Resources, to ask about saving online course information for purposes of audits and grade challenges. C. Martin responded that access to Etudes was extended for an extra three years, in addition, access to data is still available in Canvas. J. Shankweiler gave special recognition to the Business Division for submitting numerous DE Addendums which will help encourage and support working adults returning to college. ECC is attempting to offer more online courses to replace the decline seen in night classes, including offering shorter 8-week sessions. The Business Division has worked hard on the Real Estate Certification to create shorter modules offered online. ECC will be marketing the Business Administration ADT and Real Estate Certificate as part of a working adult education program. Once the new Student Services Building opens, more amenities will be offered in the evening for students, such as Admissions & Records, Financial Aid, and Career

& Counseling services. J. Shankweiler stressed the May 15 deadline for submitting Flex Credit in Cornerstone and emphasized there will be no extensions this year.
