CURRICULUM DISCUSSION

A. Full Course Review

Chair Young made an adjustment to the agenda. She explained that Fashion 48, Math 67 and Math 110 were tabled and will be reviewed at the March 12 meeting. She explained to the committee that after a discussion among the curriculum advisor and the division, and because the course was revised so extensively, that English RWE will be inactivated and replaced with a new course, English 1. The CCC had already reviewed and approved the content of this course. In order to move the course forward, the new course proposal for ENGL 1 will be reviewed and discussed in "real time" at the meeting.

Health Sciences & Athletics Division

PE 10B - Intermediate Body Conditioning and Physical Fitness was presented as a new course proposal.

4. COLLEGE CURRICULUM COMMITTEE TRAINING

Chair Young provided a brief overview of AB705 regulations pointing out the major tenets which are to: 1) increase the numbers of students who enter and complete transfer level English and math/quantitative reasoning in one year; 2) minimize the disproportionate impact on students created through inaccurate placement processes; 3) remove any references to placement tests in the catalog and replace them with "or appropriate assessment"; 4) assess students based on high school GPA or course completion; and 5) provide support courses and other strategies for student success for those who choose to take college level math or English courses.

Chair Young acknowledged the yeoman efforts by the Math and English faculty, deans, AB705 Committee, ITS, and the curriculum office to comply with these regulations in order to meet the fall 2019 deadline.

Chair Young stated that often times faculty are not aware of the process for submitting a course. She noted there are times when a faculty member entered a course in CurricUNET and mistakenly thought it is working its way through the system. She reminded the committee that if a course is listed in CurricUNET as "pending," it is as though the course is sitting in a desk drawer until it is formally "launched." Although the new Curriculog system will help with this, Chair Young reminded the committee of the process and stated that any new courses must go through a review by the Curriculum Advisor early in the process to determine if the course meets Title 5 regulations and is viable for the campus. The Dean must be apprised and the Division Curriculum Committee must approve the proposal. The proposal must also appear on the Division Plan that is submitted each fall and spring. If a course is to be reviewed out of cycle (six years for academic courses and two years for CTE), the Dean must submit a formal memo and compelling documentation to the Curriculum Advisor requesting extenuating circumstances. The request will be reviewed, and if approved, a submission date will be assigned.

Chair Young explained that the courses in CurricUNET are accessible as read only. She asked that faculty check to see if there is anything in CurricUNET that needs attention and send an email to Chair Young about it.

- J. Shankweiler recommended that CCC Reps meet with their respective deans prior to and after each CCC meeting to keep them apprised of CCC actions and relevant information.
- D. Breckheimer mentioned that there had been a discussion of moving to a three-digit numbering system for transfer level courses. J. Shankweiler agreed that this is a worthwhile project that will be entertained in the future.
