### 1. APPROVAL OF MINUTES

The minutes of February 26, 2019, were approved via email by the College Curriculum Committee (CCC) on March 4, 2019.

## 2. CHAIR'S REPORT: College Curriculum Committee Chair – J. Young

Chair Young thanked the committee for approving the minutes from the March 7 meeting.

Chair Young noted that all proposals for today's meeting were reviewed as Full Review proposals and explained that the seven proposals scheduled for the March 26 meeting fall under Standard Review. Therefore, aside from M. Lipe, the Standard Review Rep for the next meeting, CCC members will not be receiving any proposals.

Chair Young explained the Distance Education Expansion Project, which is designed for divisions who wish to offer a course via distance education, but the course is not scheduled for review. Faculty are to complete the *Distance Education Addendum for Expansion Project* form, have the action approved by their DCC, and submit the addendum with their other curriculum this semester. Chair Young noted that C. Escutia emailed the instructions and form to CCC members, division deans, and associate deans on February 28. Once Board approved, the courses may be offered in spring 2020.

Next, Chair Young presented a PowerPoint explaining that the eight-hour limit for flex credit for voting CCC members has been lifted. The presentation included a review of all the categories related to curriculum and how to submit them in the new system, Cornerstone. The PowerPoint presentation was emailed to all CCC members along with today's agenda.

Finally, Chair Young reminded CCC members to work with their deans and DCCs to get all course review proposals submitted this semester so that the college remains in compliance.

The CCC participated in a second reading of the Distance Education Addendum. The suggestions from the Distance Education Committee and the CCC were incorporated into this version. The suggestions for additional changes included revising the definitions to match definitions presented by the Chancellor's Office Distance Education Advisory Committee and other minor changes. These changes will be implemented once they are finalized at the state level. Chair Young reminder the CCC that this will be an electronic form, so any formatting issues will be resolved.
