#### 1. APPROVAL OF MINUTES

Minutes of September 25, 2018, were approved via email by the College Curriculum Committee on 10/2/18.

### 2. CHAIR'S REPORT: College Curriculum Committee Chair – J. Young

Chair Young thanked the CCC Representatives and the clerical support of each division for utilizing the new "paper" process this semester. She reminded the CCC to watch the due dates closely in order to meet all submission deadlines. The timeline is posted on the CCC website.

Chair Young reminded the committee that, if they are inactivating a course, they should also consider the effect on the degrees/certificates. Revisions to degrees or certificates should be submitted with the inactivation, or shortly thereafter, to make sure that the revisions will be included in the 2019-2020 catalog. The forms are posted on the CCC website.

Chair Young also reminded the committee to be mindful of Distance Education versions during the course review process. If faculty wish to add a Distance Education (100% online or Hybrid 51% online with regular scheduled on-campus meetings), they should do it as the course is being reviewed. If the course is already approved for distance education delivery and you think you might want to offer it as a hybrid course in the future, consider adding that option now so you don't have to wait until the next time it is up for review to add the distance education addendum.

Finally, Chair Young mentioned that she will be signing the Annual Course and Program Certification Form, obtaining signatures from the VPAA, Academic Senate President, and CEO/Superintendent and forwarding it to the Chancellor's Office by the end of the week.

## **CURRICULUM DISCUSSION**

## A. Consent Agenda Proposals

Chair Young introduced Tiffany Miller, director of Career Pathways, as she has been working with local schools on the 34 High School/South Bay Consortium Articulation Agreement Renewals presented at the meeting. Chair Young noted that while conducting review of these agreements, M. Lipe noticed some minor discrepancies. Chair Young and Articulation Officer L. Suekawa contacted T. Miller. T. Miller confirmed that the high schools use ECC outlines, and corrections were made to the articulation agreements to make sure they were accurate.

Chair Young reminded the CCC that these articulation agreements mean that students who successfully complete these courses in high schools become eligible to take the credit by exam at ECC to earn credit for the corresponding ECC courses.

It was moved by M. Lipe, seconded by J. Minei, that the committee approve the 34 high school articulation agreements. The motion carried.
