#### 1. APPROVAL OF MINUTES

The minutes of March 10, 2020 were approved via email by the College Curriculum Committee (CCC) on March 18, 2020.

The minutes of March 17, 2020, Special Meeting, were approved via email by the CCC on March 19, 2020.

## 2. CHAIR'S REPORT: College Curriculum Committee Chair – J. Young

Chair Young thanked the CCC for approving the March 10 and March 17 minutes, C. Cervantes for serving as the Standard Review Representative for today's meeting, and C. Striepe for agreeing to serve as the Standard Review representative for the April 28 meeting. She also thanked the CCC for their careful review and thoughtful suggestions for the proposals and noted that their suggestions continually improve the quality of our curriculum.

Chair Young also thanked the CCC for attending the Special CCC meeting on March 17, during which the CCC approved courses being offered in spring for online and hybrid delivery. She noted that the Chancellor's Office approved the Temporary Emergency Distance Education (DE) Blanket Addendum, which was approved through June 12, 2020. Since this is a temporary measure, the CCC is now charged with approving all courses for online and hybrid delivery through the standard process of DCC and then CCC approval. In order to facilitate this action, a simplified process will be implemented.

In the next week, Divisions will receive a memo and a spreadsheet listing the DE courses needing online and hybrid approval. This is being done in the event that these courses need to be offered via distance education in the future.

Chair Young reminded the committee that the paper process will continue until the end of the semester. If any divisions need proposals, they should contact Chair Young immediately. Chair Young also reminded the committee that they should keep their deans apprised of CCC matters, share the agenda and approved proposals, and pass along any other information gleaned from our meetings.

## 3. CURRICULUM REVIEW
