1. APPROVAL OF MINUTES

The minutes of April 28, 2020 were approved via email by the College Curriculum Committee (CCC) on May 4, 2020.

2. CHAIR'S REPORT: College Curriculum Committee Chair – J. Young

Chair Young thanked M. Chaban for her work as the Standard Review representative for this meeting and thanked M. Lipe for agreeing to serve as the Standard Review representative for the next meeting.

Chair Young updated the CCC on the Distance Education Expansion Project. She explained that the addenda for summer will be approved at the May 26 meeting and the addenda for fall will be reviewed at the June 9 meeting. She stressed that it is important that the CCC work with their Deans and DCC members to get these addenda submitted by the deadlines so we may remain in compliance.

Current course outlines are being input into Curriculog by B. Knapp, administrative assistant of Behavioral & Social Sciences, in preparation of fall review. Course input will continue throughout the summer. Curriculog training will be offered online in summer and continue in fall. J. Young and L. Plum will present an overview of Curriculog on Fall Flex Day.

Chair Young thanked the CCC for their careful review of today's proposals and reviewed some of the major questions proposed by the CCC. She noted that one of the primary responsibilities of the CCC is to review prerequisites and corequisites to ensure they meet Title 5 regulations. Future trainings will focus on this topic. Chair Young reminded the CCC that changes to SLOs should not be made on the course outline of record. The SLO Statement Change Form must be submitted approved by the department/DCC/Dean/Associate Dean and forwarded to the SLO Campus Coordinators. Once approved, the form will be forwarded to the Curriculum Office with an effective date and the change will be made on the outline. This is done to maintain consistency.

The CCC was reminded that they are the liaison between the CCC and the DCC, Deans and Associate Deans, Assessment of Learning Community (ALC), and SLO Division Facilitators and should regularly communicate with them about curriculum matters.

Chair Young noted that C. Escutia will distribute the template for Fall Division Plans soon. They will be due June 9. These plans are essential as they will help the Curriculum Office plan for curriculum review in fall and in having the courses ready in Curriculog.
