### 1. APPROVAL OF MINUTES

The minutes of September 10, 2019, were approved via email by the College Curriculum Committee (CCC) on September 18, 2019.

### 2. CHAIR'S REPORT: College Curriculum Committee Chair – J. Young

Chair Young began by thanking the committee for approving the September 7 minutes. She also thanked C. Striepe for serving as the Standard Review representative for today's meeting and thanked J. Minei for agreeing to serve as the representative for the October 8 meeting. Chair Young noted that the full and standard review proposals would be forwarded to them on Thursday, Sept 26.

Chair Young announced that Mt. San Antonio College (SAC), a leader in noncredit education, has agreed to provide us with training at their college on a Friday in October, with the date and time to be determined. This will be most helpful as we work to grow our noncredit program. All interested faculty and staff are invited and flex credit will be available. She also noted that Flex Credit for CCC faculty members is updated after each meeting in Cornerstone.

Next, Chair Young presented a memo from Curriculum Advisor L. Plum (included in the packet), which provided standardized wording for prerequisites, corequisites, and recommended preparations for courses that use the verbiage of "Eligibility for English 1A." This change was necessitated by AB 705 regulations. An extensive discussion took place which included S. Kushigemachi (Associate Dean of Humanities), M. Lipe (Past CCC Chair and HSA representative), L. Justice (Registrar), L. Suekawa (Articulation Officer), Rosie Miranda (Counseling Rep), and many other CCC members. The consensus was that these three options needed to be listed, as there are several ways in which students can meet the requirements.

The standardized wording for prerequisites, corequisites, and recommended preparations using "Eligibility for English 1A" is: English 1 or eligibility for English 1A or qualification by appropriate assessment. The CCC was directed to use the objectives from English 1 in the matching skills area of the course outline.

Chair Young asked for a motion to approve the use of the revised verbiage for courses being reviewed at today's meeting. It was moved by B. Halonen, seconded by M. Lipe. The motion was approved.
