#### 7. VICE PRESIDENT'S REPORT: Vice President of Academic Affairs – J. Shankweiler

J. Shankweiler gave an update regarding Math 12 and Math 23. She noted that the two courses were tabled in order to gain feedback on what effects the .335 units might have across campus. The Registrar's Office noted that it might be an issue with Colleague and student records. In order to determine the effects, a test run environment was suggested before approving the .335 units. Counseling noted that Degree Planner would also need to be tested. It was suggested to explore and research other colleges and what effects they have experienced.
