

Review Minutes

G. Fry approved the minutes, Susana Acosta-Acuna second. All were in favor to approve the minutes from June 2, 2022.

Course Review

- a. **MATH 150H**. This course was reviewed and approved last spring. It was mentioned, from now on, both Math 150 and Math 150H will be reviewed together in the spring.
- **b.** Math 115/116. D. Eldanaf is waiting for CM3 to see if they will review this fall or in the spring. They next cycle will be determined accordingly.
- c. Program review for Committee D. D. Eldanaf is waiting for Edwin Ambrosio to confirm if the program review is at the CCC level because it was submitted in the spring. M. Lemons will confirm if it was approved.
- **d. Program review for CM1.** It was submitted on May 31st, 2022. G. Fry received a confirmation email from Kevin that he had received it, as of then G. Fry has not received a status on the program review.
- e. Math 190S considering creating a supplemental section. G. Fry mentioned that CM 1 will be meeting to discuss possibly adding a supplemental section for Math 190.
- f. Math 160 This course is up for review. This course is no longer being taught or offered, it was Business Calculus part 1. It was suggested to deactivate this course since we now have Math 165. It was recommended to reach out to CM 2 if they would like to deactivate Math 160. G. Song does not recall having a discussion in CM 2 about Math 160 but will verify with Ben Mitchell and will inform DCC if CM 2 would like to deactivate. Once they respond with their decision, DCC will be able to vote on officially deactivating the Math 160.
- **g.** CSCI 40 This course is ready for review, but there maybe more CS courses for review but does not have the course list, once Edwin Ambrosio sends the list to D. Eldanaf, she will be able to confirm the other CS courses.
- **h.** MATH 17A/27A/47A The math academy courses are at the CCC level and ready to be approved soon.
- i. CSCI 17 articulation– Approved by CCC.
