MEETING MINUTES

- I. INFORMATION/ANNOUNCEMENTS
 - February 4, 2014 minutes Approved.
 - Congratulations to all The college was officially taken off warning by the ACCJC.
 - Clarification on PLO reporting: TracDat will generate PLO report so no need to go to archives for most departments
 - C. Mello clarified that as of now, TracDat will not generate a PLO report however it will generate results of a course level report as a list which provides data that can be used.
- II. DISCUSSION/ACTIONS
 - Spring 2014 Course SLO Assessment
 - 1. Classes that must be assessed (never assessed)
 - Reviewed list of courses that must be assessed this semester.
 - 2. Classes that weren't assessed
 - The Fall 2013 Assessment report was reviewed and discussed.
 - Campus-wide, we need to get in the habit of assessing one SLO each year.
 - C. Mello explained that not all sections of a course have to be assessed but you must assess a good number of sections to provide enough data for an effective assessment.
 - D.L. Hayden will remind Theatre and Film/Video to assess courses that have not been assessed.
 - F. Sadeghi-Tabrizi will email a copy of assessment timelines for each department to committee reps.
 - C. Mello with work with D. Berney on PLOs and CSLOs.
 - Fall 2013 Assessment Reports

 - Reviewed list of assessments that have not been done. They need to be done ASAP.
