Type of Action:	Follow up should include:
-Teaching Strategy	Was the Action implemented, and did it result in improve student success?
-College Support	Was support provided, and if not, was the request included in the division action plan?
-Curriculum Changes	Has the process begun to change or introduce new curriculum?
-Assessment Process	Was the process revised or the statements changed for the next assessment?

3. The Communication ILO is being assessed campus wide this spring. Certain sections from Math 130, 150, 23, 37, 40, 73 & 80 were selected to participate in the ILO.

III. CM1

CM1 voted to roll over to the new 8th edition of Stewart ET Calculus in the fall semester. The 7th edition will remain in use for the summer 2015. In the fall we will use the 8th edition for Math 190 and the 7th edition for Math 191 and 220. In spring 2016 we will use the 8th edition for Math 190 and 191 and the 7th edition for Math 220. In the summer 2016 all three courses will use the 8th edition.

The CM1 Program Review is next year.

IV. CM2

- 1. It is now official that we will be offering five sections of Math 165 (Calculus for Business and Social Sciences) starting Fall 2015. The last time that we will be offering Math 160 (2 sections) is Summer 2015. We will continue to offer Math 161 (two sections in Fall 2015 and one section in Spring 2016) to cycle off the students.
- 2. We are still currently in process of assessing SLO #4 in all CM2 courses and PLO #2.

V. CM3

We are collecting data and assessing the 3 PLOs for CM3, the 4 SLOs for Math 115 and the 4 SLOs for Math 116 this semester. Our next meeting to discuss the data from the PLOs is scheduled on Thursday, April 30 from 1-2 in MBA 343. Preliminary data for the SLOs for Math 115 and 116 may also be discussed. After our meeting and discussions about the data, assessment reports for the CM3 PLOs, Math 115 SLOs, and Math 116 SLOs will be written and uploaded into TracDat.

VI. CMD

All courses are proceeding with current SLO's. The lead person for each course will be collecting syllabi. We also discussed research ideas for next year's program review. Some ideas include getting students involved in program review and comparing results of classes with fulltime and part-time instructors to discussing facilities, computer classrooms.

VII. Academic Senate

- 1) Academic Senate took a vote on whether to have Cesar Chavez day as a closed campus day. It was voted against. Following that a vote was taken whether to have a day of commemoration and that passed. I am pleased to report that ALL of your Academic senators were there and took part in the voting to ensure your voice on the matter was heard.

Meeting for Adult Initiative (AB86)

In 2008/2009, funding for adult education was dropped by 30%. Because of the state and quality of adult education since these cutbacks, the state is considering adding funding support so they passed AB86. AB86 is providing one time only funds to redesign adult education. They instructed 70 districts to create consortia. The leaders of the consortia were told to create plans for a pathway which would streamline to academic and career paths. They were to improve delivery systems through collaboration between adult ed., community colleges and local industry.

There were three MAJOR challenges with the guidelines they were given:

- They were told who could and could not be in the consortium. Thus, initially there was some
 outreach to get faculty and industry input, but, once these conditions were clear, they were
 aware they would need to wait to get input.
- They were told the type of plan they should come up with and given no indication regarding any funds that might be available to support the plan.
- They were limited to which aspects of adult education they could discuss. Thus, programs such as senior living were not to be considered in their plans. The five program areas (populations) they could include in their plans are:
 - High school equivalency
 - o Immigrants
 - o Adults with disabilities
 - Short term Career Technology Education (CTE)
 - o Apprenticeships

So, here is what our consortium did:

They met weekly to study best practices, discuss results of conference and webinar attendance and came up with a final plan which was submitted on March 1, 2015. Keep in mind that the plan was contingent on unknown funding.

The objectives of the consortium were:

- 1. Evaluate existing programs and populations
 - a. Demographics
 - b. Historical review
- 2. Evaluate program needs
 - a. Socio-economic
 - b. English language learners
 - c. Declines in enrollment There are now 80,000 high school dropouts statewide, only 9% of whom are being served by adult ed.
 - d. By 2020, 65% of jobs will require education beyond 12th grade. (In 1970, this was 28% and in 1996, it was 56%) 6.3 million of these types of jobs will be available between 2010 and 2020.

- 3. Properly align adult programs and create transitions
- 4. Create plan to address the gap (what gap?)
- 5. Accelerate student success
- 6. Plan for professional development
- 7. Leverage regional structures partnerships with goodwill, EDD, calworks, libraries, etc.

The state received plans from the 70 consortia and, from these plans, they have prioritized what needs to be done:

- Increase service levels
- Improve programming to prepare students
- · Provide academic, social, and financial support
- Develop common accountability to document and evaluate student progress
- Maintain and extend structures of consortia
