Agenda for CS meeting, Oct 31

 - a. Dr. Rapp tried desperately to secure the funds to pay for the registration fees for the student competition, AMC International Collegiate Programming Contest. However, she learned that in order to fund such competitions, the students have to be part of an official (board approved) student club at El Camino College
 - b. Dr. Rapp did discuss this with Chidubem(Dubem) W Enyekwe and advised him to register the team as an official college club and perhaps future competitions may be funded and the students may even be able to use one of the campus vans for transportation.
 - c. An advisor will be needed to officially form this student club as well.
 - d. So, El Camino College and the Math Division will not be able to pay for the registration fees for this completion this year.
