Dear Members of the Board:

Welcome to the Monday, November 16, Board agenda. I trust we will all have a wonderful Thanksgiving in recognition of your superb work in the appointment of the sixth Superintendent/President of the El Camino Community College District. Dr. Dena Maloney will attend the November Board meeting and we will all celebrate her appointment with a little break from the activities early in the meeting.

The regular agenda is initiated with a presentation on the Student Equity Program from Vice President Jean Shankweiler. Supplemental information is included on Attachment A. The consent agenda is highlighted by a number of relatively routine transactions and include the following:

- A. Academic Affairs includes an information item which permits El Camino College students to attend the Keck Graduate Institute. Additional details are included on Attachment B. Other items include Destruction of Records recommendation and proposed curriculum changes for the 2016-17 academic year.
- B. Student and Community Advancement recommends a Destruction of Records action and one grant application and grant acceptance. The grant for Foster Youth is supplemented by Attachment C. The remaining action includes updates of eight Board Policy first readings and seven Administrative Procedures.
- C. Administrative Services presents the usual recommendations for contracts, personal services agreements, contract amendments and a small change order to the Natural Science roof project.
- D. Measure E provides the usual expenditure updates. Two contract amendments are supplemented by a confidential communication, Attachment D, and a change order for the stadium project, Attachment E.
- E. Human Resources recommends employment and personnel changes and the approval of temporary and non-classified service employee actions. Also

presented for approval are recommended changes for 2016 salary schedules, which is supplemented by Attachment F. In addition, Attachment G includes changes for student worker and non-classified temporary pay schedules to increase the mandated minimum wage increase. There is also a structural change modification for student worker and non-classified employees. After a change in the Assessment/Testing Center Supervisor's updated job description is a list of Local Minimum Qualifications, which is supplemented by Attachment H.

F. The consent agenda is concluded with a recommendation from the Superintendent/President to adopt Board Policy and Administrative Procedure 3540 on Sexual and Gender-Based Misconduct. It also reports the 2015 Board of Trustees Self-Evaluation and initiates the discussion of 2016 Board goals.

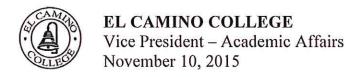

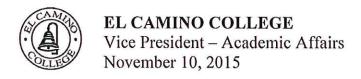
Student Equity Plan

The El Camino College Student Equity Plan (SEP) was awarded \$2,112,177 for 2015-16 to bridge the gap in student success for a variety of student groups. The gap in equity is measured using five Student Success Indicators: Access, Course Completion, ESL and Basic Skills Completion, Degree and Certificate Attainment, and Transfer. The plan developed by each school must examine the student populations disproportionately impacted in each of the success indicators. The student populations to be examined include veterans, low income, students with disabilities, current and former foster youth, and racial or ethnic groups.

The El Camino College Student Equity Plan is under the direction of Ms. Idania Reyes. To meet the revised guidelines from the Chancellor's Office for 2015-16, the SEP director has held two workshops during the months of September and October to explain the requirements of the program and to solicit funding requests from various campus groups and individuals. The Institutional Research office provided data which determined the students disproportionately impacted in the success indicators. Ms. Reyes and her team have been meeting with groups requesting funds to confirm the students targeted in each activity are disproportionately impacted and how the funding will best be used to close the gap.

The plan and the data used to develop the plan will be briefly introduced in a presentation at the November 16 ECC Board of Trustees meeting. The plan must be approved by numerous campus entities, including Academic Senate, classified employees as well as the Board of Trustees. The plan is in draft form, undergoing review by these groups, and will be presented to the Board of Trustees for approval at the December 14 meeting. This revised plan must be submitted to the Chancellor's Office by December 18, 2015.

The Keck Graduate Institute is one of the Claremont Colleges. It offers a number of graduate degrees in the sciences, including a Master's Degree in Bioscience (MBS), a Master's degree in Engineering (MEng), a Post-Baccalaureate Pre-Medical Certification (PPC), a Post-Doctoral Professional Masters (PPM), and a Pharmacy Doctorate (PharmD). The tuition for these programs ranges from \$41,921 to \$48,921, including required health insurance. The memorandum of understanding included in the packet will provide admissions benefits to El Camino STEM majors that have transferred, are completing a Bachelor's degree and are interested in these unique programs.

SUBJECT: Foster Youth Grant

At El Camino College, foster youth have been identified as a segment of the student population which is not succeeding at same rate as the general student population. El Camino College serves approximately 164 foster youth for which the gap in success rates for credit courses, basic skills courses, and transfer level courses is more than 20% than that of the general student population.

The college has proposed a Warrior Scholars Program with two primary objectives: (1) creating a student-focused program that will provide customized services to meet the individual needs of current and former foster youth; and (2) collecting data to demonstrate the need for programs and services aimed at foster youth. Currently, there are insufficient funds to provide foster youth with programs and services to assist their transition to college and ensure successful retention, persistence, graduation, and transfer to four-year universities. It is anticipated that the Foster Care program with appropriate and sufficient financial support will be able to bridge the student equity gap by 5% as it relates to the completion of credit, basic skills, and transfer level courses at the conclusion of a two year period.

SUBJECT: 2016 Salary Schedule Increases – Effective January 1, 2016

The previously negotiated collective bargaining agreements with the Federation of Teachers, the El Camino Classified Employees, and the Police Officers' Association, included a provision that effective January 1, 2016, the salary schedules are to be increased by the state-funded cost of living adjustment (COLA). This has been determined to be 1.02%. Therefore, the salary schedules included reflect this agreed-upon increase.

The unrepresented groups (management, supervisory, and confidential employees) are included and recommended for the same 1.02% COLA increase.

SUBJECT: Student Worker and Non-Classified, Temporary Pay Schedule

(Increase in California Minimum Wage and Structural Modification)

On January 1, 2016, the California minimum wage will increase from \$9.00 per hour to \$10.00 per hour. In reviewing the change in hourly wages, it was also determined that a restructuring of the Student Worker and Non-Classified, Temporary pay schedules was in order.

The current student pay schedule utilizes a five "step" structure with a twenty-five cent (\$.25) differential for some duty levels and a one dollar (\$1.00) differential for others. The current student worker pay schedule requires the management of 26 individual "step" placements. The recommended restructure results in a streamlining of pay rates of two "steps" per level, while also incorporating the new minimum wage requirement.

Because hourly employees submit monthly timesheets with a 20th to 19th of the month time period, it is recommended that these pay schedules become effective December 20, 2015. This would minimize the payroll department's need to calculate two separate rates of pay within one month's reporting. This slight change in the effective date should be negligible, as many of the student and non-classified workers are not scheduled during the week leading to the holiday break.

SUBJECT: El Camino College's Local Minimum Qualifications List

The California Community Colleges Chancellor's Office regularly updates its system-wide "<u>Minimum Qualification for Faculty and Administrators in California Community Colleges</u>" manual. This document provides an update of discipline lists as adopted by the Board of Governors and the Academic Senate for California Community Colleges.

The California Education Code permits community college districts to adopt local qualifications which may exceed, but not be less, than the state adopted minimum qualifications. Long ago, El Camino College (ECC) developed local qualifications to reflect the interests of the college's academic rigor.

The attached updated local minimum qualification list reflects system-wide updates and ECC specifics. The list was presented and discussed with the ECC Academic Senate. It is included for Board approval to facilitate the accurate posting of our upcoming faculty vacancy announcements.

Dear Members of the Board:

The Accrediting Commission for Community and Junior Colleges (ACCJC) has adopted new standards for accrediting community colleges. Within the Community and Governance standard, ACCJC has updated the standards for board governance and education to include - "The governing board has an ongoing training program for development, including new member orientation". (Standard IV.C.9)

The Community College League of California (CCLC) has developed an "Excellence in Trusteeship Program" designed to facilitate ongoing education for all trustees in California community colleges. The program is intended to provide a solid foundation for effective board governance. Board development may be obtained through CCLC events, local board workshops, and national association conferences and webinars.

The program covers seven areas of competency: Accreditation, Student Success, Governance, Fiscal Responsibility, Board Evaluation, Ethics, and Brown Act Training. (*see attachment #1*) Board development opportunities include attending CCLC events, online webinars, print resources and local and national board training events. (*see attachment #2*)

Although the CCLC program is not required for elected governing board members, it is imperative that every California community college be able to demonstrate board development as part of the accreditation self-evaluation report going forward. The "Excellence in Trusteeship Program" is a great way to demonstrate board development.

Ann Garten has researched the procedures for each board member to register for the "Excellence in Trusteeship Program". Go to the link below and register yourself and submit a receipt for reimbursement, or President's Office staff will register each board member and pay the \$150 fee for the program. Once registered, each board member will need to begin tracking and entering board development programs once they have been completed on the, "Track My Progress" section of the online form. CCLC will accept any training that has already been completed during this calendar year. For example, if you attended the Effective Trustee Workshop conference in January 2015, that can be entered toward certification.

Board Governance Education

"The institution has a governing board that has authority over and responsibility for policies to assure the academic quality, integrity, and effectiveness of the student learning programs and services and the financial stability of the institution." – WASC Accreditation Standard IV.C.1

An educated and well-informed governing board is the foundation of a successful community college. As the policy-making body of the community college, the governing board is responsible for the overall success of the institution and the students served.

Excellence in Trusteeship is a program designed to facilitate the ongoing education of all trustees in California community colleges by providing a solid foundation for effective board governance. You can obtain the training through League events, local board training, and national association conferences and webinars. Whatever venue you select, you are sure to get the most current and up-to-date governance information available.

Program Overview

"Community college boards ensure the wise and prudent delivery of education, a critical local and state resource, on behalf of the people in their communities. They are guardians of and stewards for the public's interests. Trustees, as members of boards, ensure that the community college district fulfills its responsibility to lead and serve its ever-changing communities." – CCLC, Trustee Handbook, p.23, Rev. 2013

The program covers seven (7) areas of competencies with subtopics to complete the knowledge and skills learning to support strong leadership. Participants attend sessions in each of the seven (7) competencies which define the roles and responsibilities of governance boards and provide tools that keep efforts focused on student learning.

A certificate of participation in governance leadership from the League can be earned with completion of the program. Participants must complete the program within 24 months of the start date. The program can be completed in one year.

Competencies

Accreditation

This module covers accreditation as a regional peer-review process that looks at the entire campus/district, and provides an opportunity for continuous self-improvement, grounded with data-driven evidence.

Student Success

This module covers topics from the Student Success Act of 2012, Senate Bill 1456, including utilizing student services in individual education planning, monitoring student progress, and improving completion and transfer rates.

Governance

This module covers the governing board's policy-making function, and its role in the participatory governance process.

Fiscal Responsibilities

This module will cover the skills and knowledge needed to make fiscal policy decisions and set guidelines for fiscal and asset management practices that support college goals and student success.

Board Evaluation

This module will cover the role of the board and its limits; how to run effective meetings; and how to develop and maintain a strong Board/CEO relationship; the board self-evaluation and its evaluation of the CEO.

Ethics Training

Learn how to perform in both ethical and legal ways as you govern.

Brown Act Training

Learn how to set agendas, provide for public comment, run board meetings and when to hold closed sessions.
