1. The [minutes](#) of December 3, 2018 was approved.
2. [Health & Safety](#):  
These are the current top priority Health & Safety items:
  - a. Elevator – contractor is working on the Lot H elevator; Waiting on state certification on the Bookstore elevator.
  - b. MBAH –work in progress.
  - c. North Gym – parts ordered and contractor will begin this week.
  - d. Baseball Field – new restroom - 80% design work completed.
  - e. CATS – safety netting; met with architect and will be meeting with Athletics to go over rendition.
  - f. Campus Exterior Lighting – 98% completed; there are still dark areas on campus. Working with engineering firm to install more lights.
  - g. Women's shower locker room – non-skid flooring materials ordered.
  - h. Library – putting in a new power sliding door to be ADA compliant.
  - i. MBBM trailer – rain gutter replacement.
  - j. Marsee – contractor to provide repair estimates for stage lift.
  - k. Campus power shut down – will be meeting with Edison for better communication and protocol.
3. [Bond Project Status](#)
  - a. Administration Building – 24% complete in construction phase. Project completion December 2019
  - b. Arts Complex – 30% completed in design phase; project completion June 2022.
  - c. Construction Technology – 5% completed in design phase. Waiting for input from department faculty & staff.
  - d. Gymnasium – 83% complete in construction phase. Project completion April 2019. Issues with Acoustic panel; wrong kind installed.
  - e. Pool Classroom Complex – 20% complete in construction phase
  - f. Bookstore Café Project – 5% complete in design phase. Once approved, plans will be shared.
  - g. Student Services Center – 81% complete in construction phase. Working with contractor to get project completed.
  - h. Behavioral Sciences – 42% complete in the construction document phase (includes the electrical, plumbing etc. drawings). Project completion June 2022.
  - i. Demolition of Student Activities & Student Services – will be doing the demolition in phases

with the Student Activities Center being done first.

- j. Central Plant Upgrade – going to DSA tomorrow morning to close out the old projects so that the new project can be approved.
  - k. Student Activities Relocation – relocate to basement of the Communication building. We are meeting with the group to design the area.
