

2026-2027 Dependent Verification

Your 2026–2027 Dream Act Application (CADAA) was selected for review in a process called verification. The law says that before awarding Financial Aid, we may ask you to confirm the information you reported on your CADAA. To verify that you provided correct information, we will compare your CADAA with the information on this institutional verification document and with any other required documents. If there are differences, your CADAA information may need to be corrected. You must complete and sign this institutional verification document, attach any required documents, and submit the form and other required documents to us. We may ask for additional information. This information should be submitted as soon as possible so that your financial aid will not be delayed.

The provided criteria for “dependent children” or “other persons” mirror the requirement that family size align with those the parent could claim as a dependent on a U.S. tax return if the parent were to file a U.S tax return at the time of completing the 2026-2027 FAFSA. As a result, the parent should not include any unborn children in the family size.
