

THE FOUNDATION HAS AN IRREVOCABLE BENEFICIAL INTEREST IN THE BALANCE OF FUNDS CONTRIBUTED FOR THE BENEFIT OF STUDENTS AT EL CAMINO COLLEGE AND THE ACCUMULATED EARNINGS, WHICH DOES NOT INCLUDE ANY FUNDS CONTRIBUTED BY THE OSHER FOUNDATION.

AS OF JUNE 30, 2022 AND 2021, THE FOUNDATION'S BENEFICIAL INTEREST IN THE CCCS ENDOWMENT TOTALED \$1,591,872 AND \$1,921,024, RESPECTIVELY.
