#### **EEO Plan – Annual Certification**

- Reminder that a comprehensive EEO Plan is submitted every 3 years, with annual updates to the Chancellor's Office (CO).
- Submitted annually; goals are carried out year by year.
- Approved by the board and submitted to the CO; awaiting feedback from CO regarding feedback/funding.
- Districts maintaining and updating EEO Plans receive limited funding dedicated to EEO Plan compliance.

### **EEO Plan/Component 13**

- 2024-2027 El Camino College Equal Employment Opportunity (EEO) Plan
- Training Goals/Status
  - Y1 (a): 75% Training Completion Goal
    - Already submitted; but can look at rough numbers.
    - Tracking for Y2 started; rough numbers.
  - Y1 (b): met goal of developing search chair training.
    - COMPLETE: Search Committee Chair Training launched in MS Teams for committee members on recruitments, but is a self-paced training (no tracking).
  - Y2 (a) Goal of implementing search committee chair training module and have 50% of all deans complete the training.
    - Per MS may be able attend a meeting where deans area already in attendance of to show training (will catch more than 50% goal).
       Will be helpful for upcoming faculty recruitments.
  - Y2 (b) Develop additional professional development opportunities on implicit biases.
    - Need to follow up w/ co-chairs.
    - JCI met with Sheryl Kunisaki & Linda Cooks over the summer; just need to get an update.
  - Y2 (b) Goal of identifying at least one professional development opportunity regarding implicit bias.
    - Need to follow up w/ co-chairs for a report on this.
  - Y3: Offer professional development opportunities for all employees on implicit biases.
    - Need to follow up w/ co-chairs for a report on this.
  - Y3: Goal to have each academic division attend professional development on implicit biases.
    - All EEO Committee Members are encouraged to take the EER Training!
- Implementation Section titled: Addressing diversity issues in a transparent and collaborative fashion.
