EEO Plan – Annual Certification

- Chancellor's Office (CO) Requirements:
 - Annual updates: data, spending, progress on goals.
- We will be preparing to start the process for new plan (will cover 3 years).
- CO Feedback:
 - o Funding: Slight decrease (~\$20K), not significant in overall budget.
 - Plan Issues: Concerns about adverse impact and underrepresentation metrics. Likely request for more measurable actions when adverse impact is identified. Would like to also bring up the challenges discussed at Measures of Underrepresentation Subcommittee meeting.
 - Historically positive feedback; this is first time with notable concerns.
- Next Steps:
 - Meeting with CO rep this month for feedback/clarification.
 - Report findings at next Measures of Underrepresentation Subcommittee, then update to the General EEO Committee.
- Discussion on adverse impact, definition, metrics, data, challenges and how a meeting with the CO will be helpful.
