#### General Information and Conditions

- **1. APPLICATION**: To apply, please fill out the application form in full and send it to the *The Studios on Cabrillo* office via air mail with your payment of \$200.00 security deposit and \$50.00 non-refundable application fee. Your check must be drawn on a US bank and should be made payable to **1646 CABRILLO LLC**.
- **DO NOT** delay in sending your application if you cannot immediately send your payment. Please send a letter or email indicating payment is on the way. It is suggested that you apply as early as possible to ensure confirmation of accommodations. Your reservation is not confirmed until payment in full has been received. Rooms are provided as available, we cannot guarantee availability so apply as early as possible, You will be notified whether there is availability upon receipt of your application and deposits. **Please do not use U.S. postal service for any mail requiring a signature. Regular mail is ok, but no certified or registered please. For best results use FEDEX, UPS, DHL, etc.**
- 2. HOUSING: The Studios on Cabrillo offers housing in an off-campus building. There are three different size units available standard single, large single and double. Units may be shared with another student and it is the responsibility of the student(s) to make their arrangements. The rate for the room remains the same for single or double occupancy. It is the responsibility of the student to pay the monthly rate regardless of the number of occupants. The Studios on Cabrillo are dormitory-style housing with communal gender specific bathrooms/showers and a full service community room. We place students on a first paid, first placed basis.
- 3. AIRPORT PICK-UP OR ALTERNATE TRANSPORTATION: The Studios on Cabrillo will make every effort to assist in airport pick up or we will advise on shuttle service. This service is offered on arrival only. Additional fees apply. The airport pick up fee is non-refundable if the service is cancelled less than 5 days to arrival. It is your responsibility to make sure and confirm we have the correct flight information to ensure proper airport pick up.
- **4. INSURANCE**: 1646 CABRILLO LLC and its representatives are not liable for damages, injuries, and violations to people or goods, whenever these may occur. Each student is responsible for providing insurance for such risks. \*\*NOTE\*\* Many of the schools/colleges have a policy which requires purchase of insurance upon enrollment into their educational programs. Please check with your school advisor or current insurance carrier for information regarding health and personal coverage, especially when outside your home country. It is advisable to keep a copy of your insurance plan for easy reference.
- **5. VISAS**: Obtaining the proper visas and permits for your education is the responsibility of each individual. Inquiries concerning the matter should be directed to either the American Consulate in your country or through the school to which you are applying.
- **6. CANCELLATION**: Cancellations must be in <u>writing</u> and received by *The Studios on Cabrillo* at least 25 days prior to your arrival in order to receive a refund (the application fee is non-refundable). If written cancellation is not received prior to your arrival into the US, you will forfeit all prepayments.
- **7. START DATE:** In your confirmation, you are provided a start date (which was requested by you), if you postpone that start date without advising 1646 CABRILLO at least 7 days in advance, your dates of stay will not be changed and *The Studios on Cabrillo* will be paid from the originally confirmed start date.
- **8. 1646 CABRILLO LLC** reserves the right to terminate without compensation a student's housing arrangement if the student is found to have behaved with gross misconduct. Gross misconduct includes: theft, abuse of property, abuse of persons, disrespect of property, house rules, alcohol and drug abuse, failure to adhere to local laws, property rules and regulations. In addition, 1646 CABRILLO LLC shall inform the student's advisor at the college he/she is attending. No refunds whatsoever will be paid to students who have been found to have behaved with gross misconduct.
- **9. HOUSING EXTENSIONS**: If you wish to continue your stay, all extensions must be directed through *The Studios on Cabrillo* office. The additional fees must be paid in advance and directly to 1646 Cabrillo LLC. Payments are due 30 days in advance. Due dates and late payment fees will be provided on each invoice. Once the extension has been processed, there will be no refunds allowed. If the student does not wish to extend their stay, it is understood that the student is to vacate their housing complex at the end of the terms of the housing contract. If you wish to reserve your room year round you will be responsible for the rent during the summer/winter sessions.
- 10. PRICES: SUBJECT TO CHANGE WITHOUT NOTICE.
- 11. SECURITY DEPOSIT: A security deposit of \$200.00 is to be collected from each student and will be retained by 1646 CABRILLO LLC until the completion of the student's housing contract. The security deposit can and will be used for breakage/damage and/or cleaning costs incurred by the student. 1646 Cabrillo LLC will return the security deposit after confirming with the resident manager to verify the amount of refund due to you <a href="mailto:after:af

- 12. REFUNDS: If a Student cancels in writing more than 25 days before arrival in the US, Student will receive: All amounts paid by the student, less the application fee and airport pick up fee (if cancellation is within 7 days of arrival). If cancellation is requested less than 25 days prior to the start date, refund is same as above for all fees. After arrival in the US, NO REFUND POLICY. Exception: If the student is denied their visa, we will refund all fees except the application fee and any customer convenience charges provided we are notified in writing (a copy of the denial letter is required) within 3 days of receipt of such letter.
- **13. TRANSPORTATION**: It is the responsibility of the student to provide their own transportation to and from their campus. *The Studios on Cabrillo* will assist in providing the student with local bus maps and telephone numbers of public transportation.

  \*\*NOTE\*\* Please be advised that public transportation in the US may not be as convenient as in other cities/countries.
- **14. MODE OF PAYMENT: Cash** (Cash will be taken in our office only), **Check** (Check must be drawn on a US bank), **Credit Card** (Visa, MasterCard & JCB) or **Wire Transfers.** We will charge a five percent (5%) customer convenience charge on all non-cash and non-check transactions.
- **15. WIRE TRANSFER**: Account information will be provided to you in your confirmation or if requested by email. The 5% customer convenience charge must be included in the wire transfer. Regardless of method of payment, a credit card must be kept on file at all times to cover rental payments for stays beyond the pre-paid date and any damages or bills incurred that exceed the security deposit on file.
