DESCRIPTION OF STUDY:

In 2025-2026, the California Community College system will transition from the "held harmless" funding model from the COVID pandemic to an unknown funding formula. Although student FTES will continue to be a primary metric in the new funding formula, student services, especially those services provided by counseling programs, will also be part of the new funding formula.

My sabbatical project is to be a direct participant in this transition and research how counselors and counseling programs can best use the post-hold harmless funding formula to optimize Supplemental Allocations to districts and best serve students, especially in the areas of student recruitment, retention, and academic success.

This sabbatical work will focus on evaluating legislation and data at the state and federal level and comparing ECC data and practices with state trends. The research will also evaluate best practices in the field of counseling services. This evaluation will include how current and new legislation helps and hinders students in the community college system.

I plan to research best practices for student services, specifically the way counseling programs can support student success and retention and supplemental allocation legislation as community colleges prepare to move out of hold harmless in 2025-2026. I will research best practices to increase enrollment and retention while optimizing Supplemental Allocations funding. While also researching potential changes to the Student Centered Funding Formula (SCFF) as the State moves away from hold harmless to the new unknown budget mechanism for 2025-2026.
