Virtual Parking Permit Presentation

Connor Sheil, the Director of Growth and Management at OmniQ Vision introduced himself and a gave a brief background of the company before presenting on the virtual parking permit system.

- It is an all-in-one parking solution Permits, payment, citations, reports and equipment (vehicle license plate readers, handheld readers) are all provided through the company and/or their software.
- Information is live and in real-time.
- Cloud based no onsite servers needed
- Simple equipment installation
- School email and vehicle make, model, color, license plate and a phone number is needed for a student to register for a permit
- Citations can be physically printed out or sent to the e-mail address given with their user profile
- Current clients include Cypress College, La Sierra University in Riverside, LAX and other airports

Questions

What if you have multiple cars or a rental car for the day?

You can register multiple cars or a rental car online or create a guest permit for the day.

Will it be able to be configured for large athletic events with multiple vans and officials? For event parking, a link can be setup on ECC's website for guests to register their information online. To distinguish a guest from someone trying to get free parking, you can set it up so that users/guests need to be registered for the event.

How do you rescind a citation?

The admin user has the ability to do it online.

If faculty does not want to register their personal information online, will a physical permit/decal be available?

Their company can do decals if requested but will need to set that up ahead of time if ECC wanted to provide physical decals.

What if a person does not have a smart phone or it is not working when they are on campus? They can register before coming onto campus or they can go to Parking Services to have their information entered.

Can their system be integrated with our parking permit machines that are already in place? Yes, they have partnerships with some parking pay station companies. It is a simple transfer of files and may take a month to implement.

Can a list of faculty members be submitted for the year or does each faculty member have to register on their own?

It is fully customizable so if desired, a list can be submitted for someone to enter each faculty member's information. The history can be stored so that the information doesn't need to be entered each semester for employees.

What is the cost as far as permits?

There is no per unit type fee. The only monthly charge to is keep the PERCS (Permit, Enforcement, Revenue, Collections) platform running, which is roughly \$1,000/month. There is no fee for processing permits.

When a student registers for the semester, where can they pay for their permit? When registering for classes there will be a link to the PERCS system and it will create a new permit and show payment options. They can pay with their cell phone, Apple Pay, Google Pay, credit card, etc. Payment information is for one time use and is not stored.

The roll-out date is desired by spring semester however, it still has to go through the college consultation process and be approved by the Board.

Chief Trevis would like to send a recommendation to V.P. Miyashiro that the college moves forward to have more discussion and information on the virtual parking permit system. There were no objections.
